Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Kem Krest Profit Sharing and Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 – DESCRIPTION OF PLAN

The following description of the Kem Krest Profit Sharing and Retirement Plan provides only general information. Participants should refer to the plan agreement for more complete information.

General: The Plan was established effective January 1, 1998. The Plan is a defined contribution plan which was established for the benefit of the employees of Kem Krest Corporation (the “Company” or “employer”) who meet certain eligibility requirements as defined by the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective August 7, 2023, a division of Telamon was acquired by the Company. Employees who fulfilled at least 90 days of service with Telamon prior to the acquisition date, became participants in the Plan immediately.

Contributions: Substantially all employees of the Company who have completed three months of service and have attained the age of 18 participate in the Plan. The Plan contains an auto enrollment provision of 3% with a 1% annual increase until 10%. Each year, participants may contribute up to 100% of their pretax annual compensation to the Plan up to the maximum allowable under the Internal Revenue Code (“IRC”). Participants may also contribute amounts representing distributions from other qualified plans. The Company contributes a safe harbor matching contribution equal to 100% of the first 3% of contributions and 50% of additional deferrals up to 5% of contributions. Catch-up contributions are permitted for participants greater than 50 years old.

Participant Accounts: Each participant’s account is credited with the participant’s contribution and allocation of the Company’s contribution and Plan earnings and charged with participant withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant, or beneficiary, is entitled is the benefit that can be provided from the participant’s vested account.

Retirement, Death, and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death, or disability.

Vesting: Participants are at all times fully vested and have a nonforfeitable interest in their before-tax contributions and earnings thereon. A participant is at all times fully vested in his or her share of the accumulated Company safe harbor contributions and related earnings of the Plan.

Withdrawals: Withdrawals are generally not permitted before age 59½, except in the event of death, disability, hardship or termination of employment.

Payments of Benefits: A participant may elect to receive either a lump sum or direct rollover amount equal to the value of his or her vested interest in the account, or periodic installments over a period not exceeding the life expectancy of the participant or joint lives of the participant and spouse.

Notes Receivable from Participants: The Plan provides that participants can borrow funds against their account balances limited to the lesser of 50% of their vested account balances or \$50,000. The notes receivable from participants are secured by the participant’s vested account balance, cannot exceed five years, or up to 10 years if it is for the purchase of a primary residence, and bear interest at a rate commensurate with prevailing rates.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA and its related regulations.

Administrative and Investment Management Expenses: The Plan bears administrative expenses to the extent that the Company does not pay them. Investment management fees are charged to the Plan as a reduction in investment return and included in the investment income (loss) reported by the Plan.

Investment Funds: Participants have the option of directing their pre-tax contributions and the Company's matching contributions into mutual funds and a collective trust.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation: Investments are stated at fair value as further described in Note 4. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Net Appreciation/Depreciation of Investments: In accordance with the policy of stating investments at fair value, net unrealized appreciation or depreciation for the year is reflected in the statement of changes in net assets available for benefits.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participant's account balance.

Contributions: Contributions from employees are recorded in the period the Company withholds payroll deductions from Plan participants.

Use of Estimates in the Preparation of Financial Statements: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Risks and Uncertainties: The underlying investment securities in the Plan are exposed to various risks, such as interest rate, liquidity, market, credit risks, and risks associated with ongoing global events. Due to the level of risk associated with certain investment securities and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Payment of Benefits: Benefit payments are recorded when paid.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through October 7, 2025, which is the date the financial statements were available to be issued.

NOTE 3 – CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (“Principal”).

NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan’s principal or most advantageous market for the asset or liability. The effect of a change in valuation technique or its application on a fair value estimate is accounted for prospectively as a change in accounting estimate. When evaluating indications of fair value resulting from the use of multiple valuation techniques, the Plan is to select the point within the fair value measurements as determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs.

The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan’s own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Mutual funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (level 1 inputs).

Collective Trust: The fair value of interests in the collective trust are based upon the net asset values per unit as reported by the fund managers of such funds after an adjustment to reflect all investments at fair value, including direct and indirect interests in fully benefit-responsive contracts, as reported in the audited financial statements of the fund as of the Plan’s financial statement date. The collective trust provides for daily redemptions by the Plan, with no advance notification requirement or redemption restrictions.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value for certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 – TAX STATUS

The trust established under the Plan to hold the Plan's assets is designed to be qualified pursuant to the appropriate section of the Internal Revenue Code (IRC), and accordingly, the trust's net investment income is exempt from income taxes. The prototype plan document adopted by the Plan has obtained a favorable tax opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020. Although the Plan has been amended since adopting the prototype document, Plan management believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. The Plan held certain party-in-interest investments, including collective trusts issued by the Plan's trustee, Principal. The company is an affiliate of Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, and therefore these transactions and the Plan's payment of trustee fees and investment management fees qualify as party-in-interest transactions. Investment management expenses paid by the Plan to Royal Alliance Associates, Inc. and Wilshire Associates Incorporated, which are reflected as a reduction of the Plan's investment return, qualify as party-in-interest transactions.

The Company provides certain accounting, recordkeeping and administrative services to the Plan for which it receives no compensation. Administrative expenses of \$146,530 were paid to Principal for the year ended December 31, 2024. Notes receivable from participants held by the Plan are also considered party-in-interest transactions.
