NOTES TO FINANCIAL STATEMENTS

YEAR ENDED DECEMBER 31, 2024

Note 1 - Description of the Plan

The following brief description of Little People’s School, Inc. 403(b) Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General - The Plan, established on January 15, 2013, is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). All employees of the Little People’s School, Inc. (the School) are eligible to participate. Little People’s School, Inc. is the plan administrator. Effective April 1, 2019, the Plan was restated, and Ascensus, LLC become the record keeper and Ascensus Trust Company became the custodian of plan assets. Global Retirement Partners dba Alpha Pension Group, Inc. serves as the investment advisor.

Enrollment - All employees may participate in the Plan upon the first day of employment with the School. Participants may change their deferral percentage once a month.

Contributions - Participants may elect to defer a portion of their eligible compensation, as defined in the Plan, as contributions to the Plan up to the maximum permitted by the Internal Revenue Code. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may make rollover contributions representing distributions from other qualified plans. Participants may also make after-tax contributions (Roth contributions) into the Plan. Annually, the School may elect to make a discretionary matching contribution. For the year ended December 31, 2024, the School made a discretionary matching contribution equal to the first 3% of eligible compensation that a participant contributed to the Plan. Annually, the School may also elect to make a discretionary employer contribution. To be eligible for the discretionary matching and discretionary employer contributions, the participant must have attained age 21. For the year ended December 31, 2024, no discretionary employer contribution was made. Contributions are subject to certain limitations and eligibility requirements apply to such contributions.

Participant Accounts - Each participant account is credited with (a) the participant’s contributions, (b) employer contributions, if any, (c) an allocation of plan earnings thereon, and (d) plan expenses, if any. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting - Participants are immediately vested in their salary deferral contributions, the employer discretionary matching contribution, the employer discretionary contribution, and actual earnings thereon.

Investment Options - Upon enrollment in the Plan, a participant may direct their contributions, as well as the School’s contributions, in one percent increments to various investment options comprised of certain selected mutual funds and a money market fund. Participants may reallocate their funds or redirect new contributions daily among any of the offered funds.

Notes Receivable from Participants - Participants may borrow from their accounts a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant’s account and bear interest at rates which are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions. Generally, notes must be repaid within five years unless being used to purchase a principal residence. Participants may have only two notes outstanding at a time.

Note 1 - Description of the Plan (Continued)

Payment of Benefits - On termination of service, retirement, disability or death, participants or beneficiaries are entitled to a distribution equal to the total value of the participant's vested account. A participant or beneficiary may elect to receive the value of the vested account in a lump-sum payment, a rollover distribution to an eligible retirement account, or an annuity option. Annuities are purchased through TIAA and CREF. Such annuities are fully guaranteed by TIAA and CREF and therefore, are excluded from the plan assets. Participants may withdraw from their vested accounts upon certain hardship situations defined in the Plan or upon attainment of age 59 1/2. For terminated participants with balances less than \$1,000, benefit payments are made in the form of a lump sum payment. For balances greater than \$1,000, but less than \$7,000, benefit payments are made in the form of either a lump sum payment or are rolled over into an Individual Retirement Account for the benefit of the participant. Participants with balances greater than \$7,000 may elect to defer benefit payments or may elect to receive payments either in the form of a lump sum payment, a rollover distribution to an eligible retirement account, or in a series of monthly payments.

Administrative Expenses - Generally, the plan sponsor pays expenses. Fees for origination of notes receivable from participants, maintenance of former employees' participant accounts, and other administrative expenses are paid by the participants.

Plan Amendment and Termination - The Plan may be amended at any time by the Board of Directors, provided that no such amendment may deprive participants of their vested benefits. Although it has not expressed any intent to do so, the plan sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, all participants will remain 100% vested in their accounts.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared under the accrual method of accounting in conformity with U.S. generally accepted accounting principles.

Estimates - The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect the amounts of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period, and disclosures of contingent assets and liabilities, if applicable, at the date of the financial statements. Accordingly, the actual amounts could differ from those estimates.

Investment Valuation and Income Recognition - Investments are recorded at fair value in these financial statements. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis or, if not materially different, the settlement date. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation and depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Note 2 - Summary of Significant Accounting Policies (Continued)

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions in accordance with the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits - Benefits are recorded when paid.

Tax Status - The Plan utilizes an ERISA 403(b) Volume Submitter Plan document. The volume submitter plan being utilized obtained its latest opinion letter on January 1, 2018, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirement of the Internal Revenue Code. The Plan has been amended and restated since receiving the opinion letter. The plan administrator and the Plan's tax counsel believe the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified as of the financial statement date. Therefore, no provision for income tax has been included in the Plan's financial statements.

In determining the recognition of uncertain tax positions, the Plan applied a more-likely-than-not recognition threshold and determines the measurement of uncertain tax positions considering the amounts and probabilities of the outcomes that could be realized upon ultimate settlement with taxing authorities. As of December 31, 2024, the Plan has no uncertain tax positions that qualify for either recognition or disclosure in the financial statements. The Plan is generally subject to potential examination by the appropriate regulatory authorities for the prior three years. Currently, there are no audits for any tax periods in progress.

Subsequent Events - The date to which events occurring after December 31, 2024 have been evaluated for possible adjustment to the financial statements or disclosure is the date of the Independent Auditor's Report which is the date the financial statements were available to be issued.

Note 3 - Information Certified by Custodian

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments, at fair value and notes receivable from participants held at December 31, 2024 and 2023, and all investment income and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus, the record keeper, as authorized by Ascensus Trust Company (the custodian of the Plan).

Note 4 - Fair Value Measurements

Fair value is defined under U.S. generally accepted accounting principles as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. The Plan is required to maximize the use of observable inputs, minimize the use of unobservable inputs, and disclose in the form of an outlined hierarchy the details of such fair value measurements. The hierarchy of valuation techniques is based on whether the inputs to a fair value measurement are considered to be observable or unobservable in a marketplace. Observable inputs reflect market data obtained from independent sources, while unobservable inputs reflect the Plan’s market assumptions. The hierarchy requires the use of observable market data when available. These inputs have created the following fair value hierarchy:

Level 1 - Quoted prices in active markets for identical assets or liabilities.

Level 2 - Observable inputs other than those included in Level 1. For example, quoted prices for similar assets in active markets or quoted prices for identical assets in inactive markets.

Level 3 - Unobservable inputs reflecting management’s own assumptions about the inputs used in estimating the value of the assets.

The following is a description of the Plan’s valuation methodologies for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Money Market Funds and Mutual Funds

These investments are public investment vehicles valued using the Net Asset Value (“NAV”) provided by the administrator of the fund and calculated at the close of business on the NYSE. The NAV is based on the value of the underlying asset owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. Investments in money market funds and mutual funds are classified within Level 1 of the valuation hierarchy.

Note 5 - Related Party Transactions

Ascensus, LLC is the record keeper and Ascensus Trust Company is the custodian of the Plan. Accordingly, certain transactions qualify as party-in-interest transactions. During the year ended December 31, 2024, loan origination and maintenance fees and other administrative expenses totaling \$18,502 were charged to participant accounts and paid to Ascensus. In addition, professional and advisory fees in the amount of \$20,059 were paid to the Plan's investment advisor Global Retirement Partners dba Alpha Pension Group Inc. during the year ended December 31, 2024. The Plan administrator elects to pay certain administrative expenses of the Plan.

Note 6 - Notes Receivable from Participants

As of December 31, 2024 and 2023, notes receivable from participants charged interest at rates ranging from 4.25% to 9.50% with various maturity dates through March 2027.

Note 7 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as pandemic related issues or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
