Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed an audit of the accompanying 2024 financial statements of the Thrivent 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The 2024 financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, including the related notes (collectively referred to as the "2024 financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024, and for the year then ended, stating that the certified investment information, as described in Note 1 to the financial statements, is complete and accurate.

Basis for Opinion on the 2024 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (US GAAS). We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is

sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion on the 2024 financial statements.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with US GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with US GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and

disclosed in the 2024 financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the 2024 financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



Note 1. Description of the Plan

General

The Thrivent 401(k) Plan (“the Plan”) is a defined contribution plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Empower provides the Plan’s recordkeeping, administrative and custodian services. The directed corporate trustee for the Thrivent Financial Defined Contribution Plan Trust (“the Trust”) is Empower Trust Company, LLC (the “Trustee”), formerly known as Great-West Trust Company, LLC prior to a name change effective August 3, 2022. The Plan sponsor is Thrivent Financial for Lutherans (“Thrivent”), a Wisconsin-domiciled fraternal benefit society. The Plan uses an Employee Benefit Administration Committee as the Plan Administrator (a fiduciary) as defined by ERISA.

The following description of the Plan provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan’s provisions.

Eligibility

Substantially all corporate employees and field representatives of Thrivent are eligible to participate in the Plan.

Contributions

Participants are automatically enrolled at a 6% contribution rate, unless the participant opts out or elects a different contribution rate up to a maximum of 75% of earnings. For most corporate employees, Thrivent makes a matching contribution equal to 100% of the participant’s contributions, up to 6% of earnings (specifically, “Considered Compensation”) for a maximum matching contribution of 6%. Field representatives who have not made a transition election (i.e., elected to continue in certain grandfathered retirement benefits) do not receive a match. Matched and non-matched contributions may be made from either before-tax earnings or, in the case of the Roth 401(k) option, after-tax earnings.

Aid Association for Lutherans Participants Who Made a Transition Election

Participants employed by Aid Association for Lutherans (“AAL”) before January 1, 2002 who made a transition election will receive a matching contribution, from Thrivent, equal to 65% of the participant’s contributions up to 5% of earnings (specifically, “Considered Compensation”) for a maximum match of 3.25%.

Participant Accounts

Each participant designates how their account is allocated among investments within the Trust. The Trust is maintained apart from the general assets of Thrivent.

The Plan invests contributions in selected funds as designated by each participant. Participants may elect to have their contribution invested into any combination of the following: ten core mutual funds and pooled funds, five of which are affiliated with Thrivent; one third-party fund, Vanguard Retirement Savings Trust (a common collective trust fund); and a Self-Directed Brokerage Account (“SDBA”). In the SDBA, participants can purchase a wide selection of publicly traded mutual funds, exchange traded funds (“ETF”) and exchange traded notes (“ETN”). Additional fees are paid by the participant to invest in the SDBA. One grandfathered deposit administration contract with Thrivent is closed to new contributions. The core mutual funds and pooled funds have specific financial objectives, offering various levels of risk and corresponding levels of potential returns. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Notes to Financial Statements

Note 1. Description of the Plan, continued

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants accrue a vested interest in Thrivent's matching contributions and related investment income or loss at the rate of 20% upon completion of one year of service, and an additional 20% upon completion of each succeeding year of service until fully vested at the end of five years. In the event of death, disability, or attainment of age 65, while still employed, a participant's interest in Thrivent's contributions and related investment income or loss becomes 100% vested.

The non-vested amounts are forfeited when a participant terminates employment and used to reduce Thrivent's matching contributions. Forfeitures for the years ended December 2024 and 2023, were \$2,211,000 and \$1,113,000, respectively.

Payment of Benefits

Upon termination of service, participants may elect to receive either a lump-sum amount equal to the value of their account, installment payments, periodic partial payments, or for certain grandfathered participants, a portion of the value of the account may be used to purchase an annuity policy with an insurance carrier. Participants can elect to make partial or full withdrawals of contributions, subject to certain limitations.

Notes Receivable from Participants

The Plan provides for up to three loans to active participants with a vested account balance of at least \$2,000 and are subject to limitations based on the participant's vested account balance. Generally, the duration of the loan cannot exceed five years and will be repaid through payroll deductions. These loans bear interest at the prime rate plus 1% and are secured by the vested employee account balance.

Certified Investment Information

Thrivent has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for reporting and disclosure under ERISA. Thrivent has obtained certifications from the Trustee, a qualified institution, that certain financial information included in the Plan's financial statements, notes to the financial statements and Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024 and for the year then ended that total investments of \$1,708,658,000 and investment income/(loss) of \$235,697,000 are complete and accurate.

Plan Termination

Thrivent's Board of Directors may amend or terminate the Plan at any time. Upon termination of the Plan or discontinuance of the contributions, participants shall become fully vested. Thrivent does not have any current intentions to terminate the Plan.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements have been prepared on the accrual basis of accounting in accordance with U.S. Generally Accepted Accounting Principles ("GAAP").

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Interest in the Trust

The Plan is part of the Trust. The Plan's interest in the Trust and share of investment activities are based upon the total of the participants' Plan accounts. The assets of the Trust consist of assets of the Plan and assets of the Capital Accumulation Plan ("CAP"). The Plan's interest in the net assets of the Trust was approximately 80% for the years ended December 31, 2024 and 2023.

Valuation of Investments

Interest in Thrivent Financial Defined Contribution Plan Trust

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). All financial instruments are valued at fair value on a recurring basis. Each of the financial instruments has been classified into one of three categories based on the significance of observable and unobservable inputs, except for investments measured at Net Asset Value ("NAV") as a practical expedient for fair value. A Level 1 financial instrument is valued using quoted prices for identical assets in active markets that are readily accessible. A Level 2 financial instrument is valued based on quoted prices for similar instruments in active markets that are readily accessible, quoted prices for identical or similar instruments in markets that are not active, or model-derived valuations where the significant value driver inputs are observable. A Level 3 financial instrument is valued using significant value driver inputs that are unobservable. If a financial instrument is valued using both observable and unobservable inputs, the most significant input used in the valuation dictates the level where the instrument is reported.

Mutual Funds and Self-Directed Brokerage Account: The Plan's investments in the core mutual funds and the self-directed brokerage option are stated at fair value. There are no restrictions on the participant's ability to redeem investments. The Plan's self-directed brokerage option gives participants the choice to invest in various mutual funds including exchange-traded funds, exchange-traded notes and closed-ended mutual funds.

Note 2. Summary of Significant Accounting Policies, continued

Valuation of Investments, continued

Common Collective Trust Funds: The Plan's investment options include various Blackrock and Vanguard funds. The fair value of common collective trust funds is determined by the NAV of the funds. NAV is used as a practical expedient and represents the exit price for the funds. Collective investment funds are traded in principal-to-principal markets with little publicly released pricing information.

Deposit Administration Contract with Thrivent – Insurance Carrier

The deposit administration contract is a fully benefit-responsive investment contract, backed by Thrivent's general account assets, and as such, contract value is the appropriate measurement for its portion of the net assets available for benefits. Contract value represents contributions, plus interest, less deductions for benefits paid. This investment option is closed to new contributions.

Notes Receivable from Participants

Notes receivable from participants are stated at their unpaid principal balances plus any accrued but unpaid interest. Interest income is calculated and added to the balance based on a biweekly amortization schedule. A loan origination fee and an annual loan maintenance fee is paid by the participant.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Trustee fees, record keeping fees, and other expenses the Plan incurs are paid by the Plan unless Thrivent elects to pay the expenses. Expenses are recognized when paid by the Plan. The expenses of investment options, including commissions, investment management fees, and other transactional costs, are paid out of the investment options and reduce the investment option's rate of return. Participants are charged fees for loan set-up and loan maintenance, hardship withdrawals, processing qualified domestic relations orders, participating in the SDBA option, and participating in the managed account option. All the plan fees may change from time to time.

Subsequent Events

The Plan evaluated events and transactions that occurred after the date on the Statement of Net Assets Available for Benefits for potential recognition or disclosure through October 1, 2025, the date the financial statements were available to be issued. There were no subsequent events or transactions which required recognition or disclosure.

Note 3. Investments

A portion of the investments of the Plan are held in the Trust, which was established by Thrivent. The Trust administers the assets of the Plan. The Plan has a divided interest in the net assets and investment income of the Trust.

Level 1 financial instruments include the investments in the Trust's core mutual funds and investments held in the SDBA, whose fair values are primarily based on net asset values traded in active markets and quoted prices are readily available.

Financial Instruments Valued using Net Asset Value

The fair value of common collective trust funds is determined by the NAV of the funds. NAV is used as a practical expedient and represents the exit price for the funds. These funds are excluded from classification in the fair value hierarchy. Collective investment funds are traded in principal-to-principal markets with little publicly released pricing information.

Note 5. Parties in Interest Transactions

Empower provides the recordkeeping, administrative and custodian services for the Plan and Empower Trust Company, LLC is the directed corporate trustee for the Trust. The Plan uses an Employee Benefit Investment Committee (“the Committee”) to make decisions on investment options for the Plan participants. The Committee is comprised of employees of Thrivent. All contributions by the participants and Thrivent are made to the Trustee. Contributions can be invested in five mutual funds sponsored by Thrivent, five third-party mutual funds and pooled funds, the Vanguard Retirement Savings Trust, and the SDBA. The Trustee authorizes payments for investments at the direction of the participants. Notes receivable from participants are considered party of interest transactions. These transactions are specifically exempted from the prohibited transactions under Section 406 of ERISA.

Note 6. Tax and Other Regulatory Matters

The Plan is qualified under Section 401(a) of the Internal Revenue Code (“the Code”), and therefore, the related trust is exempt from taxation. Effective January 1, 2017, the IRS will no longer issue determination letters to qualified plans on a five-year cycle to evidence compliance with IRS rules. The IRS has determined and informed the Company by a letter dated July 26, 2016, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. The Plan administrator believes the Plan is qualified and remains exempt from taxation; therefore, no tax contingencies or provisions for uncertain tax positions that warrant disclosure in accordance with GAAP have been recorded. The Plan is no longer subject to income tax examinations for years prior to 2021.
