Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

We have performed audits of the accompanying financial statements of Libbey Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Libbey Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

December 31, 2024 and 2023

1. Description of Plan

The following description of the Second Amended and Restated Libbey Retirement Savings Plan (the "Plan") is provided for general information purposes only. Participants should refer to the summary plan description or plan document for more complete information about the Plan. Copies of these documents are available at the corporate office of Libbey Glass LLC (the Company, the Plan Administrator, and Plan Sponsor).

General

The Plan was adopted by Libbey Glass LLC for the benefit of eligible salary and non-union hourly employees. The Plan is a defined contribution plan that provides eligible employees the opportunity to make pre-tax and/or after-tax contributions, in specific percentages, within guidelines established by the Employee Benefits Committee of Libbey Glass LLC (the "Committee"). The Plan is administered by the Committee, and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended. Participant contributions are limited to 50% of their eligible wages and are immediately 100% vested. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Contributions are allocated at the participant's discretion among the various investment options with no limit on the number of options selected. A participant may elect to change the percentage of eligible compensation to be contributed, and any such changes shall be effective as soon as administratively feasible.

The Company typically contributes to the Plan on behalf of each participant an amount equal to 100% of the participant's first 6% of pre-tax contributions not to exceed 6% of the participant's eligible compensation. Company matching contributions are allocated to investments based on the participant's deferral elections. Company matching contributions are immediately 100% vested. A newly eligible participant will be automatically enrolled at a pre-tax contribution rate of 3% of eligible compensation unless an affirmative election is made to contribute at a different rate. Enrollment occurs as soon as administratively feasible following the first 30 days of becoming eligible. If another election is not made, these contributions will be deposited into the Plan's default fund. The default fund is a target-date (or "life cycle") fund that applies generally accepted investment theories, is diversified to reduce the risk of large losses, and provides varying degrees of long-term appreciation and capital preservation through a mix of equity and fixed income exposures based on age. In addition, the rate of pre-tax contributions will automatically increase 1% each year until the pre-tax deferral rate is 6% of eligible compensation. The participant has the opportunity to waive the automatic enrollment provision or elect to contribute a different percentage of compensation by contacting the recordkeeper.

Within certain limitations of the Internal Revenue Code (IRC), a participant may also transfer into the Plan by making a rollover contribution from another qualified plan.

The above information is intended as a general description of the Plan's operating guidelines. Reference should be made to the plan document for more specific provisions, including benefit payments.

Plan Termination

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. Upon Plan termination, the entire interest of each participant's account is distributed to the participants.

Assets in Trust

At December 31, 2024 and 2023, Empower Annuity Insurance Company and Empower Trust Company, LLC was the Plan's Trustee, and the Plan utilizes record keeping services Empower Retirement Plan Services.

Notes to Financial Statements (continued)

Investments

Participants may direct the investment of their contribution, the Company's matching contribution and their account balances into various investment options offered by the Plan and may change investments and transfer amounts between funds daily, within certain limitations. Including the various retirement target date funds, the Plan offers over 25 different mutual funds across several asset categories including US and International equities and fixed income funds, through nine registered investment companies, a stable asset income fund and a pooled separate fund.

Distributions of Benefits

Distribution of vested benefits may be made upon the occurrence of any one of the following:

- In-service withdrawal on or after attainment of age 59-1/2;
- Total and permanent disability, as defined in the Plan, of the participant;
- Death of the participant;
- Termination of employment; or
- Financial hardship that complies with Internal Revenue Service (IRS) regulations.

Benefits due upon death are generally paid in a lump sum or installments. Death benefits are based on amounts in the participants' accounts. Benefits due upon termination, withdrawal, or disability are paid in a lump sum or installments of a substantially equal amount for a period of time not to exceed the life expectancy of the participant or the participant's designated beneficiary, as applicable, and are based on vested amounts in the participants' accounts.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's matching contributions and their respective share of investment fund earnings (losses) and administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the value of the participant's account.

Plan Amendments

The Plan was amended in 2023 to allow participants to enroll in a Roth IRA effective January 1, 2024. A participant can make an unrestricted conversion to a Roth IRA, including rollover contributions consisting of non-Roth amounts, through an in-Plan conversion, except any amount subject to a plan loan which is not eligible for conversion.

Subsequent Events

The Company has evaluated all subsequent events through August 27, 2025, the date the financial statements were available to be issued, noting no events occurring subsequent to December 31, 2024, but before August 27, 2025, that require consideration as adjustments to or disclosures in the financial statements.

2. Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America.

Notes to Financial Statements (continued)

Payment of Benefits

Benefit payments to participants are recorded when paid. There were no participants, who elected to withdraw from the Plan, but had not yet been paid at December 31, 2024. Termination benefit distributions requests are processed the same day as they occur however certain requests made via paper require processing time or additional documentation such as in-service distributions, hardships, or loans requested by paper forms (not electronic) loans.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Plan Expenses

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan's provisions. Administrative expenses generally paid by the Plan include recordkeeping, consulting and trustee fees. Expenses relating to purchases, sales or transfers of the Plan's investments are included in net appreciation of fair value of investments. All other administrative expenses of the Plan are generally paid by the Company.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts in the financial statements and accompanying notes and supplemental schedules. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded. As of December 31, 2024, participant loans have interest rates ranging from 4.25% to 9.50%.

Transfers

Along with the Plan, the Company also sponsors the Libbey Supplemental Retirement Plan, a defined contribution plan for union hourly employees. If employees change their employment status from salary or non-union hourly to union hourly or vice-versa during the year, their account balances are transferred into or from the Libbey Supplemental Retirement Plan. There were no pending transfers for the year ended December 31, 2024.

Excess Contributions Payable

The Plan is required to re-characterize or return contributions received during the Plan year in excess of the IRC limits. There were no Plan payables as of December 31, 2024 or 2023.

3. Investment Information Certified by Trustee

All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants as of December 31, 2024 and 2023, and net realized and unrealized appreciation (depreciation) in fair value of investments, interest, dividends and interest income on notes receivable from participants for the year ended December 31, 2024, were obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Empower Annuity Insurance Company and Empower Trust Company, LLC, as of December 31, 2024 and 2023 and for the year ended December 31, 2024 in accordance with Section 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information has not been examined by independent auditors.

4. Fair Value Measurements

The Financial Accounting Standards Board (FASB) Accounting Standard Codification (ASC) 820, *Fair Value Measurements*, establishes a framework for measuring fair value. The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

- Level 1 — Fair value is based on unadjusted quoted prices for identical assets or liabilities in an active market that the Plan has the ability to access at the measurement date.
- Level 2 — Fair value is based on quoted prices in markets that are not active, quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability.
- Level 3 — Fair value is based on prices or valuation techniques that require inputs that are both significant to the fair value measurement and unobservable. These inputs reflect management's judgment about the assumptions that a market participant would use in pricing the investment and are based on the best available information, some of which may be internally developed.

Following is a description of the valuation techniques and inputs used for each major class of assets measured at fair value by the Plan:

- *Registered investment companies:* Valued at quoted market prices, which represent the net asset value (NAV) of shares held by the Plan at year-end.
- *Common collective trust:* A stable value fund that is composed primarily of fully benefit-responsive investment contracts that is valued at the NAV of units of the common collective trust.
- *Pooled separate accounts:* Valued using the NAV of units calculated daily by the annuity provider according to the methods outlined in the annuity contract.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

5. Notes Receivable from Participants

The Plan permits participants to borrow up to a maximum of \$50,000, or 50%, of their investment balance once their investment balance reaches \$1,000. Loans are made subject to certain conditions and limitations specified in the plan document and are repaid in semi-monthly or weekly installments, including interest, over periods of between one to five years or up to 10 years for the purchase of a primary residence. A participant is entitled to a maximum of two loans; however, the loans must be initiated 12 months apart. Participant loans are collateralized by their account balances. The rate at which loans bear interest is established at the inception of the borrowing, based on the prime rate then being charged by the Trustee plus 1%. Repayments of loans, including the interest portion thereof, are reinvested on the participants' behalf in accordance with their current choice of investment options. If a participant terminates employment from the Company, the participant must make arrangements with the record keeper to pay off the loan, otherwise it will be treated as a distribution to the participant after 90 days.

6. Income Tax Status

The Plan has received a determination letter from the IRS dated May 1, 2014, stating that the Plan is qualified under applicable sections of the IRC and therefore, the related trust is exempt from taxation. Subsequent to this determination by the IRS, the Plan was amended. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and therefore, believes the Plan is qualified and the related trust is tax-exempt. The Plan's amendment during 2020 to name the Company as the Plan Sponsor, did not result in any loss of qualified status. As a result of the amendment, the Plan was assigned a new employer identification number from the IRS.

U.S. GAAP requires plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Parties-in-Interest

The investments in the notes receivable from participants, described in Note 2, qualify as party-in-interest transactions. There have been no known prohibited transactions with a party-in-interest.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
