## INDEPENDENT AUDITORS' REPORT

To the Administrative Committee of the

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of the Ortho Development Corporation 401(k) Profit Sharing Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**NOTES TO FINANCIAL STATEMENTS**

**(1) Description of the Plan**

The following description of the Ortho Development Corporation 401(k) Profit Sharing Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan's provisions, which are available from the Plan administrator.

- A. **General** – The Plan, which was formed on May 15, 1995, is a defined contribution plan covering all eligible employees of Ortho Development Corporation (the "Company" or "Plan sponsor"), as defined in the Plan document. The Plan is designed to qualify under Sections 401(a) and 401(k) of the Internal Revenue Code (the "IRC") as amended and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Administrative Committee is responsible for oversight of the Plan. The Administrative Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

The Plan has arranged for Fidelity Management Trust Company ("Fidelity" or "Trustee") to serve as Trustee, and Fidelity Workplace Services, LLC (the "recordkeeper"), to provide record keeping services for the Plan.

Plan Change – Under the provisions of the SECURE 2.0 act, effective January 1, 2024, the automatic force out distribution limit was increased from \$5,000 to \$7,000. The Plan implemented this change and will be amended for this provision by the time prescribed.

Effective April 1, 2024, the Plan was amended to reduce the service requirements at which participants are eligible to participate in the Plan from 6 months to 3 months.

- B. **Contributions** – Employees are eligible to participate in the Plan upon the completion of 6 months of service, or 3 months of service effective April 2024. Entrance to the Plan occurs on the first day of each month after eligibility requirements have been met. Participants may elect to contribute up to 96% of their annual eligible earnings on a pre-tax basis, plus catch-up contributions, subject to the maximum amount allowable by the Internal Revenue Service ("IRS") (\$23,000 for participants to age 50 and \$30,500 for participants over 50 years of age for the year ended December 31, 2024). Participants may also make post-tax (ROTH) contributions and contribute amounts representing distributions from other tax qualified retirement plans. Safe harbor employer matching contributions are made each pay period by the Company. The amount contributed is based on a match of 100% of the participant's elective deferral for the pay period up to 3% of the participant's eligible earnings and then 50% of the next 2% contributed. In addition, the Company may make discretionary nonelective contributions to the Plan each year in amounts determined by the Company. There were no discretionary non-elective contributions made during the year ended December 31, 2024.
- C. **Participant investment account options** – The Plan currently offers registered investment companies and a stable value collective trust fund as investment options for participants. Participants may also purchase shares of other investments, such as mutual funds and common stocks not offered by the Plan through self-directed brokerage accounts.
- D. **Participant accounts** – Each participant's account is credited with the participant's contributions, safe harbor employer matching contributions, and an allocation of the Company's discretionary non-elective contributions (if any), and the Plan's earnings and losses, which include administrative expenses. Allocations are based on participants' earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**(1) Description of the Plan (continued)**

- E. **Vesting** – Participants are immediately vested in their voluntary contributions, earnings thereon, and rollover contributions. Beginning January 1, 2017, participants also immediately vest in the Company’s safe harbor matching contributions. Employer matching contributions made prior to January 1, 2017 and discretionary non-elective contributions (if any) are subject to the following vesting schedule:

<u>Years of Service</u>	<u>Vested Percentage</u>
More than 1 year	25%
2 years	50%
3 years	75%
4 or more years	100%

Participants also become 100% vested when the participant reaches normal retirement age defined under the Plan (65), incurs a disability as defined by the Plan, or upon death.

- F. **Notes receivable from participants** – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance with terms from 1 year up to 5 years. Loans related to the purchase of a primary residence are allowed to have terms up to 10 years. The loans are secured by the balance in the participant’s account and bear interest at the prevailing market rate, determined using the prime rate plus 2%. As of December 31, 2024, the interest rates for all outstanding notes receivable ranged from 5.25% to 10.50%. Principal and interest are paid ratably through bi-weekly or semi-monthly payroll deductions, and loan payoffs may be made directly by the participant without penalty.
- G. **Payment of benefits** – Participants may receive the vested interest of their Plan account through a distribution of benefits upon retirement, death, termination of employment, or a qualifying withdrawal. Benefit payments are made in a lump sum distribution or as rollover contributions to another plan. Participants terminating employment prior to obtaining an account balance of at least \$1,000 may receive a force-out lump sum distribution from the Plan upon termination. Participants terminating employment with a balance between \$1,000 and \$7,000 may have their account balance rolled by the Plan into an Individual Retirement Account upon termination. Participants who terminate with a balance of greater than \$7,000 are not subject to these automatic distribution provisions.
- H. **Forfeited accounts** – As of December 31, 2024 and 2023, forfeited non-vested accounts in the Plan totaled \$23 and \$23, respectively. Forfeited non-vested accounts may be used to offset future employer matching contributions or pay administrative expenses. During the year ended December 31, 2024, there were no forfeited non-vested account balances used to offset employer matching contributions or administrative expenses.

**(2) Summary of significant accounting policies**

**Basis of accounting** – The financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

**Use of estimates** – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

**Investment valuation and income recognition** – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the Trustee. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Contributions** - Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

**Cash** – Cash is non-interest bearing and consists of amounts that have not been used by participants to invest in funds within the Plan.

**Notes receivable from participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged to the participant's account as administrative expenses and are expensed when they are incurred.

**Payment of benefits** – Benefits are recorded when paid.

**Administrative expenses** – Certain expenses of the Plan are paid by the Company and are not included in the statement of changes in net assets for benefits. Expenses related to investment advisory services, management fees, maintenance of participant accounts, and Plan administration are paid by the Plan. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

**(3) Information prepared and certified by the Trustee**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company has certified that the following data included in the accompanying financial statements and supplemental schedule of assets (held at end of year) are complete and accurate with respect to investments and notes receivable from participants:

- Investments at fair value
- Notes receivable from participants
- Interest income from notes receivable from participants
- Interest and dividend income
- Net appreciation in fair value of investments
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule of assets (held at end of year).

**(4) Fair value measurements**

The Financial Accounting Standards Board (“FASB”) Accounting Standards Codification Topic 820 (“ASC 820”), *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Registered investment companies:* Valued at the daily closing price as reported by the registered investment companies. The funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (“NAV”) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

*Self-directed brokerage accounts:* The underlying investments in the self-directed brokerage account are measured at fair value as follows:

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common stocks and exchange-traded funds:* Valued at the closing price reported on the active market on which the individual securities are traded.

*Interest-bearing cash:* Valued at the account balance at year end.

*Stable value collective investment trust:* A stable value fund that is composed primarily of fully benefit-responsive investment contracts is valued at the NAV of units of the bank collective trust. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the account less its liabilities. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the stable value collective trust, the issuer reserves the right to require 12-months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

The stable value collective investment trust consists of the Columbia Trust Stable Income Fund, which is generally redeemed on a daily basis. The Trustee, in its discretion, may process redemptions in cash as soon as practicable, but payments are not required to be made until after the actual settlement date with respect to investments sold to raise cash for redemption. In addition, such payments may be delayed if the Trustee determines it cannot reasonably make such payment due to reasons beyond its control. Additionally, there are no unfunded commitments.

**(5) Related party transaction and party-in-interest transactions**

Certain investments of the Plan are managed by Fidelity Management Trust Company. Fidelity is the Plan's Trustee and recordkeeper, and therefore, the transactions are considered exempt party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than direct payment. As described in Note 2, certain other administrative expenses paid from Plan assets directly to the recordkeeper, qualify as party-in-interest transactions and totaled \$5,500 for the year ended December 31, 2024.

**(6) Plan termination**

Although it has not expressed any intent to do so, the Plan sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in all employer contributions.

**(7) Tax status**

The Company has adopted a pre-approved plan document that has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**(8) Risks, uncertainties, and concentrations**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic, tariffs, or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

As of December 31, 2024 and 2023, approximately 21%, of the Plan investments were invested in one investment option, respectively.

**(9) Subsequent Events**

Effective January 1, 2025, the Plan documents were amended to exclude any imputed income from group-term life insurance in excess of \$50,000 from eligible compensation.

The Plan has evaluated subsequent events through October 9, 2025, which is the date the financial statements were available to be issued.
