## **Independent Auditor's Report**

To the Plan Administrator

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of Blue Ocean Realty, LLC Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE 1 – DESCRIPTION OF PLAN

The following brief description of the Blue Ocean Realty, LLC Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Blue Ocean Realty, LLC (the Company) who have attained the age of 18. Employees are eligible to participate in the Plan the first day of the quarter following the date of hire. All eligible employees are auto enrolled into the plan, unless they opt out. The Plan became effective June 1, 2011. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants have the right to elect to defer a portion of their compensation which will then be contributed on their behalf to the Plan. For 2024 and 2023, the maximum statutory limits for employee deferrals are \$23,000 and \$22,500, respectively. For 2024 and 2023, employees 50 years of age or older could defer a maximum of \$30,500 and \$30,000, respectively. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company contributes a matching contribution as determined by the Company. The Company may also, at its discretion, contribute an additional amount to each participant's account, as determined on a yearly basis by the Company. There were no discretionary contributions made during 2024 and 2023.

Participant Accounts

Each participant's account is participant-directed and is credited with the participant's contribution, the employer matching contribution, allocations of the Plan earnings and or losses, and charged with an allocation of administrative expenses in excess of forfeitures. Allocations are based on participant earnings or account balances, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are 100% vested in their contributions and Company's matching contributions plus actual earnings thereon.

Payment of Benefits

Upon termination of service, a participant (or designated beneficiary) may elect to receive an amount equal to the value of the interest in their account. The Plan allows for distributions upon termination of service, death, disability, attainment of age 59 1/2, or in certain hardship situations. A participant may elect to receive a lump sum payment, an annuity or may roll over the value of their account into another qualified plan. Hardship distributions are permitted if certain conditions are met. After, the withdrawal, the participants may not make contributions to the Plan for six months. These hardship withdrawals are subject to IRC restrictions and penalties.

Forfeitures

Forfeitures resulting from overfunded employer contributions are used to reduce the contributions of the Company and to pay the administrative fees of the Plan. As of December 31, 2024 and 2023, the forfeited account balance was \$21, respectively.

Administrative Costs

The Plan pays the reasonable expenses for administration of the Plan and the Company also pays expenses for the Plan, including audit costs and some administrative costs. Certain investment management fees and other charges paid to the Trustee are offset against fund performance in net realized and unrealized depreciation in fair value of investments. Participants are also charged a quarterly maintenance fee.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are presented on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates that affect the reported amounts in the financial statements and accompanying notes. Accordingly, actual results could differ from those estimates.

Investment Valuation

Investments are reported at fair value. Quoted market prices are used to value these investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold and held during the year.

Distributions

Distributions to participants are recorded when paid.

NOTE 3 – FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) guidance for fair value measurement and disclosure provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB guidance are described as follows:

- Level 1 – Observable inputs such as quoted prices (unadjusted) in active markets for identical as identical assets or liabilities;

- Level 2 – Inputs other than quoted prices that are observable for the asset or liability either directly or indirectly. These include quoted prices for similar assets or liabilities in active markets and quoted prices for identical or similar assets or liabilities in markets that are not active; or
- Level 3 – Unobservable inputs that reflect the reporting entity’s own assumptions.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Investments measured at fair value on a recurring basis consisted of mutual funds in the amount of \$2,233,850 and \$1,978,546 as of December 31, 2024 and 2023 and are categorized as Level 1 in the hierarchy. The Plan did not have Level 2 or 3 investments as of December 31, 2024 and 2023, respectively.

#### NOTE 4 – INFORMATION CERTIFIED BY THE PLAN’S TRUSTEE (UNAUDITED)

Investments are carried at market value and held by Empower as of December 31, 2024 and 2023, the Trustee of the Plan.

All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023 and net realized and unrealized appreciation in fair value of investments, dividend and interest income for the year ended December 31, 2024 are based on information certified by the Trustee as complete and accurate in accordance with Section 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under the Employment Retirement Income Security Act of 1974.

#### NOTE 5 – INCOME TAX STATUS

The Plan obtained its latest IRS determination letter dated June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

#### NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS

As of December 2024, Empower was the trustee and the record keeper as defined by the Plan during 2024. Transactions involving these instruments are party-in-interest transactions.

NOTE 7 – CORRECTIVE ACTION

The Plan’s employee deferrals on employer matches were not calculated on the employee's full compensation. As of the year ended December 31, 2024 the estimated amount owed to the employees as catch up including lost earnings is \$30,500.

NOTE 8 – RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for plan benefits.

NOTE 9 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts. The Company has the right to terminate the Plan at any time, although it has no intention to do so. The Company will provide for the orderly distribution of benefits either at the of Plan termination or at a later date.

NOTE 10 – PROHIBITED TRANSACTIONS

During the plan year ended December 31, 2024, the Company failed to remit an aggregate of \$85,951 of participant contributions timely on 9 occasions, as reflected in the supplemental schedule of delinquent participant contributions. The Company will submit additional funds for lost earnings in the amount of \$245 to the affected participant accounts during 2025. The Company reported these transactions to the IRS under its voluntary correction program.
