The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

#### Note 1: Description of Plan

The following description of the Northeast Michigan Community Service Agency, Inc. Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan established by Northeast Michigan Community Service Agency, Inc. (the "Employer"). Participants of the Plan include all employees working in eligible classes of the Employer who have completed at least 60 days of continuous service, and attainment of age 18. Employees are eligible to receive the Employer contributions after reaching the age of 18 and completing 1 year of service. Ineligible classes of employees are leased employees, reclassified employees, senior corp participants, senior community employment program participants, Federal or State job training employees, and Title V program participants. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. All investments are participant-directed.

In December 2022, Securing a Strong Retirement Act (SECURE 2.0) was passed into law. The provisions of SECURE 2.0 continue the themes and reforms that began with the 2019 CARES Act. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Plan management will determine the optional provisions to elect in the future.

#### Contributions

Each year, participants may contribute any amount up to a maximum of 100% of annual compensation as defined in the Plan, as either pretax contributions or Roth contributions, which are after-tax contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants who have reached the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Effective January 1, 2024 eligible employees have automatic elective deferrals at 5% on the date they become eligible to participate in the Plan, unless a different deferral percentage is chosen or employee chooses not to defer. Before January 1, 2024, eligible employees had automatic elective deferrals at 3%. The automatic deferral amount will increase by 1% annually up to a maximum of 10%. The Employer will make Qualified Nonelective Contributions in the amount of 3% of each participant's eligible compensation. The Plan also allows for additional Employer contributions of 7% of each participant's eligible compensation if the employee has been employed more than 5 years and 2% of their eligible compensation if they have been employed less than 5 years. The Employer contributes to the Plan on a monthly basis. During 2024, the Employer made Qualified Nonelective Contributions of \$630,090 and \$1,072,075 additional contribution. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

##### **Participant Accounts**

Each participant's account is credited with the participant's contributions, Employer qualified nonelective contributions, additional Employer contributions, and plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### **Vesting**

Participants are fully and immediately vested in their voluntary contributions plus Employer qualified nonelective contributions, additional contributions, and actual earnings thereon.

##### **Payment of Benefits**

On termination of service a participant may elect to receive an amount equal to the value of the participant's vested interest in their account in a lump-sum amount as defined in the Plan agreement. If the participant's vested account balance does not exceed \$5,000, it can be distributed only in a single lump-sum payment. In addition, a participant may elect to receive a lump-sum distribution of vested balances from the Plan while still employed with the Employer if the participant has reached 59 1/2 years old at the time of distribution. Also, hardship distributions are permitted if certain criteria are met.

#### **Note 2: Summary of Significant Accounting Policies**

##### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

##### **Use of Estimates in Preparation of Financial Statements**

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

##### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts (FBRICs)). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

FBRICs are reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

##### **Payment of Benefits**

Benefits are recorded when paid.

##### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Employer and are excluded from these financial statements. Fees related to recordkeeping and for certain transactions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are allocated proportionately to plan participants based on their respective account balances and are included in total investment income.

##### **Subsequent Events**

The Plan has evaluated subsequent events through October 6, 2025, which is the date the financial statements were available to be issued.

#### Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs are used if Level 1 or Level 2 inputs are not available. There were no plan assets requiring the use of Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Mutual funds held in pooled separate accounts:* Fair value of mutual funds held in pooled separate accounts is based on quoted net asset values of underlying investments held by the pooled separate accounts adjusted by an asset charge. The underlying mutual funds held in the pooled separate accounts are open-ended mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price.

*Common collective trust:* Investments in common collective trusts are valued using a readily available fair value based on the fair value of the underlying securities in which the account is invested. The readily determinable fair value is used if the fair value per share is determined and published and is the basis for current transactions. There are currently no redemption restrictions or unfunded commitments on these transactions.

#### Note 4: Fully Benefit-Responsive Group Annuity Contract (FBRIC)

The Plan invests in a FBRIC with Lincoln Financial Group in the form of a guaranteed investment contract (GIC) that invests in traditional investment contracts. Lincoln Financial Group maintains the contributions in its general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Lincoln Financial Group is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The GIC is carried at contract value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contract issuer is contractually obligated to repay the principal and specified interest rate that is guaranteed to the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a semi-annual basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer including plan termination and other events as described in the contract. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants or the issuer are probable of occurring.

#### **Note 5: Information Prepared and Certified by the Custodian**

The Employer has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends and interest for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company, the Custodian of the Plan.

#### **Note 6: Party-in-Interest Transactions**

Certain plan investments are managed by an affiliate of Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company. Principal Trust Company is the Custodian, as defined by the Plan and, therefore, these transactions qualify as a party-in-interest transactions. Fees incurred and paid by the Plan for recordkeeping and third party administration were \$107,336 for the year ended December 31, 2024. Fees incurred and paid by the Plan for providing investment advisor services were \$48,872 for the year ended December 31, 2024 and were offset against earnings.

#### **Note 7: Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

#### **Note 8: Tax Status**

The Employer adopted a non-standardized pre-approved profit sharing plan with an IRS notification letter which states the pre-approved plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the notification letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

#### **Note 9: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **Note 10: Prohibited Transactions**

Under DOL Reg. 2510.3-102(b), the Plan is required to remit the employee contributions to the Plan at the earliest date such amounts can be reasonably segregated from the Plan's general assets, but no later than the fifteenth business day of the month following the date that participant contributions are withheld by the Plan. As reported on Schedule H, Line 4a – Schedule of Delinquent Participant Contributions, certain contributions for payrolls during the plan year ended December 31, 2024, totaling \$69,273, were remitted outside the 15-day requirement. These transactions constitute a prohibited transaction as defined by ERISA.
