**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the Conn-Weld Industries, LLC 401(k) Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Conn-Weld Industries, 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General - The Plan is a defined contribution 401(k) plan covering the employees of Conn-Weld Industries, LLC (the Company). The Plan began operations on January 1, 2021 in connection with the formation of the Company and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility - All full-time employees of the Company, except excluded employees that include those who are collectively bargained or are non-resident aliens, are eligible to be participants in the Plan upon hire. Eligible part-time employees can participate in the Plan upon completion of a year of service, defined as 1,000 hours of service within their first 12 consecutive months.

Contributions - Participants may contribute pretax or Roth qualifying compensation, subject to statutory limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollovers). Participants direct the investment of all contributions into various investment options offered by the Plan.

The Company makes safe harbor matching contributions to the Plan in an amount equal to 100% of the employee's contributions up to 3% of the employee's compensation, plus 50% of the employee's contribution that exceeds 3%, but is not greater than 5%. Additionally, the Company may make discretionary matching contributions based upon a percentage of participant salary deferrals made during the Plan year, or as a uniform dollar amount. For the year ended December 31, 2024, the Company did not make a discretionary matching contribution.

Participant Accounts - Each participant's account is credited with the participant's contribution and allocations of the Company's contributions and Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their voluntary contributions and the Company's safe harbor and discretionary matching contributions plus actual earnings thereon.

Payment of Benefits - Upon retirement, permanent disability, death, or other termination of employment, a participant is entitled to the fair market value of their account as of the day of their separation or termination. Participants may elect to receive benefit payments in a single lump sum or as a life annuity, or a combination of such, depending on marital status and elections made. The Plan requires that all participant accounts valued at less than \$5,000 at the time of termination are distributed to the employee or to another qualified account.

The Plan provides for withdrawals, other than distributions to terminated employees, based on financial hardship. The Plan administrator may determine that a financial hardship exists based on several events outlined in the Plan document, including expenses for medical care, payment of tuition expenses, costs related to the purchase of a personal residence, and payments necessary to prevent the participant from being evicted from their principal residence.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of significant accounting policies consistently applied by the Plan administrator in the preparation of the accompanying financial statements follows:

**Basis of Accounting** - The financial statements of the Plan are presented on the accrual basis of accounting.

**Use of Estimates** - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** - Investments are reported at fair value (except for the fully benefit-responsive contract, which is reported at contract value), which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. (See Note 4 for discussion of fair value measurement.)

**Purchases and sales of securities** are reflected on a trade-date basis. Interest income is recorded as earned on an accrual basis. The net appreciation in the fair value of investments consists of the realized gains and losses and the unrealized appreciation and depreciation on these investments during the year. Dividends are recorded on the ex-dividend date.

**Notes Receivable to Participants** - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance for a term not to exceed five years, with the exception of a loan for the purchase of a principal residence which can be for a term not to exceed 30 years. The loans are collateralized by the balance in the participant's account and bear interest at a rate commensurate with the prime rate at the time of the loan, plus 1%. Principal and interest is paid ratably through payroll deductions. The Plan allows participants to have one outstanding loan at any time.

**Benefit Payments** - Payments to participants are recorded when paid.

**Administrative Expenses** - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

**Risks and Uncertainties** - The Plan invests in various investment securities that are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

**Subsequent Events** - The Plan administrator has evaluated subsequent events through August 27, 2025, the date that the financial statements were issued.

NOTE 3 - CERTIFICATION OF FINANCIAL INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and income from notes receivables from participants for the year ended December 31, 2024 was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC (Empower) and Empower Annuity Insurance Company of America (Empower Annuity), the trustees of the Plan.

NOTE 4 - FAIR VALUE MEASUREMENT

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; or
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 4 - FAIR VALUE MEASUREMENT (Continued)

Common Collective Trusts - Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value and is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. There are no unfunded commitments at December 31, 2024 and 2023. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

NOTE 5 - FIXED ANNUITY CONTRACT

The Plan offers an investment option in a fixed annuity with Empower Annuity, which is measured at contract value. Contributions are maintained in a general account and the account is credited with earnings on the underlying interest contract. The issuer is contractually obligated to repay the principal a specified interest rate that is guaranteed to the Plan. The Plan held \$1,133,789 and \$1,615,595 in this fixed annuity at December 31, 2024 and 2023, respectively. The annualized crediting rate was approximately 2.70% and 1.80% at December 31, 2024 and 2023, respectively.

NOTE 5 - FIXED ANNUITY CONTRACT (Continued)

Because the fixed annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed interest fund, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer, including the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) divestitures or spin-offs that cause a significant withdrawal from the Plan; (4) corporate relocations; or (5) the failure of the trust to qualify for exemption under ERISA. The Plan administrator does not believe that there are any events that would limit the Plan's ability to transact at contract value with participants are probable.

NOTE 6 - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Empower Retirement Services was the recordkeeper and Empower was trustee of the Plan during the years ended December 31, 2024 and 2023. Therefore, transactions between the Plan and these parties qualify as party-in-interest transactions.

Additionally, certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan for these services.

NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its operations at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 8 - INCOME TAX STATUS

The underlying nonstandardized prototype plan has received an opinion letter from the Internal Revenue Service (IRS) dated November 14, 2022, stating that the form of the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan's operations began after the nonstandardized opinion letter, the Plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken or expected to be taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. The Plan administrator believes that all Plan years are open for examination.
