INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Crossroads Rhode Island 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the Statements of Net Assets Available for Plan Benefits as of December 31, 2024 and 2023, and the related Statement of Changes in Net Assets Available for Plan Benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). 1. Description of Plan

The following description of the Crossroads Rhode Island 401(k) Retirement Plan (the Plan) is intended to provide only general information regarding the Plan. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution profit sharing 401(k) savings plan, covering employees of Crossroads Rhode Island (the Plan Sponsor, Employer or Plan Administrator) who have completed six months of service. Per diem employees and part-time employees who do not work at least 1,000 hours per year are not eligible for participation in the Plan, as defined by Plan provisions. The Plan is a contributory single employer defined contribution plan under Section 401(k) of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may elect to contribute any percentage of their annual pretax compensation, as limited by the IRC and defined in the Plan provisions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may not contribute more than the maximum allowed by the IRC of more than 75% of compensation. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers). The Plan has a 4% automatic enrollment policy, wherein unless an active participant elects otherwise, they are deemed to have elected to make automatic pre-tax contribution of 4% in the Plan. The automatic pre-tax contribution is effective beginning on their first day of eligibility for Employer contributions. Participants who are automatically enrolled in the Plan will have their pre-tax contribution rate increased by 1% each April until their pre-tax contribution rate reaches 75% of their compensation, unless they elect otherwise.

The Employer matches participant contributions equal to the lesser of 50% of each participant's elective deferrals excluding catch-up deferrals, or 3% of a participant's eligible compensation. The Employer may also elect to make discretionary contribution to the Plan for all eligible participants in an amount determined by the Employer. For the year ended December 31, 2024, no discretionary contributions were made to the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution, their allocation of the Employer's matching and discretionary contributions, and their allocation of Plan earnings/losses and administrative expenses. The allocation of earnings/losses and administrative expenses is based on individual participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions and rollover contributions plus actual earnings thereon. Participants are vested in the Employer's matching contributions plus actual earnings and the Employer's discretionary contributions thereon as follows: 50% after 2 years, 75% after 3 years and 100% after 4 years. Each participant shall be 100% vested in their Employer contribution accounts upon death or disability.

Participant Notes Receivable

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 within the last 12-month period or 50% of their vested account balance. Note terms range from one to five years, or if used to acquire a principal residence, they may repay the loan over a reasonable period of time that may be longer than five years. The notes are secured by the balance in the participant's account and bear interest at rates that range from 4.25% to 9.50% as of December 31, 2024, which are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through bi-weekly payroll deductions. Participants can only have one loan outstanding at any given time.

Payment of Benefits and Withdrawals

Upon retirement, death, disability or termination, a participant (or participant's beneficiary in the event of death) may receive the value of his or her vested account in a lump-sum amount, substantially equal installments, or partial withdrawals, provided the minimum withdrawal is \$1,000. If a participant terminates employment for any reason and their vested account does not exceed \$7,000, the Plan Administrator may distribute such amount as a lump-sum payment.

Participants who have attained age 59 ½ are permitted to take in-service withdrawals from all accounts.

Effective January 1, 2024, the Plan adopted a provision of the Setting Every Community Up for Retirement Enhancement Act of 2019 (SECURE) Act 2.0. The adoption increased the limits for involuntary automatic rollovers to an individual retirement plan upon participant termination for account balances from \$5,000 to \$7,000.

Hardship Withdrawals

A hardship withdrawal may be authorized by the Employer in an amount up to 100% of the participant's voluntary contributions and rollover contributions.

Forfeitures

Participants in the Plan who leave employment of the Employer before completing the applicable vesting requirements forfeit the non-vested portion of their accounts. Forfeited non-vested accounts may be used to reduce Employer matching contributions or pay administrative expenses. At December 31, 2024 and 2023 forfeited non-vested accounts totaled \$18,584 and \$15,106, respectively. Forfeitures are generally used to reduce future employer contributions and pay administrative expenses. During the year ending 2024, forfeited non-vested accounts totaling \$11,078 were used to pay administrative expenses or to reduce the employer contribution.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Valuation of Investments and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (see Note 3). The Plan invests in the T. Rowe Price Stable Value Fund, a common collective trust fund. The Plan's interest in the common/collective trust funds is valued at the net asset value (NAV) practical expedient of the underlying investments reported by the issuer of the common collective trust at year-end. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Participant Notes Receivable

Participant notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest and are secured by the balance in the respective participant's account. Related fees are recorded as administrative expenses and are expensed as incurred. Interest income on participant notes receivable is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Contributions

Participant and Employer matching contributions are recorded bi-weekly when the Employer remits the contributions for investment into the Plan.

Payment of Benefits

Benefits are recognized when paid to participants or their designated beneficiaries and include deemed distributions, which consist of participant loan balances in default.

Administrative Expenses

Certain administrative expenses of the Plan are paid by the Employer, unless the Employer directs that the expenses be paid by the Plan. Expenses that are paid by the Employer are excluded from these financial statements. Participant notes receivable set-up and maintenance fees are paid directly by the participants through a reduction in their account and are included in administrative expenses. Investment management fees for certain investments are included as a reduction of investment income (net appreciation or depreciation) from the related investment fund.

Estimates

The preparation of financial statements in accordance with GAAP requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Risks and Uncertainties

The Plan provides for various investment options with various investment objectives. Investment securities, including mutual funds, are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.

The Plan invested in three mutual funds that accounted for approximately 50% of total Plan investments as of December 31, 2024. The Plan invested in two mutual funds that accounted for approximately 66% of total Plan investments as of December 31, 2023.

Financial Instruments with a Concentration of Credit Risk

The Plan's investments are held by a single trustee. The Plan's exposure to credit risk is associated with the outside trustee's non-performance of their fiduciary responsibilities relating to these amounts as specified in the agreements. Benefits provided by the Plan are not insured or guaranteed by the Pension Benefit Guaranty Corporation.

3. Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives highest priority to unadjusted quoted prices in active markets for identical assets (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of fair value hierarchy and inputs to the valuation methodologies are described as follows:

Level 1 inputs are unadjusted quoted prices in active markets for identical assets the Plan has the ability to access.

Level 2 inputs are other than quoted prices in active markets that are observable either directly or indirectly for the asset. Such inputs are derived principally from or corroborated by observable market data for similar assets by correlation or other means, over substantially the full contractual term of the asset, if applicable.

Level 3 inputs are unobservable and significant to the fair value measurement. Such inputs generally rely on the Plan's own assumptions about the assumptions that market participants would use in pricing the asset.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis:

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money Market Fund: The carrying amount of the money market fund is the deposit amount plus accrued interest, as determined according to stated terms.

Common Collective Trust: The Plan invests in the T. Rowe Price Stable Value Fund, an investment vehicle that invests in benefit-responsive investment contracts, fixed income securities and money market funds. Units held are valued at NAV. The NAV, as provided by T. Rowe Price, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Unit values are determined by dividing the fund’s net assets at fair value by its units outstanding at the valuation dates. Participant transactions (purchases and sales) may occur on one day’s notice. There are no unfunded commitments or redemption restrictions for the individual participants within the Plan.

As of December 31, 2024 and 2023, the Plan’s investments in mutual funds and money market fund are reported at level 1 within the fair value hierarchy.

4. Plan Termination

The Plan Administrator expects to continue the Plan indefinitely. However, the Plan Administrator reserves the right to amend the Plan or contributions thereto, at any time and in any manner that it deems advisable, provided that no amendment shall have the effect of diverting Plan assets for purposes other than for the exclusive benefit of the Plan participants and any Plan termination would be subject to the provisions of ERISA. In the event of Plan termination, the participants are entitled to receive all amounts credited to their accounts.

5. Income Tax Status

The Plan adopted the DST Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA plan. DST has obtained an opinion letter on the Plan dated June 30, 2020 stating that the form of the Plan is acceptable under Section 401 of the IRC. Generally, the Plan Administrator and the Plan may rely on the opinion letter received by DST as to the form of the Plan qualifying under the Code. The Plan has been amended since the letter was obtained. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, the Plan Administrator believes that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service (IRS). The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Summary of Financial Data Certified by the Trustee

The following is a summary of financial information and data certified by the trustee, Reliance Trust Company:

Statements of Net Assets Available for Plan Benefits at December 31, 2024 and 2023, excluding contributions receivable, if any;

Investment income and interest from participant notes receivable on the Statement of Changes in Net Assets Available for Plan Benefits for the year ended December 31, 2024; and

Investment information provided in the supplemental schedule, Schedule of Assets (Held at End of Year) at December 31, 2024.

7. Differences from Form 5500

Differences between the Annual Return/Report of Employee Benefit Plan, Form 5500, and these financial statements are a result of different classifications between line items. Total Plan assets are in agreement.

8. Related Party Transactions and Party-in-Interest Transactions

Plan investments are held and managed by T. Rowe Price, the custodian and recordkeeper of the Plan. Therefore, these transactions qualify as party-in-interest transactions. The Plan made direct payments to the recordkeeper for administrative fees totaling \$33,000 for the year ended December 31, 2024. In addition, participant notes receivable qualify as party-in-interest transactions.

9. Employer Contributions Receivable and Subsequent Events

Subsequent to December 31, 2024, the Employer identified operational errors whereby the Employer did not comply with the definition of compensation per the Plan for certain employees during 2024. These errors resulted in missed deferral opportunities. During June 2025, these errors were corrected resulting in the Employer contributing to the Plan \$3,431, which is included in employer contributions receivable as of December 31, 2024 on the accompanying Statements of Net Asset Available for Plan Benefits. The Employer is in the process of determining lost earnings on these missed deferral opportunities.

10. Subsequent Events

Effective January 1, 2025, the Plan adopted a provision of the SECURE Act 2.0 allowing certain eligible participants to make increased catch-up elective deferrals, referred to as “super catch-up” contributions. Under this provision, the maximum catch-up deferral amount for participants between the ages of 60 and 63 increased from \$7,500 to \$11,250.

Management has evaluated subsequent events through October 3, 2025, which is the date these financial statements were available to be issued.
