## INDEPENDENT AUDITORS' REPORT

To the Retirement Committee  
403(b) Thrift Plan of Families Forward

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of 403(b) Thrift Plan of Families Forward (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section –

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **INDEPENDENT AUDITORS' REPORT (CONTINUED)**

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America; this includes the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

### 1. Description of Plan

The following description of the 403(b) Thrift Plan of Families Forward (the “Plan”) provides only general information. Participants should refer to the Plan agreement and the Summary Plan Description for a more complete description of the Plan’s provisions.

#### *General*

The Plan is a defined-contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan was established on January 1, 2009, and amended and restated January 17, 2020, by Families Forward (the “Employer”, “Plan Sponsor”) as a safe-harbor plan. The Plan is intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (“IRC”).

#### *Administration*

The Plan is administered by the Retirement Committee, which consists of senior management of the Plan Sponsor. The Investment Committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance, and reports to the Plan’s Retirement Committee. Mutual of America Life Insurance Company (the “Custodian”) is responsible for the custody and the management of the Plan’s assets.

#### *Participant Contributions*

Participants may make Elective Deferral Contributions up to the maximum dollar amount established by the IRC of pretax annual compensation (\$23,000 in 2024), as defined in the Plan. Participants aged 50 and older may make catch-up contributions to a maximum dollar amount established by the IRC. During 2024, a participant’s catch-up contributions for the plan year may not exceed \$7,500. Participants may elect to designate all or any portion of their Elective Deferral Contributions as Roth Elective Deferrals. Participants may also contribute amounts representing distributions from other tax qualified plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

#### *Employer Contributions*

The Plan Sponsor shall make safe harbor base contributions equal to 3% of eligible compensation and makes discretionary matching contributions of up to 4% of eligible compensation, for a maximum employer contribution of up to 7% of eligible compensation. For the year ended December 31, 2024, the Plan Sponsor made safe harbor base contributions of \$109,490 and discretionary matching contributions of \$97,385. Contributions are subject to certain Internal Revenue Service (“IRS”) limitations.

#### 1. Description of Plan (continued)

##### *Vesting*

Participants are vested immediately in their contributions plus actual earnings thereon. Participants are vested immediately in the Employer's contribution portion of their accounts.

##### *Participant Accounts*

Each participant's account is credited with the participant's contributions and Employer discretionary matching contribution, as well as allocations of the Employer's safe-harbor matching contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### *Investment Options*

Participants may direct participant, Employer safe-harbor and Employer discretionary matching contributions as desired in any of several investment options offered by the Plan. Participants may change their investment options any time throughout the year via the Mutual of America website or by using the automated telephone system offered by the Custodian.

##### *Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of 50% of their vested balance, not to exceed \$50,000. Note terms range from one to five years, except for notes related to the purchase of a primary residence. There is no limit to the number of loans a participant can have outstanding at one time. The loans are secured by the balance in the participant's account with interest rates commensurate with interest rates charged by persons in the business of lending money. There was one loan outstanding as of December 31, 2024. Principal and interest are paid ratably through biweekly payroll deductions. Defaulted participants notes are reclassified as distributions based upon the terms of the Plan Document.

##### *Payment of Benefits*

Upon retirement, death, disability, or other termination of employment, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account or payment in the form of an annuitized series of payments. Participants may withdraw any part of their vested account upon attaining age 59 1/2.

#### 1. Description of Plan (continued)

##### *Payment of Benefits (continued)*

The Plan permits hardship withdrawals in certain circumstances, as defined by the plan document.

##### *Administrative Expenses*

Expenses of the Plan, including legal, audit, administrative, and trustee expenses, are generally paid by the Employer, with the exception of certain administrative expenses totaling \$1,013 during the year ended December 31, 2024, which are paid for by the Plan and charged to participants' accounts.

##### *Forfeitures*

Forfeitures are used to reduce the Employer's contribution or to pay Plan expenses. There were no forfeitures during the year ended December 31, 2024.

#### 2. Significant Accounting Policies

##### *Basis of Accounting*

The financial statements of the Plan have been prepared on the accrual basis of accounting which is in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"). Employee and employer contributions were recognized in the period that contributions are due.

##### *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

##### *Investment Valuation and Income Recognition*

Investments in pooled separate accounts ("PSAs") are valued on a net asset value ("NAV") per share basis. The PSAs are credited with earnings on the underlying investments and charged for Plan benefits paid and deductions for investment expenses and annual management fees. Redemptions may occur on a daily basis.

##### *Investment Valuation and Income Recognition (continued)*

The Plan invests in a guaranteed interest account, which is a group annuity contract valued at contract value. Contract value reflects the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan and is the relevant measure for the portion of assets attributable to the fully benefit-responsive guaranteed interest account.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation of investments consists of both the realized and unrealized gains and losses.

The Plan's Investment Committee determines the Plan's valuation policies using information provided by the investment advisors, custodians and insurance company. See Note 4 for discussion of fair value measurements.

##### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

##### *Payment of Benefits*

Benefits are recorded upon approval of the participant's distribution request.

#### 3. Information Certified by the Custodian

The Plan's management has elected the method of compliance permitted by 29 CFR 2520.103-5(c) of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Custodian of the Plan has certified to the completeness and accuracy of all investments and notes receivable from participants reflected on the accompanying statements of net assets available for plan benefits as of December 31, 2024 and 2023, the supplemental schedule, Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024; and the related investment activity reflected in the statement of changes in net assets available for plan benefits for the year ended December 31, 2024.

#### 4. Investments

##### *Fair Value Measurements*

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under U.S. GAAP are described as follows:

- Level 1- Inputs are quoted prices in active markets for identical investments that the investment manager has the ability to access at the measurement date.
- Level 2- Inputs are inputs other than quoted prices included within Level 1 that are observable for the investment, either directly or indirectly.
- Level 3- Inputs are unobservable inputs for the investment.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Investments in PSAs are valued using the NAV as of the reporting date. The NAV is used as a practical expedient to estimate fair value. PSAs are valued based on the underlying investments (i.e., common stock, mutual funds, and short-term securities) in the separate account as reported by Mutual of America Life Insurance Company based on recent transaction prices. While the majority of the underlying asset values are based on quoted prices, NAV of the PSAs are not publicly quoted. The PSAs held by the Plan provide for daily redemptions by the Plan at reported NAV with no advance notice requirement. Investments that are measured at fair value using the NAV per share (or its equivalent) practical expedient have not been categorized in the fair value hierarchy.

The Plan is party to a fully benefit-responsive guaranteed interest account with Mutual of America Life Insurance Company. The guaranteed interest account issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Because the guaranteed interest account is fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits. The guaranteed interest account is presented on the accompanying statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by the issuer, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

##### *Fair Value Measurements (continued)*

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Employer or other Employer events that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants. In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

Although Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the value of certain financial instruments could result in a different value measurement at the reporting date. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

#### 5. Party-In-Interest Transactions

Certain Plan investments are managed by the Custodian, and therefore, these transactions qualify as exempt party-in-interest transactions permitted by the United States Department of Labor (DOL) Rules and Regulations. Fees paid by the Plan to the Custodian amounted to \$1,013 for the year ended December 31, 2024. The Plan issues notes receivables to participants, which are secured by the balances in the participants' accounts.

#### 6. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, further contributions to the Plan will cease and participants will remain 100% vested in their accounts.

#### **7. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statement of net assets available for benefits.

U.S. GAAP requires the financial statements to present the fair value of investments. The guaranteed interest account has been presented at contract value, which approximates fair value, as reported to the Plan by Mutual of America. This determination is based on Mutual of America's credit rating and yield during 2024 being comparable to similar alternative investments and the interest rate which resets annually being comparable to a ten-year treasury bond. In subsequent periods, if market conditions change, such as the insurance company credit rating or interest rate environment, the difference between contract value and fair value could become significant causing the financial statements to become materially misstated.

#### **8. Tax Status**

The Plan is intended to comply with the applicable requirements of Section 403(b) of the IRC, as amended. A tax determination letter program is not yet available for IRC Section 403(b) plans through the IRS. The Plan Sponsor believes the Plan is currently designed and operated in compliance with applicable requirements of the IRC and, as such, is exempt from federal income taxes. Therefore, no provision for income tax has been included in the Plan's financial statements. The Plan's management will make any changes deemed necessary to ensure the Plan maintains its tax-exempt status.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability, asset, or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **9. Commitments and Contingencies**

As required by ERISA Section 2510.3-102, the Plan Sponsor is required to segregate participant contributions from its general assets and remit them to the Plan as soon as administratively feasible. For the year ended December 31, 2023, the Plan Sponsor transferred employee contributions of \$120,131 after what was considered to be a reasonable period of time. For the year ended December 31, 2021, the Plan Sponsor transferred employee contributions of \$29,161 after what was considered to be a reasonable period of time. During the year ended December 31, 2024, management fully corrected these late remittances by submitting lost earnings of \$310 to the Plan outside of the DOL's Voluntary Fiduciary Correction Program.

#### **10. Subsequent Events**

In preparing these financial statements, the Plan management has evaluated events and transactions for potential recognition or disclosure through October 1, 2025, the date the financial statements were available to be issued.
