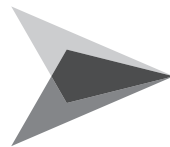

Accordingly, the objective of an ERISA Section 103(a)(3)(c) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedules Required by ERISA

The supplemental schedule of assets (held at end of year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Emphasis of Matter – Prior Period Adjustment

As discussed in Note 9 to the financial statements, the Plan restated its previously issued financial statements for the year ended December 31, 2023 to correct a misstatement related to contributions. Accordingly, the statement of net assets available for benefits as of December 31, 2023 have been restated to correct the error. Our opinion is not modified with respect to this matter.

Note 1 - Description of Plan

The following description of CommIT Enterprises, Inc. 401(k) & Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

General – The Plan is a defined contribution plan available to eligible employees of CommIT Enterprises, Inc., (the Plan Sponsor). Participation in the Plan is allowed immediately after obtaining age 21 with entry dates on the first day of the plan year quarter. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan Sponsor is responsible for the administration of the Plan and entrusted the maintenance of records and the day-to-day administration to John Hancock Life Insurance Company and John Hancock Trust Company (TPA) who processed transactions for the years ended December 31, 2024 and 2023.

Contributions – Participating employees may defer 401(k) contributions up to 100% of their pre-tax and after-tax annual compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan as listed in the Schedule of Assets (Held at End of Year). Participants can change the investment options previously elected at any time.

The Plan Sponsor makes safe-harbor matching contributions equal to 100% of the participant's contributions up to 3% of the participants compensation plus 50% of the participant's contributions in excess of 3% up to 5% of the participant's compensations. The Plan Sponsor may also make qualified nonelective contributions; for 2024, the Plan Sponsor did not make any such contributions.

Contributions are subject to Internal Revenue Service (IRS) limitations. Receivables from the Plan Sponsor for contributions are unsecured.

Participant Accounts – Each participant's account is credited with the participant's contributions, the Plan Sponsor's safe-harbor matching and qualified nonelective contributions and Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are immediately vested in their voluntary contributions, plus actual earnings on these contributions. Vesting in the Plan Sponsor’s safe harbor matching contribution and discretionary qualified nonelective contributions portion of their accounts plus related earnings thereon is based on years of vesting service in which the participants complete 1,000 hours of services, as follows:

Payment of Benefits – If the participant’s vested benefit in the Plan does not exceed \$1,000 at the time of termination of employment, the participant’s benefit may be distributed in a single lump-sum payment as soon as administratively feasible. If the participant’s vested benefit in the Plan exceeds \$1,000 but is less than \$5,000, the participant’s benefit must be distributed in a single lump sum payment or rolled over into another individual retirement account. If the participant’s vested benefit in the Plan exceeds \$5,000 at the time of termination of employment, the participant may elect to either maintain their account in the Plan, receive a lump sum distribution or rollover their account balance into another individual retirement account. Participants may also withdraw their vested account balances at any time on or after age 59 ½, or upon retirement, death or disability.

Loans to Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the participant’s vested account balance. The loans are secured by the participant’s vested account balance and bear interest at 9.5%. Principal and interest are paid ratably through payroll deductions over a maximum period of fifteen years for all loan funds.

Forfeitures – Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeitures may first be used to pay administrative expenses and then to reduce future Plan Sponsor contributions. At year end December 31, 2024, forfeitures generated totaled \$-0-.

Note 2 - Significant Accounting Policies

Basis of Accounting – The financial statements of the Plan are prepared on the accrual method of accounting.

Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures and changes therein. Accordingly, actual results could differ from those estimates.

Note 2 - Significant Accounting Policies (Continued)

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Payment of Benefits – Benefits are recorded when paid.

Administration Expenses – Certain expenses of the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses paid by the Plan Sponsor are excluded from these financial statements. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Date of Management Review – Management has evaluated subsequent events through September 15, 2025, the date that the financial statements were available to be issued.

Note 3 - Certified Information (Unaudited)

John Hancock Trust Company holds the Plan's investment assets and executes transactions therein. Financial information relating to those investments is included in the accompanying financial statements based on information supplied to the plan administrator and certified as complete and accurate by John Hancock Trust Company. That information, which has not been audited by independent auditors, is summarized below:

Note 4 - Investments and Fair Value Measurements

The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below.

Basis of Fair Value Measurement

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets the Plan can access.

Level 2 Inputs to the methodology include

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds – Valued at quoted market prices which represent the fair value of shares held by the Plan at year-end.

Stable Value Funds – Stable value funds are composed of investment contracts that are valued at net asset value. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur immediately.

Classification within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following tables set forth by level, within the fair value hierarchy, the Plan's investments as of December 31:

Note 5 - Related Party Transaction and Party in Interest Transactions

Plan investments are in accounts of John Hancock Trust Company and therefore, these transactions qualify as party-in-interest transactions. In addition, contributions from participants are considered to be party-in-interest transactions. Plan Sponsor contributions are considered to be both party-in-interest and related party transactions.

Note 6 - Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their Plan Sponsor contributions.

Note 7 - Income Tax Status

The Plan adopted a volume submitter plan which had received an advisory letter dated November 30, 2020 from the IRS which stated the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the advisory letter, the plan administrator and the Plan's tax counsel believe the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe the Plan is qualified, and the related trust is tax-exempt.

Note 8 - Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9 - Prior Period Adjustment

During the year ended December 31, 2024, the Plan identified an error in the previously issued financial statements for the year ended December 31, 2023. The error related to an understatement of employer contributions, which resulted in an understatement of net assets available for benefits. As a result, the Plan has restated the statement of net assets available for benefits as of December 31, 2023 to correct this error. The correction increased net assets available for benefits by \$5,495 as of December 31, 2023 from the amount previously reported.

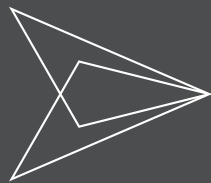
