## INDEPENDENT AUDITORS' REPORT

To the Trustees of  
403(b) Thrift Plan for Employees of  
The Joyce Theater Foundation, Inc.

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of 403(b) Thrift Plan for Employees of The Joyce Theater Foundation, Inc., an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of 403(b) Thrift Plan for Employees of The Joyce Theater Foundation, Inc.'s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of 403(b) Thrift Plan for Employees of The Joyce Theater Foundation, Inc. and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about 403(b) Thrift Plan for Employees of The Joyce Theater Foundation, Inc.'s ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**Note 1 - Description of Plan**

This description of the 403(b) Thrift Plan for Employees of The Joyce Theater Foundation, Inc. (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**a - General and Eligibility**

The Plan is a defined contribution plan covering all employees of The Joyce Theater Foundation, Inc. (the "Employer" or "Sponsor"), except for those:

- (1) who are non-resident aliens with no U.S. source income,
- (2) who are classified or treated as independent contractors, or
- (3) who are eligible to make salary reduction contributions to another plan of the Employer described in Sections 401(k) or 403(b) of the Internal Revenue Code (the "Code), or a governmental eligible deferred compensation plan described in Section 457(b) of the Code.

Employees covered under a collective bargaining agreement are not eligible to receive employer matching or base contributions under this Plan.

There is no minimum age requirement to make salary reduction contributions or to receive employer contributions under the Plan. Employees must complete at least one year of service to receive employer contributions. Participants will be credited with a year of service at the end of their first twelve months of employment provided they complete at least 1,000 hours of service within that twelve-month period.

**b - Contributions**

The Plan may accept the following types of contributions:

**Participant Contributions**

Participant contributions, including catch-up contributions for participants who are age 50 or greater, are made to the Plan by means of salary deferral. The participant is entitled to defer up to 100% of his or her compensation or a fixed amount up to the maximum allowable under the Code. Participants may also contribute amounts representing distributions from other qualified plans, other than rollovers from a governmental 457(b) plan, or rollovers of after-tax contributions.

**Employer Contributions**

The Employer makes a base contribution on behalf of participants equal to 7% of the participant's compensation, as defined by the Plan. The employer base contribution will be made whether or not a participant is making salary reduction contributions to the Plan. The employer will also make matching contributions on behalf of participants equal to 50% of the participant's salary reduction amount that does not exceed 2% of compensation received during the year.

c - Participant Accounts

Participants direct the investment of their contributions into various investment options offered by the Plan. Each participant's account is credited with the participant's contributions and their proportionate share of the Plan's earnings and charged with an allocation of any administrative expenses paid by the Plan.

d - Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. A participant is vested in the Employer's contributions according to the following schedule:

e - Payment of Benefits

Withdrawals of salary reduction contributions and vested Employer contributions, including earnings thereon, may be withdrawn upon reaching age 59½, termination of employment, disability, death, or Plan termination. Participants may request a hardship withdrawal of their salary reduction contributions and vested employer contributions under certain conditions specified in the Plan. Benefits may be paid as lump sum or in installments. Any amounts withdrawn due to hardship must be distributed in a single sum. The Plan makes mandatory distributions following termination of employment to any participant whose vested balance is \$1,000 or less.

f - Participant Loans

Participants may obtain loans issued directly from funds owned by the custodian of the Plan and not directly from a participant's account. Borrowings are collateralized by the participant's account, limited to one-half of a participant's vested account balance, and may not exceed \$50,000 per participant. The loan term may not exceed five years, except for loans used to acquire a participant's principal residence, for which the term may be up to fifteen years. Such loans totaled \$11,415 and \$26,301 as of December 31, 2024 and 2023, respectively.

**Note 2 - Summary of Accounting Policies**

The following accounting policies have been used consistently in the preparation of the Plan's financial statements:

a - Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

b - Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains on investments bought and sold as well as held during the year. Interest income is recorded on the accrual basis.

c - Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management of the Plan to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

d - Payment of Benefits

Benefits are recorded when paid.

e - Plan Expenses

Substantially all administrative expenses of the Plan are paid by the Sponsor.

f - Forfeited Accounts

Forfeitures are used to reduce future Employer contributions.

g - Subsequent Events

The Plan has evaluated subsequent events through October 7, 2025, the date that the financial statements are considered available to be issued.

**Note 3 - Certified Financial Information**

The Plan administrator elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, Mutual of America Life Insurance Company, the custodian of the Plan, has certified as to the completeness and accuracy of the Plan's investments totaling \$10,447,512 and \$8,873,300 as of December 31, 2024 and 2023, respectively, and the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

**Note 4 - Fair Value Measurements**

FASB ASC 820, "Fair Value Measurements and Disclosures," provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FAS8 ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets;
  - quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from and corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The Plan's investments consist of shares of registered investment companies whose fair values are based on quoted market prices that are available on an active market and are priced daily.

The Plan's pooled separate accounts consist solely of investments in mutual funds registered with the Securities and Exchange Commission and are carried at the net asset value at which the mutual fund shares are actively traded.

The Plan's policy is to recognize the transfer of financial instruments from one fair value level to another at the beginning of the reporting period. For the year ended December 31, 2024, there were no transfers in or out of levels 1, 2 or 3.

**Note 5 - Party-in-Interest Transactions**

Certain Plan investments are funds managed by Mutual of America Life Insurance Company, which serves as custodian for the Plan. Therefore, these transactions qualify as party-in-interest transactions. Investment expenses for these funds are offset by net investment income.

Participants in the Plan are permitted to borrow funds from their vested balance as described in Note 1f. These transactions also qualify as party-in-interest transactions.

**Note 6 - Tax Status**

The Trust established under the Plan to hold the Plan's assets is qualified pursuant to the appropriate sections of the Code, and accordingly, the Trust's net investment income is exempt from income taxes. The Plan has adopted a prototype plan through the custodian that is qualified by the Internal Revenue Service and a determination letter separately filed is not mandatory by Plan sponsor. The Sponsor believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

**Note 7 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with these investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 8 - Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.
