Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

Note 1: Description of Plan

The following description of the Briess Industries, Inc. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Briess Industries, Inc. (the "Company") who have one month of service and are age 18 or older. Effective January 1, 2024, employees are required to have two months of service. Temporary and seasonal employees must complete 1,000 hours of service or effective January 1, 2024, complete three consecutive years of service where the employee completes at least 500 hours to become eligible to participate in the plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Officers of the Company are responsible for oversight of the Plan, including determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

Eligibility

Upon meeting eligibility requirements for elective deferrals, employees also become eligible to receive plan safe harbor matching contributions. Newly eligible employees enter the Plan quarterly on January 1, April 1, July 1, or October 1.

To be eligible for plan discretionary Company contributions, participants must have worked 1,000 hours in the initial year of eligibility. Participants must also be employed by the Company on the last day of the plan year, unless they terminated their employment by reason of death, or normal retirement upon attaining age 65.

Contributions

Each year, participants may contribute eligible compensation, as defined by the plan document, to the Plan up to the maximum allowable limits of the Internal Revenue Service ("IRS") on a pre-tax or Roth basis. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan. Effective April 1, 2023, the Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan or elect an alternate deferral rate. Automatically enrolled participants have their pre-tax deferral rate set at 5% of eligible compensation and their contributions invested in a designated fund until changed by the participant.

Notes to Financial Statements

Note 1: Description of Plan (Continued)

Contributions (Continued)

The Company makes a safe harbor matching contribution equal to 100% of the first 3% and 50% of the next 2%, not to exceed 4% of eligible compensation, that a participant contributes to the Plan. Rollover contributions are not matched. The Company also may make a discretionary nonelective contribution and a discretionary matching contribution to the Plan. For the year ended December 31, 2024, the Company made a safe harbor matching contribution of \$753,012 and a discretionary nonelective contribution of \$920,147 to the Plan. The Company did not make a discretionary matching contribution during 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company matching contributions, and allocations of (a) the Company's discretionary nonelective contribution and (b) plan earnings (losses). Participant accounts are reduced by withdrawals and charged with an allocation of administrative and investment expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their voluntary and Company safe harbor matching contributions plus actual earnings thereon. Vesting in the Company's discretionary nonelective contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. Participants vest at a rate of 20% per year beginning with the second year of service. Participants become fully vested after six years of service. In addition, participants become fully vested upon death or disability.

Notes Receivable From Participants

Participants may borrow from their fund accounts a maximum of one loan with a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms shall not exceed five years, unless the note proceeds are used to purchase a primary residence, in which case the note terms shall be determined in accordance with the plan document. The notes are secured by the balance in the participant's account and bear interest at a rate of prime plus 1.0%. The interest rates on existing notes range between 4.25% and 9.50% at December 31, 2024. Principal and interest are paid ratably through payroll deductions.

Note 1: Description of Plan (Continued)

Payment of Benefits

On termination of service due to death, a participant's beneficiary may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution, partial withdrawal, or installments if the account balance is greater than \$5,000. If the participant's vested account balance does not exceed \$5,000, but is greater than \$1,000, the plan administrator will pay an involuntary cashout distribution as a direct rollover to an individual retirement plan, unless the participant elects a lump sum payment in a timely manner. Vested balances less than \$1,000 can be distributed only in a single lump sum payment. In addition, hardship distributions out of the participant's pretax elective deferral account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2. Participants may withdraw their rollover contributions at any time.

Forfeitures

Plan forfeitures arise as a result of participants terminating service with the Company before becoming 100% vested in the Company's discretionary nonelective contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$4,130 and \$42,140, respectively. These accounts will be used to pay plan administrative expenses or reduce future Company contributions in accordance with the plan document. During the year ended December 31, 2024, the Company used forfeitures of \$46,340 to reduce plan administrative expenses and Company contributions.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion on fair value measurements.

Investment Valuation and Income Recognition (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative and Investment Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment management fees paid directly by the Plan are allocated proportionately to the plan participants based on their respective account balances and are reflected as investment expenses and included in net investment income. Fees related to distributions and the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Certain investment-related expenses are included in net appreciation in fair value of investments, since they are paid through revenue sharing rather than direct payment. All other expenses paid by the Plan are allocated proportionately to plan participants based on their respective account balances and are included in administrative expenses.

Subsequent Events

Subsequent events have been evaluated through September 2, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would be used only if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trust funds: Valued at the NAV provided by the administrator of the fund using NAV as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The NAV's unit price is quoted on a private market that is not active; however, the unit price is based on underlying investments that are traded on an active market. Participant transactions (purchases and sales) may occur daily. There are no restrictions as to the redemption of these investments or unfunded commitments as of December 31, 2024 and 2023.

Included in the common/collective trust balance as of December 31, 2024 and 2023, are the International Equity Fund Fee Class R1 and Small Cap Growth Fund II Fee Class R1. These funds do not file individual 5500s and therefore, the investment strategy of each fund is disclosed below.

The International Equity Fund Fee Class R1 seeks capital appreciation by investing in the Fidelity Institutional AM International Core CIT, for which Great Gray Trust Company, LLC, is trustee and FIAM LLC is subadvisor. The underlying fund has a broad geographic equity mandate to invest in an equity portfolio of mostly non-US companies. It is managed on the belief that earnings drive stock prices and high-quality growth companies are consistently undervalued by the market due to the common misconception that all companies' returns on invested capital, return on investment, or earnings, must "revert to the mean" over time.

The Small Cap Growth Fund II Fee Class R1 seeks to deliver long-term growth of capital and to outperform the Russell 2000 Growth Index over full market cycles, which indirectly invests in the AB US Small Cap Growth Collective Trust Series W for which AB Trust Company, LLC is the trustee and Alliance Bernstein LP is investment advisor. The underlying fund's strategy employs a highly disciplined stock selection process that marries in-depth fundamental research with quantitative analysis to identify high-quality, rapidly growing smaller capitalization companies with earnings growth potential that appear likely to outpace market expectations.

Note 4: Information Prepared and Certified by the Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments, and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Trust Company, LLC ("Empower"), the trustee of the Plan.

Note 5: Party-in-Interest Transactions

Empower Advisory Group, LLC ("Empower Advisory"), is the investment manager, as defined by the plan document and, therefore, transactions with Empower Advisory qualify as party-in-interest transactions. Fees paid by the Plan to Empower Advisory for investment expenses totaled \$22,970 during 2024.

Global Retirement Partners, LLC d/b/a M3 Financial ("Global") is the investment advisor for the Plan, and therefore, transactions with Global qualify as party-in-interest transactions. Fees paid by the Plan to Global for investment advisory services during 2024 totaled \$39,503.

Peak Retirement Group d/b/a TG Benefit ("Peak") is the contract administrator for the Plan, and therefore, transactions with Peak qualify as party-in-interest transactions. Fees paid by the Plan to Peak Retirement Group for contract administrator services during 2024 totaled \$15,424.

Empower Annuity Insurance Company ("Empower Annuity") is the record keeper, as defined by the plan document, and, therefore, transactions with Empower Annuity qualify as party-in-interest transactions. Fees paid by the Plan to Empower Annuity for administrative expenses totaled \$25,280.

Notes receivable from participants qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 6: Plan Termination

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in the Company's discretionary nonelective contributions.

Note 7: Tax Status

The Company adopted a non-standardized pre-approved plan document with an IRS notification letter dated June 30, 2020, which states the non-standardized pre-approved plan document, as then designed, was in compliance with the applicable sections of the Internal Revenue Code ("IRC"). Although the plan document has been amended since receipt of the notification letter, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
