We have performed audits of the accompanying financial statements of Diversified Aero Services, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). Note 1—Description of the Plan

The following description of the Diversified Aero Services, LLC 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan documents for a more complete description of the Plan’s provisions.

General – The Plan, established in January 2013, is a defined contribution 401(k) Plan covering all eligible employees of Diversified Aero Services, LLC (the “Employer”, the “Company”, or “Plan Sponsor”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Administration – The Plan is administered by the Company. The Plan’s assets are maintained and administered by Fidelity Management Trust Company (“qualified institution”). The qualified institution holds the Plan’s assets and also performs certain administrative services including the maintenance of certain participant records. The Plan administrator is responsible for the oversight of the Plan and determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Eligibility – Employees become eligible to participate in the Plan at the age of 21 and after completing three months of employment. Employees included in a collective bargaining unit covered by a collective bargaining agreement with the Employer are not eligible to join the Plan.

Participants Contributions – Subject to certain limitations, under Internal Revenue Code (“IRC”) Section 401(k), participants may contribute up to 90% of their eligible compensation pre-tax or after-tax contributions to the Plan’s Elective or Roth investment option as defined in the Plan document, subject to 2024 annual limits of \$23,000, and an additional \$7,500 for catch-up contribution for participants who are age 50 or older. Certain groups of eligible employees, as defined in the Plan document, are subject to automatic enrollment contributions of 6%. Participants may also rollover amounts representing distributions from other qualified plans.

Employer Contributions – The Plan included Employer safe harbor matching contributions whereby the Employer will contribute an amount equal to 100% of salary deferrals of the first 3% of eligible compensation and 50% of salary deferrals on the next 2% of eligible compensation. The Plan document allows the Employer to make discretionary-matching contributions to eligible participants, as defined by the Plan document. The Company did not elect to make a discretionary-matching contribution for the year ended December 31, 2024.

Participant Accounts – Each participant’s account is credited with the participant’s contribution including any rollover amounts from qualified plans, as well as allocations of: (a) the Plan Sponsor’s discretionary-matching contribution, (b) the Plan Sponsor’s safe harbor matching contribution, (c) Plan earnings (losses), and (d) forfeitures, and charged with the participant’s distributions and allocations of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment Options – Participants may direct contributions to selected investments as made available and determined by the Plan administrator. Participants may change their investment options at any time throughout the year via direct phone and internet access to the third party administrator.

Note 1—Description of the Plan (continued)

Vesting – Participants are fully vested in their elective contributions, as well as any rollover contributions, and Employer safe harbor matching contributions, plus or minus any earnings or losses thereon. Vesting in the Employer’s discretionary-matching contributions of their accounts plus actual earnings therein is based on the following schedule:

5 years or more	100%

Forfeitures – Forfeitures are those amounts of Employer discretionary-matching contributions in which a participant is not fully vested at the time of termination. Forfeitures will be used to reduce future Employer contributions. During the year ended December 31, 2024, no amounts were used to offset Plan Sponsor contributions. As of December 31, 2024 the Plan had a de minimis amount of forfeitures.

Notes Receivable from Participants – Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant’s account and bear interest that is similar to rates charged by persons in the business of lending money for loans which would be made under similar circumstances and must be based on appropriate regional factors unless the Plan is administered on a national basis. The interest rates on all participant loans outstanding at December 31, 2024 range from 5.25% to 10.50%. Loans must be fully repaid through payroll deductions within five years unless the loan is used for the purchase of the primary residence which may be repaid within a period of no more than 10 years from the date of the loan. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits – On termination of services due to either voluntary or involuntary resignation, death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of participant’s vested interest in his or her account. If the participant’s vested account balance is less than \$5,000 at the termination date, then that balance shall be distributed to the participant in a single lump-sum payment without the participant’s consent.

Hardship Distribution – A participant who is experiencing a financial hardship, as defined in the Plan document, may request a withdrawal of all or any portion of such participant’s salary deferral contributions, excluding earnings and rollovers, if any.

Plan Termination – Although it has not expressed any intent to do so, the Company reserves the right at any time to amend, modify, or terminate the Plan without the consent of any participant or beneficiary, subject to the provisions of ERISA. In the event of such termination, the Plan provides that the participants shall become 100% vested in their accounts.

Note 2—Summary of significant accounting policies

Basis of Accounting – The financial statements of the Plan are based on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Use of Estimates – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect certain reported amounts of net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Such estimates include those regarding fair value of investments. Actual results could differ from those estimates.

Payment of Benefits – Benefits are recorded when paid.

Investment Valuation and Income Recognition – Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

The Plan presents in the statement of changes in net assets available for benefits the net appreciation in the fair value of its investments which consists of the realized gains or losses and the unrealized appreciation (depreciation) on those investments. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan documents.

Administrative Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Note 3—Information prepared and certified by the qualified institution (unaudited)

The Plan has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the qualified institution, has certified to the completeness and accuracy of the following data included in the accompanying financial statements and supplemental schedule:

- Investments, at fair value, and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, interest and dividend income, and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules (schedule of assets and schedule of delinquent contributions).

U.S. GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value.

Three levels of inputs may be used to measure fair value:

Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following are descriptions of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy:

Money Market Fund – The investment is a public investment vehicle valued using the net asset value (“NAV”) provided by the administrator of the fund. The underlying assets are generally comprised of short-term securities representing high quality, liquid debt, and monetary assets. The qualified institution establishes the market and quotes the price, on a daily basis, that is available to market participants, which is a market approach to valuation. The money market account is classified within Level 1 of the valuation hierarchy.

Mutual Funds – These investments are public investment vehicles valued using NAV provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is quoted price in an active market and is classified within Level 1 of the valuation hierarchy.

The Plan believes its valuation methods are appropriate and consistent with those of other market participants; however, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5—Party-in-interest transactions

Certain Plan investments and the related transactions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, were in investments managed by the qualified institution; therefore, these investments and transactions qualify as party-in-interest transactions.

During the year ended December 31, 2024, the Plan paid approximately \$28,000 to Fidelity Investments Institutional, for investment advisory and administrative services for the year ended December 31, 2024.

Notes receivable from participants also qualify as party-in-interest transactions.

Note 6—Risks and uncertainties

The Plan provides for various investment fund options. Investments are exposed to various risks such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Note 7—Income tax status

The Plan Sponsor adopted a volume submitter 401(k) profit-sharing plan. The Internal Revenue Service (“IRS”) has determined by a letter dated June 30, 2020, that the prototype is designed in accordance with applicable sections of the IRC. Although the Plan has not obtained an individual determination letter and has been amended since receiving opinion letter, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC and has no income subject to unrelated business income tax.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8—Delinquent participant contributions

During the year ended December 31, 2024, the Company’s failure to remit certain employee contributions to the Plan in a timely manner resulted in a temporary use of participant funds by the Company, which constitutes a prohibited transaction under ERISA. As such, these transactions represented prohibited transactions between the Company and the Plan as identified in the Schedule of Delinquent Participant Contributions – Form 5500, Schedule H, Part IV, Line 4a. The Company is calculating the lost earnings to finalize correction on those remittances.

Note 9—Subsequent events

The Plan has evaluated subsequent events through October 6, 2025, which is the date the financial statements were available to be issued.
