## INDEPENDENT AUDITORS' REPORT

To The Plan Administrator  
Simpson Senior Services, Inc. 403(b)(7) Retirement Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements**

We have performed an audit of the accompanying financial statements of Simpson Senior Services, Inc. 403(b)(7) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements ("2024 financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from Empower Trust Company, LLC (formerly Great West Trust Company, LLC) and Empower Life and Annuity Insurance Company (formerly Great-West Life and Annuity Insurance Company) as of December 31, 2024, and for the year then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion on the 2024 Financial Statements**

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the 2024 Financial Statements section:

- the amounts and disclosures in the 2024 financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the 2024 financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion on the 2024 Financial Statements**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the 2024 Financial Statements section of our report. ## **Responsibilities of Management for the 2024 Financial Statements**

NOTES TO FINANCIAL STATEMENTS  
DECEMBER 31, 2024

Note 1 - Description of Plan

The following description of Simpson Senior Services, Inc. 403(b)(7) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan, which was established under Internal Revenue Code Section 403(b) effective January 1, 1985, amended effective January 1, 2022, and restated January 1, 2024, is a defined contribution plan covering all employees of Simpson Senior Services (the "Company") and certain related entities as listed below, with the following exceptions: (1) nonresident aliens are excluded from all contributions; (2) employees covered by a collective bargaining agreement ("Union employees") are excluded from employer matching contributions; (3) nonunion employees are excluded from profit sharing contributions. Union employees become eligible for profit sharing contributions after they reach age 21 and complete one year of service. Nonunion employees are eligible to receive discretionary employer matching contributions upon commencement of employment. The Plan requires all participants to be employed as of year-end to be eligible to receive employer contributions.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"), and covers all eligible employees of the following related employers, which are each Participating Employers in the Plan through December 31, 2024:

- Simpson Senior Services
- Simpson House Inc.
- Simpson Meadows
- Jenners Pond Inc.

The Plan administrator is responsible for oversight of the Plan. Management determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's administrator.

Contributions

Each year, participants may contribute up to the maximum percentage allowable by law of eligible annual compensation, as defined in the Plan, provided that such contributions do not exceed the limitations under the Internal Revenue Code (the "IRC") for 2024 of \$23,000, plus a maximum of \$7,500 in catch-up contributions for participants who have attained age 50 before the end of the Plan year. Contributions may be made as a pre-tax deferral or after-tax (Roth) deferral. A participant may stop contributing to the Plan at any time. Highly compensated employees are subject to additional limits set forth in the IRC. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may also contribute amounts representing rollover distributions from other qualified defined benefit or defined contribution plans.

Contributions (cont'd.)

The Company may, at its discretion, elect to make a qualified matching contribution or profit sharing contribution to the Plan for eligible employees. For the year ended December 31, 2024, the Plan made a discretionary matching contribution of 100% of deferrals on up to 3% of eligible compensation for eligible nonunion employees. Discretionary matching contributions amounted to \$357,400 in 2024.

Participant Accounts

Participant accounts are credited with the participant's contributions, the Company's profit sharing or discretionary matching contributions as applicable, and the participant's proportionate share of the Plan's earnings. Participant accounts are charged with the participant's withdrawal, the participant's proportionate share of the Plan's losses, and an allocation of the Plan's service charge. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings or losses thereon. Vesting in the Company's profit sharing contributions and related interest and investment gains and losses is as follows:

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account. The loans are secured by the balance in the participant's account. The loan interest rate, determined by the Plan administrator, is set at 1.5% above the prime rate, as defined by the Plan. Principal and interest are paid ratably through payroll deductions over a period not to exceed five years, unless the funds are used to acquire a principal residence, in which case the repayment period is no longer than 25 years.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in their account. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the plan administrator will authorize the benefit payment without the participant's consent. If a terminated participant's vested balance is less than or equal to \$5,000, the amount may be automatically distributed in the form of lump sum cash payment. The Plan allows for in-service distributions if a participant reaches age 59½. In addition, the Plan allows for hardship distributions if certain criteria are met.

Forfeitures

Forfeitures of employer profit sharing contributions will be used to reduce the employer contributions for the succeeding Plan year. Forfeited nonvested accounts totaled \$20,141 and \$52,039 at December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, \$24,513 from forfeited nonvested accounts was applied against the employer contribution made for the 2024 Plan year.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value except for the fully benefit-responsive investment contract, which is stated at contract value (see Note 4). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for a discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Notes receivable from participants are reclassified as distributions once the participant is no longer employed by the Sponsor. Interest rates on loans outstanding at December 31, 2024 ranged from 4.25% to 10%.

Excess Contributions Payable

The Plan is required to return contributions received during the Plan year in excess of IRC limits. Excess deferrals are recorded as a liability in the year the contribution is received, with a corresponding reduction to contributions. At December 31, 2024 and 2023, there were amounts due to participants totaling \$2,084 and \$6,809, respectively.

Payments of Benefits

Benefit payments to participants are recorded when paid.

Deemed Distributions

For participant loans in which the participant has a distributable event, such as employment termination, death, or disability, the loan is considered a deemed distribution. The participant loan is removed from the statement of net assets available for benefits and a distribution is recorded. For active participants who have not incurred a distributable event, but have delinquent loans, the participant loan remains outstanding until a distributable event occurs.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment-related expenses are included in net appreciation or depreciation in fair value of investments. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

Note 3 - Information Certified By Empower and ELAIC

The following information, including investments and notes receivable from participants at December 31, 2024 and 2023, and investment income and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC (“Empower”) (formerly Great-West Trust Company, LLC), the custodian of the Plan, and Empower Life and Annuity Insurance Company (“ELAIC”) (formerly Great-West Life and Annuity Insurance Company), an insurance company which maintains certain Plan assets under a group annuity contract.

Note 4 - Guaranteed Investment Contract

As part of the Guaranteed Portfolio Fund, the Plan entered into a fully benefit-responsive guaranteed investment contract with ELAIC. At December 31, 2024 and 2023, the contract value of the fully benefit-responsive contract was \$173,589 and \$284,375, respectively. ELAIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula established by the contract issuer and is reviewed annually for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Thus, the guaranteed investment contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by ELAIC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events may permit ELAIC to terminate the investment contract. Such events include the following: (a) the Plan is amended or is operated in a manner which is unacceptable to ELAIC; (b) the Plan fails to comply with any provision contained in the contract; (c) the Plan fails to qualify or becomes disqualified under the IRC; (d) the total amount of contributions received by ELAIC in the preceding 12 months is less than \$25,000; and (e) the Plan fails to remit participant contributions within 30 days after the deduction was made. Upon termination by ELAIC, a surrender value adjustment may apply.

Note 5 - Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") Topic 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables set forth by level, within the fair value hierarchy, the Plan’s assets at fair value at December 31, 2024 and 2023. Classification within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. For the year ended December 31, 2024, there were no significant transfers between Levels 1 and 2 and no transfers in or out of Level 3.

Note 6 - Related Party Transactions and Party-In-Interest Transactions

Certain Plan investments are shares of mutual funds, which are managed by Empower, the custodian, and a fully benefit-responsive guaranteed investment contract managed by ELAIC. Therefore, the transactions related to these investments qualify as party-in-interest transactions.

The Recordkeeper of the Plan for the year ended December 31, 2024 is Empower Retirement Advisory Service. Therefore, fees paid to this entity qualify as party-in-interest transactions. Such fees amounted to \$48,458 for the year ended December 31, 2024.

Notes receivable from participants also qualify as party-in-interest transactions.

Note 7 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 8 - Tax Status

The Plan has been designed to qualify under Section 403(b) of the IRC. The terms of the Plan have been prepared to conform to the sample language provided by the Internal Revenue Service in Revenue Procedure 2007-71 and the draft Listing of Required Modifications issued December 17, 2006. The Plan is required to operate in conformity with the IRC to maintain the tax-exempt status for Plan participants under Section 403(b). The Plan administrator and Sponsor believe that the Plan is designed and being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that at December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset, or require disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

Note 9 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 10 - Delinquent Participant Contributions

As of December 31, 2019, there were uncorrected delinquent participant contributions of \$48,711 related to the Plan year ended December 31, 2019. This Sponsor corrected these delinquent contributions during the year ended December 31, 2024 through the Voluntary Fiduciary Correction Program ("VFCP").

Note 11 - Subsequent Events

The Plan administrator has evaluated all events or transactions that occurred after December 31, 2024 through October 7, 2025, which is the date that the financial statements were available to be issued. During this period, there were no material subsequent events requiring disclosure.
