### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Dermatology Associates, P.C. Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### Note 1 – Description of Plan

---

The following description of the Dermatology Associates, P.C. Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan covering all eligible employees of Dermatology Associates, P.C. (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### *Eligibility*

Effective May 1, 2024, employees, with the exception of leased, union, and non-resident alien employees, who have one month of service and are aged twenty-one or older, are eligible to make elective deferral contributions. Employees are eligible to receive non-elective and safe harbor matching contributions on the first day of the Plan year or the first day of the seventh month of the Plan year following the date they complete one year of eligible service and attain age twenty-one. Prior to May 1, 2024, employees, with the exception of leased, union, and non-resident alien employees, were eligible, for all contribution types, when they were aged twenty-one or older, and had completed one year of service. The Plan was adopted on November 1, 1977, and was last restated on January 1, 2021, and last amended on May 1, 2024.

#### *Contributions*

Each year, participants may contribute up to 100% of pretax or after-tax annual compensation, not to exceed annual limits established by the *Internal Revenue Code (IRC)*, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants are subject to 3% automatic deferral. Participants have the ability to opt out of this provision. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company matches 100% of the first 3% and 50% over 3% up to 5% of eligible compensation that a participant contributes to the Plan. The Company may also make discretionary profit-sharing contributions as determined annually by the Company's board of directors. Company contributions are subject to certain limitations as prescribed annually by the Internal Revenue Service (IRS).

Safe harbor matching contributions were made by the Company in 2024 totaling \$341,170.

No discretionary profit-sharing contributions were made by the Company in 2024.

#### *Participants' Accounts*

Each participant's account is credited with the participant's contribution, the Company's matching contribution, the Company's discretionary profit-sharing contribution, if any, and an allocation of Plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### *Vesting*

Participants are immediately vested in their contributions plus actual earnings thereon. Participants are also immediately vested in the Company matching contribution plus actual earnings thereon since the Plan is a Safe Harbor Plan. Vesting in the Company's discretionary profit-sharing contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service as follows:

2 years to 3 years	20 %
3 years to 4 years	40 %
4 years to 5 years	60 %
5 years to 6 years	80 %
6 years or more	100 %

### *Payment of Benefits*

On termination of service due to disability or retirement, a participant or a participant's beneficiary, in the case of a participant's death, may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. If the participant's balance is under \$5,000 upon termination, the participants vested interest in his or her account may be automatically distributed. Participants age 59 1/2 or older may receive in-service withdrawals from their deferral and employer funded accounts. Hardship withdrawals are permitted pursuant to IRS regulations.

### *Forfeitures*

Forfeitures may be used to reduce Company contributions, restore forfeitures, or to pay Plan expenses.

Forfeited nonvested accounts totaled \$-0- in both 2024 and 2023. For 2024, no forfeitures were used for Plan expenses.

### *Administration*

The Plan's assets are in the custody of The Trust Company of Tennessee. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

### *Administration Costs*

Although not required to do so, the Plan Sponsor paid substantially all administrative expenses of the Plan except for single sum benefit payment fees for a distribution other than at death, permanent disability or retirement, and qualified domestic relations order fees.

### Note 2 – Summary of Accounting Policies

---

#### *Basis of Accounting*

The financial statements of the Plan are prepared using the accrual method of accounting.

#### *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### *Investment Valuation and Income Recognition*

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

#### *Payment of Benefits*

Benefits are recorded when paid.

### Note 5 – Related Party Transactions and Parties in Interest

---

The Plan invests in assets that are managed by the Trustee of the Plan. The Trust Company of Tennessee acts as the Trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions.

The Trust Company of Tennessee provides certain administrative services to the Plan pursuant to a Services Agreement between the Company and The Trust Company of Tennessee. The Trust Company of Tennessee receives revenue from mutual fund and collective trust fund service providers for services The Trust Company of Tennessee provides to the funds. This revenue is used to offset certain amounts owed to The Trust Company of Tennessee for its administrative services to the Plan.

If the revenue received by The Trust Company of Tennessee from such mutual fund or collective trust fund service providers exceeds the amount owed under the Services Agreement, The Trust Company of Tennessee remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2024, there were no excess amounts. The Plan or Plan Sponsor may make a payment to The Trust Company of Tennessee for administrative expenses not covered by revenue sharing.

---

### Note 6 – Tax Status

---

The pre-approved document obtained its latest determination letter on June 30, 2020, in which the IRS stated that the Plan is designed in accordance with applicable sections of the *IRC*. Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the *IRC*.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The federal annual returns are subject to examination by the Internal Revenue Service, generally for three years after they are filed.
