Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of **WOONSOCKET URGENT CARE PC 401(k) PROFIT SHARING PLAN AND TRUST**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Note A – Description of Plan:

The following description of the Woonsocket Urgent Care 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan established effective January 1, 2015 and amended and restated effective January 1, 2023. The Plan covers all employees, excluding union employees, non-resident aliens, and acquired employees, of Woonsocket Urgent Care, P.C. (the Company) upon hire. The Plan is intended to be a qualified retirement plan under the Internal Revenue Code of 1986 ("IRC") as amended and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan allows traditional 401(k) deferral (pre-tax) and after-tax (Roth) contributions

Participant contributions:

Eligible employees generally include all employees of the Company, excluding union employees, non-resident aliens, and acquired employees of the Company. There are no age or service requirements for eligibility and entry into the Plan will be monthly, the first day of each month of the Plan year.

Subject to limitations issued by the Internal Revenue Service (the "IRS"), participants may elect to contribute to the Plan from 1% to 90% of pre-tax eligible earnings. Participants also may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan was amended effective January 1, 2023 to include an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 1% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Automatically enrolled participants will have their deferral rate increase by 1% on January 1st until their deferral rate reaches 6%.

Employer contributions:

The Company may make discretionary matching and profit-sharing contributions equal to a percentage, determined annually by the Company. The Company did not elect to make any matching or profit-sharing contributions for the year ended December 31, 2024. Contributions are subject to certain statutory limitations. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

Participant accounts:

Each participant's account is credited with the participant's contributions, Company matching contributions, allocations of the Company's discretionary contributions and an allocation of the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note A – Description of Plan (continued):

Investment options:

Plan Participants may invest in one or more of the various investment funds offered by the Plan. Each of the Plan's funds represents a mix of various investments. The investment mix chosen by the participant will apply to employee and Company contributions. Rollover contributions are invested at the election of the participant. The Plan's investment advisor determined the appropriateness of the Plan's investment offerings, monitors investment performance and reports to Plan management.

Vesting:

Participants are immediately vested in their deferral and rollover contributions, including the earnings on those amounts. Vesting in the Company's contribution portion of their accounts is based on years of continuous service as follows:

In the event of death, disability, attainment of the Plan's normal retirement age, or Plan termination, a Participant becomes 100% vested in their total account balance.

Notes receivable from participants:

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 47.50% of their vested balance in the pre-tax Core Funds, or 95% if the Roth elective deferral balance is excluded, of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. Loan terms range up to 4.5 years, except for loans to purchase a primary residence, which may be offered over an extended term. Generally, principal and interest are paid ratably through bi-weekly payroll deductions.

As of December 31, 2024, and 2023, there were outstanding notes receivable from participants of \$22,949 and \$22,080, respectively.

Payment of benefits:

Upon termination of service due to death, disability, retirement, or any other reason, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or installment payments as provided in the plan document. For termination of service due to death, total distribution of the participant's account must be made to the beneficiary within 5 years of death as a lump sum distribution. If a terminated participant's vested balance is less than or equal to \$5,000, the amount may be automatically distributed in the form of a lump sum distribution. In addition, the Plan allows for hardship distributions if certain criteria are met.

Note A – Description of Plan (continued):

Forfeitures:

Forfeitures of terminated participants' nonvested accounts are retained in the Plan. These accounts will be used to reduce future employer contributions or to pay plan administrative expenses. During 2024, no amounts were applied to plan activities from forfeited nonvested accounts. As of December 31, 2024 and 2023, there were no forfeited nonvested accounts.

Note B – Recently issued accounting pronouncements

Recent accounting pronouncements issued by the FASB did not or are not believed by management to have a material impact on the Plan's present or future financial statements.

Note C – Summary of significant accounting policies:

Financial statement presentation:

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets, additions to net assets, deductions from net assets, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates and assumptions.

Plan expenses:

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

Financial instruments with a concentration of credit risk:

The Plan's investments are held by third party custodians. The Plan's exposure to credit risk is associated with the outside entity's non-performance of their fiduciary responsibilities relating to these amounts as specified in the agreements. The Plan also provides for various investment options which are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and those changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits. Benefits provided by the Plan are not insured or guaranteed by the Pension Benefit Guaranty Corporation.

Users of these financial statements should be aware that the financial markets' volatility may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments at December 31, 2024, may not necessarily be indicative of amounts that could be realized in a current market exchange.

Note C – Summary of significant accounting policies (continued):

Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. If a participant does not make note repayments and the Plan administrator considers the participant note to be in default, the note balance is reduced and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Notes receivable from participants represent participant loans and are valued at their unpaid principal balance plus any accrued but unpaid interest, which approximates fair value. Related fees are recorded as administrative expenses and are expensed as incurred. Management has concluded that no allowance for current expected credit losses was necessary at December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Investment valuation and income recognition:

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's administrator determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company, as applicable. See Note E for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payments of benefits:

Benefits paid to participants are charged to expense during the period paid.

Subsequent events:

Plan management has evaluated subsequent events through October 6, 2025, the date that the accompanying financial statements were available to be issued.

Note D – Investments certified by plan trustees:

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, American Trust Custody (formerly known as Mid-Atlantic Trust Company), the Custodian of the Plan, has certified to the completeness and accuracy of all investments reported in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) (excluding notes receivable from participants) as of December 31, 2024, and the related investment activity, other than interest on notes receivable from participants, reported in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

Note E – Fair value measurements:

Generally accepted accounting principles establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in inactive markets;

Inputs other than quoted prices that are observable for the asset or liability;

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurements. Valuation techniques used need to maximize the use of observable inputs (that is, Level 1 and Level 2 inputs that do not require significant adjustment) and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value:

Money Market Fund: Valued at the quoted NAV of shares held by the Plan at year end.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

There have been no changes in the methodology used at December 31, 2024 and 2023.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note F – Party-in-interest transactions:

Paychex Retirement Services is the recordkeeper for the Plan and American Trust Company (formerly Mid-Atlantic Trust Company) is the custodian of the Plan. Certain investment and administrative expenses were paid to American Trust Company. Fees incurred by the Plan for administrative services provided by the custodian, recordkeepers and investment management companies totaled \$11,058 for the year ended December 31, 2024.

Certain employees and officers of the Company, who are also participants in the Plan, perform administrative services for the Plan at no cost to the Plan. Also, the Plan issues loans to participants, which are secured by balances in the participants' accounts. These transactions qualify as party-in-interest transactions and are exempted from the prohibited transaction rules of ERISA.

Cavanagh CPA's & Associates, LLC, the auditor of the Plan's financial statements, is also a party-in-interest as defined by ERISA.

Note G – Plan tax status:

The Plan adopted a non-standardized pre-approved profit sharing plan offered by Paychex, Inc. which received an IRS Advisory Letter dated August 31, 2020, stating that the Plan is designed in accordance with the applicable sections of the Internal Revenue Code (IRC).

Although the Plan has been amended since receiving the most recent determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore believes the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

The Plan files the Annual Return/Report of Employee Benefit Plan (Form 5500) in the U.S. federal jurisdiction. The Plan is no longer subject to U.S. federal tax examinations for years before 2021.

Note H – Plan termination:

Subsequent to December 31, 2024, the Plan Sponsor adopted a resolution to terminate the Woonsocket Urgent Care PC 401(k) Plan effective September 15, 2025. Upon termination, participants became fully vested in their account balances. The Plan Sponsor is in the process of obtaining all required regulatory approvals and distributing plan assets to participants and beneficiaries in accordance with applicable laws and regulations.

The financial statements as of and for the year ended December 31, 2024 have been prepared on the going concern basis of accounting and do not include any adjustments that might result from the Plan's termination.
