Notes to Financial Statements

Note 1: Description of Plan

The following description of the Golden Triangle Construction, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Golden Triangle Construction, LLC (the "Company") who are age 18 or older and have completed two consecutive months of service. Eligible employees are permitted to enter the Plan on the first day of the month coinciding with or following the date on which the employee has met the Plan's eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

The Company is the plan administrator and is responsible for oversight of the Plan. Effective March 1, 2024, the plan changed custodian and recordkeeper from Minnesota Life Insurance Company and Securian Financial Group, Inc. to Fidelity Management Trust Company ("Fidelity") on March 1, 2024. Plan management works with Fidelity to determine the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions

Each year, participants may contribute up to the amount allowed by law of annual compensation, as defined in the Plan, on a pretax or after-tax basis. Deferral contributions and after-tax Roth contributions shall not exceed certain limits set forth by the Internal Revenue Service ("IRS"). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Plan also includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

The Plan is a safe harbor plan and requires the Company to match 100% of the participant's salary deferral that does not exceed 3% of compensation plus 50% of the participant's salary deferrals between 3% and 5% of the participant's compensation. The Company may make additional discretionary matching contributions and nonelective contributions. Participants must be employed as of the plan year end to receive the nonelective contributions. During the year ended December 31, 2024, the Company made safe harbor matching contributions of \$310,173, and additional discretionary matching contributions and nonelective contributions of \$-0- to the Plan.

Note 1: Description of Plan (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's safe harbor matching contributions, discretionary Company matching contributions and nonelective contributions, and allocations of plan earnings and losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions, rollover contributions, and Company safe harbor contributions, plus actual earnings thereon. Vesting in the Company's discretionary matching contribution and nonelective contribution portion of their accounts, plus actual earnings thereon, is based on years of continuous service. Participants become fully vested after three years of service according to the following schedule:

Investment Options

Participants direct the investment of their contributions into various options offered by the Plan. The Plan currently offers investments in mutual funds as investment options for participants. Participants may change their investment options at any time.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 reduced by the excess of the highest outstanding balance in the participant's account during the prior twelve month period or 50% of their vested account balance. The term of the loan is a maximum of five years unless the loan is for the purchase of a primary residence for which the maximum term is 10 years. The notes are secured by the balance in the participant's account and bear interest at a rate comparable to the rates being charged by lending institutions in the same geographic locale as the Company. A note will carry the same rate of interest throughout its term. Interest rates on existing notes range from 6.5% to 9.5%. Principal and interest are paid ratably through withdrawals from the participant's personal bank account.

Note 1: Description of Plan (Continued)

Payment of Benefits

Upon retirement, death, permanent disability, or other termination of service, a participant has the option to receive the vested portion of his or her account balance as a lump-sum or partial withdrawals as described in the plan agreement. The Plan also allows for in-service distributions upon attaining age 59 1/2. Distribution of benefits upon termination becomes automatic if the participants account balance is less than \$7,000.

Hardship withdrawals are available if the participant meets certain criteria.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,557 and \$3,887, respectively. These accounts may be used to reduce future Company contributions or to pay administrative expenses of the Plan in accordance with the plan document. During the year ended December 31, 2024, the Company used \$3,920 to pay administrative expenses and reduce Company contributions.

SECURE 2.0

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. There are provisions which are currently part of the plan design, including the provisions designed to assist with participant savings, automatic enrollment and automatic increases, and the required minimum distribution provisions required in 2023 which have already been adopted by the Plan. All provisions of SECURE 2.0 will be evaluated and implemented in accordance with future regulations and guidance and the Plan will be amended as needed.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the Plan's fully benefit-responsive investment contract ("FBRIC")(for the year ended December 31, 2023). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and the custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

FBRICs are reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of benefit payments and notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are allocated proportionately to plan participants based on their respective account balances and are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through September 30, 2025, which is the date the financial statements were available to be issued.

Note 3: Information Prepared and Certified by the Custodians (Unaudited)

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Minnesota Life Insurance Company, the custodian of the Plan through February 29, 2024, and Fidelity, the custodian of the plan thereafter, have certified that the following unaudited information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments and notes receivable from participants, as reported in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, interest and dividend income, and interest income from notes receivable from participants as shown in the Statement of Changes in Net Assets Available for Benefits.
- All investment information included in the Supplemental Schedule – Form 5500 Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024.

Accordingly, at the request of the plan administrator, this information has not been audited by the Plan's independent auditors, except for comparing such information to the related information included in the financial statements and supplemental schedule.

Note 4: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used as of December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Accounts: Investments include pooled separate accounts and mutual funds held in pooled separate accounts. Fair value of pooled separate accounts are based on quoted net asset values (NAV) of underlying investments held by the pooled separate accounts. The underlying mutual funds held in the pooled separate accounts are open-ended mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily NAV and transact at that price. Investments in pooled separate accounts are stated at the corresponding unit value of the pooled separate account. The estimated fair value of pooled separate accounts are based on the fair value of the underlying assets owned by the pooled separate account and are generally based on observable inputs. Assets within the pooled separate accounts include: fixed maturity securities, equity securities, and cash and cash equivalents.

Note 5: Fully Benefit-Responsive Investment Contracts (FBRICs)

The Plan invested in a FBRIC with Minnesota Life Insurance Company through February 29, 2024 in the form of a Fixed Account Investment option provided through a group annuity contract that invests in traditional investment contracts. Minnesota Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Minnesota Life Insurance Company is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The fixed account is carried at contract value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 1.50%. Such interest rates are reviewed on a quarterly basis for resetting.

Note 5: Fully Benefit-Responsive Investment Contracts (FBRICs) (Continued)

Certain events limit the Plan's ability to transact at contract value with Minnesota Life Insurance Company, including plan termination and other events as specified in the group annuity contract. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants or the issuer are probable of occurring. The group annuity contract does not permit Minnesota Life Insurance Company to terminate the agreement prior to the scheduled maturity date.

Note 6: Related-Party Transactions and Party-In-Interest Transactions

Certain plan investments are managed by Fidelity and formerly Minnesota Life Insurance Company (through February 29, 2024). Fidelity is the custodian and record-keeper of the Plan as of March 1, 2024 and Minnesota Life Insurance Company was the custodian and Securian Financial Group, Inc. was the record-keeper of the Plan through February 29, 2024. Additionally, Fidelity provides investment advisory services and administrative services to the Plan. Transactions with these companies qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net change in fair value of investments, as they are paid through revenue sharing rather than a direct payment. Fees incurred and paid by the Plan for administrative services were \$7,078 for the year ended December 31, 2024.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 7: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions and earnings thereon.

Note 8: Tax Status

The Plan utilizes a volume submitter plan, which obtained a favorable determination letter from the IRS dated June 30, 2020, stating that the volume submitter plan is qualified under the applicable sections of the Internal Revenue Code ("IRC"). The plan administrator believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires plan management to evaluate the tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosures in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in place.

Note 9: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
