NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following description of the St. Luke Residential Health Care Facility, Inc. Retirement Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description or Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time non-union employees of St. Luke Residential Health Care Facility, Inc. (the Facility) who have completed one year of service and are twenty-one years of age or older. Other related entities covered by the Plan include Bishop's Commons at St. Luke, St. Francis Commons, Inc., St. Luke Services Corporation and former employees of Michaud Residential Health Service, Inc. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Facility is the sponsor of the Plan. Capital Bank and Trust Company is the custodian of the Plan's assets, and American Funds Retirement Plan Services is the recordkeeper.

Contributions

The Plan is a non-contributory plan. Each year the Facility makes discretionary contributions into the Plan on behalf of eligible participants. In 2023, the Facility contributed an amount equal to 3.5% of the eligible compensation for all participants meeting the eligibility requirements.

Participant Accounts

The plan administrator maintains separate accounts in the name of each participant. Each participant's account is credited with an allocation of (a) the Facility's contribution, (b) Plan earnings and (losses), and (c) forfeitures of terminated participants' non-vested accounts. Investments are participant directed. As such, allocations of Plan earnings and (losses) are based upon performance of the investment funds chosen by the individual participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Vesting in the Facility's contributions plus actual earnings and (losses) thereon is based on years of continuous service. A participant is 0% vested until three years of credited service when they become 100% vested.

Forfeited Accounts

Forfeitures are allocated to all eligible participants on a pro rata basis that is based on each participant's eligible compensation for the Plan year. Forfeitures may first be used to pay any administrative expenses. At December 31, 2024 and 2023, forfeited non-vested accounts allocated to participants totaled \$0 and \$620, respectively. Total forfeitures used were \$10,807 and \$10,327 in 2024 and 2023, respectively.

Payment of Benefits

On termination of service due to death, disability or retirement, or for other reasons, a participant may elect to receive a lump-sum amount equal to the amount of the participant's vested interest in his or her account. A participant of at least 59 ½ years of age may also be eligible to receive in-service distributions subject to other requirements.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared in conformity with accounting principles generally accepted in the United States of America (GAAP).

Allowance for Credit Losses

The Plan records a receivable for the employer contributions that are remitted to the Plan subsequent to the Plan's year end. The Plan recognizes an expected allowance for credit losses that is updated to reflect any changes in credit risk since the receivable was initially recorded. The estimated allowance for credit losses is based on historical, current, and expected future conditions. No significant improvements or deteriorations are expected in the future economic conditions; therefore management has determined that no allowance for credit losses is necessary for the year ended December 31, 2024 and 2023.

Investments and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are reflected on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. All investments are participant directed.

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, currency and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Fair Value Measurement - Definition and Hierarchy

GAAP framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under GAAP are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets and liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Fair Value Measurement - Definition and Hierarchy (Continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value.

Money market funds: Valued at amortized cost, which approximates fair value. (primarily valued using level 2 inputs)

Mutual funds: Valued at the net asset value of shares held at year-end based on quoted prices in active markets. (primarily valued using level 1 inputs)

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no changes in the valuation methodologies used during 2024 or 2023.

Administrative Expenses

The Facility pays certain administrative expenses of the Plan. Additionally, the participants are assessed an administrative charge that is determined by several factors, including the investment mix and total value of the participant's account. In 2024 and 2023, administrative expenses charged to the Plan were \$2,110 and \$1,850, respectively.

Payment of Benefits

Benefits paid to participants are recorded upon distribution.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make significant estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Reclassifications

Certain reclassifications have been made to the financial statements as of and for the year ended December 31, 2023. These reclassifications are for comparative purposes only and have no effect on the net assets available for benefits as originally reported.

5. PLAN TERMINATION

The Facility has the right under the Plan to discontinue its contribution at any time and to terminate the Plan subject to the provisions of ERISA. Although the Facility has not expressed any intent to do so, if the Plan were to terminate, participants would become 100% vested in their account balances.

6. TAX STATUS

The Plan is operating under the Non-Standardized Defined Contribution Pre-Approved Plan prepared by Security Administrators, Inc. The Pre-Approved Plan obtained its latest opinion letter on June 30, 2020, which the Internal Revenue Service stated that the Plan as then designated, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the opinion letter. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.
