Note 1 - Description of the Plan

The following description of the Kline Galland Center Tax Sheltered Annuity Plan (the Plan) provides general information only. Participants should refer to the plan document for complete information regarding the Plan's definitions, benefits, eligibility, and other matters.

General - The Plan is a defined contribution plan that was established for the benefit of employees of the Kline Galland Center and participating affiliates (collectively referred to as "the Sponsor"). The Plan is intended to be a plan that meets requirements under Section 403(b) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions - All employees may elect to defer a portion of their compensation to the Plan as pre-tax or Roth contributions. Participants who attain age 50 before the end of a calendar year may make additional deferrals (catch-up contributions) to the Plan. Participants may rollover contributions into the Plan from other eligible retirement plans or individual retirement accounts.

The Sponsor may make discretionary employer contributions for employees who have attained age 21 and completed two years of service. An employee earns a year of service for each 12-month period beginning on their date of hire and any 12-month period beginning with the anniversary of their date of hire during which they work at least 1,000 hours. Once employees become eligible for discretionary employer contributions, they will receive an allocation of the contribution regardless of how many hours they work in subsequent years. The formula used to calculate discretionary employer contributions is based on participants' eligible compensation, years of service, and date of hire. For the 2024 plan year, eligible participants received employer contributions ranging from 3% to 10% of eligible compensation.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts - Participant contributions to the Plan are voluntary. Each participant's account is credited with any contributions made to the account as well as increases or decreases in the market value of investments. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their account into various investment options offered by the Plan.

Vesting - Participants are immediately vested in all contributions to the Plan plus actual earnings thereon.

Benefit Payments - Upon termination of service, retirement, death, or disability, a participant or beneficiary may elect to receive a distribution equal to the value of the participant's vested interest in his or her account. The distribution may be in the form of a lump-sum payment, annuity, or installment payments. Participants may elect to receive a distribution of all or any portion of their account balance prior to termination of employment (in-service withdrawals) upon attainment of age 59½. The Plan also allows for hardship withdrawals in accordance with provisions specified in the Plan document.

Note 1 - Continued

Plan Loans - The Plan provides for loans which are issued directly from funds owned by Lincoln National Life Insurance Company (Lincoln). Accordingly, loans are not reported on the statements of net assets available for benefits and related interest income is not reported on the statement of changes in net assets available for benefits. Adequate security is required and a portion of the participant's account is held as collateral to cover outstanding loans in case of default. There was \$841,162 and \$842,288 held as collateral for outstanding loans, of which approximately \$154,000 and \$170,500 represented defaulted loans, at December 31, 2024 and 2023, respectively. The maximum amount that a participant can borrow is equal to the lesser of 50% of their vested account balance or \$50,000, reduced by the highest outstanding balance within the last twelve-month period, with a minimum loan of \$1,000. All loans must be repaid within five years, except those used to purchase a primary residence which require repayment within twenty years.

Note 2 - Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation or depreciation in the fair value of investments includes the Plan's net gains and losses on investments bought and sold as well as held during the year.

Benefits Paid to Participants - Benefits paid to participants are recognized when they are paid.

Administrative Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. Certain investment related expenses are charged directly against the fund's investment performance and, therefore, are not separately disclosed in the accompanying financial statements.

Subsequent Events - The Plan's management has evaluated subsequent events through October 2, 2025, the date on which the Plan's financial statements were available to be issued.

Note 3 - Fair Value Measurements

GAAP provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 - Unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than the quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Unobservable inputs that are significant to the fair value measurement.

An asset or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Guaranteed Interest Account - Valued at contract value which is the aggregation of contributions, plus interest, less any withdrawals. Contract value approximates a discounted cash flow value (fair value) calculated using an appropriate risk-adjusted market discount rate which correlates closely with the Plan's guaranteed interest account's historical crediting rates. Fair value is determined annually for financial statement reporting purposes since participants normally transact at contract value. In determining the reasonableness of the methodology, the Plan's management evaluates a variety of factors including review of historical returns, market conditions, and overall credit ratings. Certain unobservable inputs are determined through review of contract terms (e.g., historical crediting rates) while others are substantiated utilizing available market data (e.g., Treasury yields).

Variable Annuity Accounts - Fair values of the Plan's variable annuity accounts are based on their net asset value (NAV) per unit as determined by Lincoln. The fair values of participation units are based on the market value of securities underlying the variable annuity accounts. NAV per unit is used as a practical expedient for measuring fair value. Participant transactions (purchases and sales) may occur daily. Participants eligible to receive benefit payments may withdraw the value of their variable annuity accounts, in whole or in part, at any time without penalty. There are no participant redemption restrictions for these investments.

Note 4 - Investment Contracts With Insurance Company

Over the course of the Plan's existence, the Plan entered into three separate investment contracts with Lincoln. Participants may choose to invest in the investment contracts through the guaranteed interest account. Lincoln maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Lincoln is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Transfers or withdrawals from the guaranteed account may be subject to a market value adjustment or surrender charge based on the number of years the contract is held. In addition, Lincoln has placed some restrictions on the ability of plan participants to transfer/transact some or all of their balance in the guaranteed account to other investment options available to them. Therefore, the Plan's guaranteed account is not considered fully benefit-responsive. The effective annual guaranteed yield on the contracts will never be less than 3.5% or 4.5% depending on the type of contract.

Note 5 - Certified Information

Certain information in the accompanying financial statements and supplementary information related to investments held as of December 31, 2024 and 2023, and investment income or loss for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Lincoln National Life Insurance Company, a qualified institution. The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplementary information.

Note 6 - Tax Status

The Sponsor adopted a Lincoln Financial Group pre-approved 403(b) plan document. Lincoln Financial Group received an approval letter from the IRS dated March 31, 2017, which states that the volume submitter plan document satisfies the applicable provisions of Section 403(b) of the IRC. The Plan itself has not received a determination letter from the IRS; however, the Plan's management believes that the Plan is currently designed in a manner that would not jeopardize the tax benefits associated with these arrangements. The Plan is subject to audits by the IRS; however, there are currently no audits for any tax periods in progress.

Note 7 - Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 8 - Party-in-Interest Transactions

The Plan's investments include fixed and variable annuity contracts issued by Lincoln. Lincoln provides recordkeeping services to the Plan. Therefore, transactions with these investments and payments from the Plan to Lincoln qualify as party-in-interest transactions.

Note 9 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Note 10 - Concentrations

Financial instruments that potentially subject the Plan to concentrations of credit risk consist principally of the guaranteed interest account issued by Lincoln. These investments represent approximately 63% and 69% of total Plan investments at December 31, 2024 and 2023, respectively. The Plan's management seeks to limit its credit exposure by working with high-credit quality institutions.

Note 11 - Reconciliation to Form 5500

The value of the Plan's variable annuity accounts are classified as registered investment companies on Schedule H of Form 5500, which reflect the underlying investments for those accounts.

Amounts held as collateral in the guaranteed interest account for outstanding plan loans are classified as participant loans on the Schedule H of Form 5500.

Note 12 - Delinquent Contributions

The Sponsor determined there were instances during 2024 in which participant deferral contributions were not deposited by the Company as plan assets within the time limitation stipulated under the Department of Labor's (DOL) regulations. Delinquent contributions are prohibited party-in-interest transactions under ERISA and also represent related party transactions between the Plan and the plan sponsor. In total, \$206,163 of deferral contributions were identified as delinquent. During 2025, the Sponsor restored lost earnings associated with the delinquent deposits.
