Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### ***Other Matter – Supplemental Schedule Required by ERISA***

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment

information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- the certified investment information in the supplemental schedule agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### 1. Description of Plan

The following description of the Scully Signal Company 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

#### *General*

The Plan is a defined contribution profit sharing plan covering all employees, as defined in the Plan, of Scully Signal Company (the “Company” or “Plan Sponsor”) who have attained the age of 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

#### *Contributions*

Each year, participants may elect to contribute up to 100% of their eligible compensation, as defined by the Plan, subject to Internal Revenue Code (“IRC”) limitations. The Plan will automatically enroll eligible participants with a contribution rate equal to 2% of their eligible compensation for the plan year, unless the participant elects otherwise or elects not to participate in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan Sponsor may, at its discretion, make matching contributions to the Plan in any plan year at a percentage determined by the Board of Directors of the Plan Sponsor. Participants who are employed at the end of the plan year are eligible for the Company’s discretionary matching and profit sharing contributions. For the year ended December 31, 2024, the Company elected to make a matching contribution of \$0.50 for each \$1.00 contributed up to 6% of each participant’s salary. For the year ended December 31, 2024, the Company made matching contributions of \$169,273, net of forfeitures applied of \$5,306. Contributions are subject to certain limitations.

The Plan Sponsor, at the option of its Board of Directors, may make additional profit sharing contributions. During the year ended December 31, 2024, there were no additional profit sharing contributions to the Plan.

#### *Participant Accounts*

Each participant’s account is credited with the participant’s contribution, and the Company’s matching contributions, as well as allocations of the Company’s profit sharing contribution and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

### ***Vesting***

Participants are vested immediately in their contributions, plus actual earnings thereon. Vesting in the Company's matching and discretionary profit-sharing contributions, plus actual earnings thereon, is based on years of service as follows:

<i>Years of Service</i>	<i>Percent Vested</i>
Less than two years	0%
Two years but less than three years	20%
Three years but less than four years	40%
Four years but less than five years	60%
Five years but less than six years	80%
Six or more years	100%

### ***Notes Receivable from Participants***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 3.25% to 8.50%, which is commensurate with local prevailing rates, as determined by the plan administrator. Loans must be repaid within a five-year period. The term of a loan to be used to acquire a participant's principal residence may extend over a reasonable amount of time that may exceed five years. Principal and interest are paid ratably through payroll deductions.

### ***Payment of Benefits***

Benefits are paid upon a participant's retirement, termination, death, disability, or upon defined hardship situations. The participant may receive his or her benefits in a lump-sum distribution. Upon attainment of age 60, or any time thereafter, each participant shall be entitled to withdraw all or a portion of their vested account balance.

### ***Forfeited Accounts***

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeited amounts are used first to reduce the Plan Sponsor's matching or profit sharing contributions to the Plan and then used to pay any plan administrative expenses. At December 31, 2024 and 2023, the balance in the forfeitures account totaled \$5,306 and \$5,764, respectively. Subsequent to the year ended December 31, 2024, the Plan used \$5,306 of forfeitures to reduce the 2024 Plan Sponsor's matching contributions.

## **2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The financial statements of the Plan are prepared under the accrual basis of accounting.

### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (“GAAP”) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan’s valuation policies utilizing information provided by the investment advisors and insurance carrier. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan’s gains and losses on investments bought and sold, as well as held during the year.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

### ***Contributions***

Participant contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant’s compensation. Discretionary employer matching and profit-sharing contributions are recorded in the relevant period in accordance with the terms in the plan document.

### ***Payment of Benefits***

Benefits are recorded when paid.

### ***Expenses***

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are netted with net appreciation (depreciation) in fair value of investments. Reasonable investment expenses for investment funds are allocated among participants in proportion of their investment fund balances.

### *Subsequent Events*

The Plan evaluated all events and transactions that occurred after December 31, 2024, through October 7, 2025, the date these financial statements were available to be issued.

### **3. Certified Investments**

The plan administrator has elected the method of compliance permitted by ERISA Section 103(a)(3)(c) 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Life Insurance Company (U.S.A) ("John Hancock"), the custodian for the Plan and a qualified institution, has certified as to the completeness and accuracy of all the investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the supplemental schedule, Form 5500 - Schedule H, Part IV, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reflected on the statement of changes in net assets available for benefits for the year ended December 31, 2024. The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

### **4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1:* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

*Level 2:* Inputs other than quoted prices included in Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3:* Inputs that are unobservable inputs for the asset or liability.

The asset or liability's fair value measurement level, within the fair value hierarchy, is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

### *Pooled Separate Accounts*

Pooled separate accounts are valued at the daily closing price. The pooled separate accounts held by the Plan publish their daily net asset value ("NAV") and transact at this published price, similar to a mutual fund. The published NAV is readily determinable fair value and the basis for current transactions and, therefore, are classified as level 1 assets in the fair value hierarchy. The pooled separate accounts held by the Plan invest exclusively in mutual funds. Mutual funds are registered with the Securities and Exchange Commission and are required to publish their daily NAV and transact at that price.

### *Guaranteed Interest Accounts*

Guaranteed interest accounts, which are not fully benefit-responsive, are valued at fair value which is the amount that would be received were the funds to be withdrawn or transferred prior to maturity. Fair market value approximates contract value, which means the aggregate of contributions made plus interest earned less contract asset charges, fees and any previous withdrawals, adjusted to reflect current observable market interest rates only to the extent such market rates exceed crediting rates. Guaranteed interest accounts are classified as Level 2 within the hierarchy.

The preceding methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **5. Related-Party Transactions and Party-in-Interest Transactions**

Certain plan investments are units of pooled separate accounts and guaranteed interest accounts managed by John Hancock. John Hancock is the insurance carrier and custodian, and therefore, these transactions qualify as party-in-interest transactions. During 2024, the Plan made a direct payment to the insurance carrier in the amount of \$26,409. The Company pays directly any other fees related to the Plan's operations. Investment management fees paid by the Plan to John Hancock and passed through to Bay Colony Advisors are included in advisory fees on the statement of changes in net assets available for benefits.

Amounts credited back to participants during the year ended December 31, 2024, are included as other income on the statement of changes in net assets available for benefits. Notes receivable from participants also qualify as party-in-interest transactions.

Certain employees of the Company who participate in the Plan, perform administrative services to the Plan at no cost to the Plan.

### **6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their company contributions.

### **7. Tax Status**

The Company adopted a Non-Standardized Pre-Approved document with CODA, sponsored by Angell Pension Group, Inc. The Internal Revenue Service has issued a favorable opinion letter dated June 30, 2020, indicating that the pre-approved plan is designed in accordance with applicable sections of the IRC. The pre-approved Plan's opinion letter is being relied upon by the Plan. Plan management believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the federal and state taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the statements of net assets available for benefits.
