Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of WinCo Development 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits – modified cash basis as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits – modified cash basis for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Notes to Financial Statements

December 31, 2024 and 2023

(1) Description of Plan

The following description of the WinCo Development 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan is a defined contribution plan covering substantially all full-time employees of WinCo Development, LLC and subsidiaries, and the following participating employers: Scorpion Pressure Control, LLC; Smitty’s Texas, LLC; and Denali Iron & Disposal, LLC (the “Company”) who have six months of service and are at least 18 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Trustees are responsible for oversight of the Plan, including determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

(b) Contributions

Each year, participants may contribute up to 90 percent of pretax annual compensation, as defined in the Plan. Participants who have attained age fifty before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (“rollovers”). The Company matches 100% of the participant deferrals up to 3% and 50% of participant deferrals greater than 3% but less than 5%. Also, the Company may also make discretionary profit-sharing contributions to the Plan in an amount determined by the Company’s Board of Directors. There were no profit-sharing contributions made during 2024 and 2023. Contributions are subject to certain limitations. Participants direct the investment of their contributions into various investment options offered by the Plan.

(c) Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit-sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements (Continued)

(1) Description of Plan (continued)

(d) Vesting

Participants are vested immediately in their contributions and employer safe harbor contribution plus actual earnings thereon. Vesting in the Company's discretionary contributions of their accounts is based on years of continuous service. A participant is fully vested after six years of credited service. Full vesting in employer contributions also occur upon death or disability.

(e) Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set at 2 percent above the prime rate, as defined. Principal and interest is paid ratably through payroll deductions. Loans are typically repaid over a period not to exceed five years. Any outstanding loans become immediately due and payable upon termination of a participant's employment.

(f) Payment of Benefits

On termination of service, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

(g) Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$11,602 and \$5,132, respectively. These accounts are used to pay administrative expenses and/or reduce future employer contributions. In 2024, administrative expenses were reduced by \$1,050 of forfeited non-vested accounts. In 2023, employer contributions were reduced by \$26,016 of forfeited non-vested accounts.

(2) Summary of Significant Accounting Policies

(a) Basis of Accounting

The financial statements of the Plan are prepared under the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Under the modified cash basis of accounting, interest income and contributions are recognized when they are received rather than earned. Certain expenses and related liabilities, including liabilities for corrective distributions, are recognized when paid rather than when the obligation is incurred.

The Plan provides for self-directed investment programs for individual participants. Investments are reported at net asset value as a practical expedient, except for fully-benefit responsive investment contracts, which are reported at contract value. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to direct investments in fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for further discussion of investment valuation.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as received. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(c) Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance. Interest income is recorded as received in accordance with the modified cash basis. Related fees are recorded as administrative expenses and are expensed when they are paid. Delinquent participant loans are classified as distributions based upon the terms of the Plan agreement.

(d) Payment of Benefits

Benefits are recorded when paid.

(e) Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

(2) Summary of Significant Accounting Policies (continued)

(f) Income Taxes

The Plan recognizes the effect of income tax positions only if those positions are more likely than not of being sustained. Recognized income tax positions are measured at the largest amount that is greater than 50% likely of being realized. Changes in recognition or measurement are reflected in the period in which the change in judgment occurs.

(g) Use of Estimates

The preparation of financial statements in accordance with modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(3) Investment Contract with an Insurance Company

The Plan maintains a group annuity investment contract with Transamerica Financial Life Insurance Company (“Transamerica”). Transamerica maintains all assets of the group annuity investment contract in pooled separate accounts and an unallocated investment contract. The following methods and assumptions were used to report the values of the investment contract with an insurance company. The pooled separate accounts are valued daily at the net asset value (“NAV”) of units in the account. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investment held by the account. This practical expedient is not used when it is determined to be probable that Transamerica will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. The ability to exchange units of a pooled separate account may be restricted in the event that the Plan or participant engages in trading patterns which are detrimental to the account or the underlying investments. Trading restrictions apply to transfers into an investment fund; transfers out of a pooled separate account are allowed at any time. There were no unfunded commitments at December 31, 2024 and 2023 related to the Fund.

The unallocated investment contract is a stable value fund (Stable Value Core Account) (the “Fund”) with Transamerica. The Fund, maintained by Transamerica in a general account, is valued at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less funds used to pay benefits and administrative expenses. The primary objective of the Fund is to preserve principal while generating returns in excess of money market funds and one-year U.S. Treasury bills. Prior to January 1st and July 1st, the effective annual rate of interest is established for the corresponding six-month period.

Interest is credited, based upon the daily balance, at a rate that is the daily equivalent of the effective annual rate of interest applicable for the six-month period. There is no stated minimum or maximum interest rate for the Fund. Although Plan participants generally may withdraw assets from the Fund without restrictions, Transamerica may impose a hold period at the contract level in the event of a full contract discontinuance or partial contract discontinuance.

(4) Information Certified by the Custodian

The financial information included in the financial statements, except for contributions, benefits paid to participants, and administrative expenses, have been derived from information certified as complete and accurate by the custodian of the Plan, Transamerica Financial Life Insurance Company, in accordance with Section 2520.103-5(c) of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA.

(5) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

(6) Tax Status

The Plan is using a standardized prototype profit-sharing plan document. In a letter dated June 30, 2020, the IRS indicated the standardized form of the Plan is acceptable under Section 401 of the Internal Revenue Code (the "Code"). The opinion of the IRS on the acceptability of the form of the Plan is not a ruling or determination as to whether the Plan qualifies under Code Section 401(a). Although the Plan has been amended as a result of legislative changes since receiving the acceptability letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

(7) Risks and Uncertainties

The Plan invests in a group annuity investment contract with various investments underlying the contract. Investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at

least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits – modified cash basis.

(8) Party-In-Interest Transactions

The Plan invests in a group annuity investment contract with Transamerica. Transamerica Retirement Solutions Corporation, a marketing unit of Transamerica, provides administration services to the Plan. Additionally, as discussed in Note 2, the Plan paid certain other expenses related to operations and investment activity to service providers.

The Plan has not considered Company contributions to the Plan, notes receivable from participants, or benefits paid by the Plan to participants as party-in-interest transactions as these are exempt from the prohibition of party-in-interest transactions under ERISA.

(9) Delinquent Participant Contributions

In 2022, participant contributions were withheld from participants' wages, but through oversight, were not remitted to the Plan within the time frame required by the Department of Labor under the Plan asset rules. This constitutes a loan from the Plan to the Company. The Company plans to remit the contributions of \$236, plus earnings, to the Plan by December 31, 2025.

(10) Subsequent Events

Effective January 1, 2025, the Plan document was amended to provide that the Company will match 100% of the participant deferrals up to 4% of the participant's plan compensation.

The Plan has evaluated subsequent events from the date of the statements of net assets available for benefits – modified cash basis through October 8, 2025, the date at which the financial statements were available to be issued, and determined there are no other items to disclose.
