Opinion

NOTE 1 – DESCRIPTION OF PLAN

The following brief description of the DHE Plumbing and Mechanical Employee Stock Ownership Plan (the Plan), is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

DHE Plumbing and Mechanical Inc., herein referred to as “the Company” established the DHE Plumbing and Mechanical Employee Stock Ownership Plan effective as of August 31, 2023. The Plan was created and operates, in relevant part, as a leveraged employee stock ownership plan (ESOP), and is designed to comply with Section 4975(e)(7) and the regulations thereunder the Internal Revenue Code of 1986, as amended (IRC) and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan is administered by the Company.

The Plan purchased Company common stock using the proceeds of a loan issued from the Company to the Plan (Note 7), and holds the common stock in a trust established under the Plan. The borrowing is to be repaid over a period of six years by fully deductible Company contributions to the trust fund. As the Plan makes each loan payment, an appropriate percentage of stock will be allocated to eligible employees' accounts in accordance with applicable regulations under the IRC.

The borrowing is collateralized by the unallocated shares of common stock. The Company has no rights against shares of common stock once they are allocated under the provisions of the ESOP. Accordingly, the financial statements of the Plan as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, present separately the assets and liabilities and changes therein pertaining to:

1. The accounts of employees with vested rights in allocated common stock (Allocated) and,
2. Common stock not yet allocated to employees (Unallocated).

Eligibility

Employees of the Company are generally eligible to participate in the Plan after having worked one hour of service. Entry dates to the Plan are the first day of each calendar month. Participants who are not eligible during such plan year or are not employed on the last working day of a plan year are generally not eligible for an allocation of Company contributions for such year.

Contributions

The Company is obligated to make contributions in cash to the Plan which equal the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on its term loan. The Company is allowed to make additional contributions to the Plan to pay down the principal and interest on its term loan. Employees are not permitted to make contributions.

Payment of Benefits

Participants may receive distributions from their vested accounts under the Plan upon termination of service or death in the form of a lump-sum payment or in installments. Generally, installment payments will be made over a period not to exceed five years. The five year period may be extended an additional year (up to an additional five years) for each \$275,000 by which the participant's vested account balance exceeds \$1,380,000 (as adjusted under Code 409(o) for plan years beginning after December 31, 2023). Distributions are made as soon as administratively feasible following the end of the plan year in which the event occurred. Distributions are made in cash or, if a participant elects, in the form of Company common stock plus cash for any fractional share of common stock.

Under the provisions of the Plan, the Company is obligated to repurchase participant shares which have been distributed under the terms of the Plan as long as the shares are not publicly traded or if the shares are subject to trading limitations. The Company did not repurchase any shares from participants during 2024 and 2023.

Voting Rights

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the trustee prior to the time that such rights are to be exercised. If a participant fails to exercise their voting rights, the trustee, in its discretion, shall vote the shares of allocated employer stock. The trustee is required, however, to vote any unallocated shares.

Plan Termination

The Company reserves the right to terminate the Plan at any time, subject to plan provisions. Upon such termination of the Plan, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the IRC. Upon termination of the Plan, the trustee shall pay all liabilities and expenses of the trust fund and sell shares of financed common stock held in the loan suspense account to the extent it determines such sale to be necessary in order to repay the loan.

Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each plan year with an allocation of shares of the Company's common stock released by the trustee from the unallocated account and forfeitures of terminated participants' non vested accounts. Only those participants who are eligible employees of the Company as of the last day of the plan year will receive an allocation. Allocations are based on a participant's credited points, relative to the total credited points of all the Plan's participants. An eligible participant shall be credited with one point for each \$10,000 of participating compensation plus one point for each of the participant's years of service with the employer. Plan earnings are allocated to each participant's account based on the ratio of the participant's allocation balance to all participants' allocation balances. A participant's allocation balance is the account balance at the preceding valuation date reduced by the amount of each withdrawal, distribution, transfer, or forfeiture from the account after the preceding valuation date.

Vesting

If a participant's employment with the Company ends for any reason other than retirement, permanent disability or death, he or she will vest in the balances in his or her account based on total years of service with the Company. Participants vest 20% per year of service, beginning with the second year of service, and are 100% vested after six years of service.

Put Option

Under Federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments which are more diversified. Participants who are at least age 55 and have least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. Participants who elect to diversify receive a cash distribution. Participants eligible to diversify shall have the proceeds distributed directly to them or receive the distribution in the form of the Company's common stock. Participants eligible to diversify make their election within the first ninety days after year-end based on the number of shares of the employer's stock held in their account at year-end.

Forfeitures

Employer contributions and plan forfeitures are allocated to each participant's account based upon the relation of the participant's points to total points for the plan year. Participants forfeited 336.62 and -0- shares for the years ended December 31, 2024 and 2023, respectively. Forfeited cash totaled \$2,190 and \$-0- for the years ended December 31, 2024 and 2023, respectively. The Company subsequently contributed the forfeited shares and cash back to the Plan before the end of the respective plan year.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Allocations

The financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to (a) the accounts of employees with rights in allocated stock ("allocated") and (b) stock not yet allocated to employees ("unallocated"), including shares that are committed to be released. Shares are released from collateral and become allocated generally in the period in which debt service is actually paid.

Investment Valuation and Income Recognition

The share of the company stock is valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Payment of Benefits

Benefits are recorded when paid.

Expenses

In 2024 and 2023, certain expenses of maintaining the Plan were paid by the Company and were therefore excluded from these financial statements.

Date of Management’s Review of Subsequent Events

Management has evaluated subsequent transactions and events through October 9, 2025, the date these financial statements were available to be issued, and has determined that no items require additional disclosure.

NOTE 3 – FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

Level 3 Fair Value Measurements

The fair value of the Company common stock is based on an annual independent appraisal. This appraisal was based on a combination of the market and income valuation approaches. The appraiser took into account historical and projected cash flow and net earnings, weighted average cost of capital, market comparables, and applicable discounts and premiums.

NOTE 4 – TAX STATUS

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan's tax counsel believe that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE 5 – ADMINISTRATION OF PLAN ASSETS

The Plan's assets, which consist principally of Company common stock, are held by the trustee of the Plan.

Company contributions are held and managed by the trustee, which invests cash received, interest, and dividend income and makes distributions to participants. The trustee also administers the payment of interest and principal on the loan, which is reimbursed to the trustee through contributions as determined by the Company.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Administrative expenses for the trustee's fees are paid directly by the Company.

NOTE 7 – LOAN PAYABLE

In 2023, the Plan entered into a \$4,959,833 term loan agreement with the Company. The proceeds of the loan were used to purchase 75,000 shares (or 25 percent) of the Company’s common stock. Unallocated shares are collateral for the loan. Shares are released from collateral and allocated to participants when principal and interest payments are made. The number of shares released in any year is the number of shares held as collateral, multiplied by the ratio of the current year payments, divided by the total of this year's payments, plus all future years' principal and interest payments. This resulted in 11,331 and 22,392 shares being released and allocated for the plan years ended December 31, 2024 and 2023, respectively. The agreement provides for the loan to be repaid over six years. The note bears interest at 4.09% and interest expense for the years ended December 31, 2024 and 2023 was \$108,258 and \$105,635, respectively.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan’s investments consist primarily of the Company’s common stock, which is exposed to various risks, including interest rate, market, and credit risks, as well as valuation assumptions based on earnings and cash flows. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

NOTE 9 – PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in Company common stock and has indebtedness to the Company, therefore these transactions qualify as party-in-interest transactions. As described in Note 2, the Company pays certain expenses of the Plan.

Principal Financial Group is the Plan’s recordkeeper, and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the recordkeeping services are paid by the Company.

These party-in-interest transactions are exempt from prohibited transaction rules of ERISA.
