## 1. Description of Plan

The following description of the Lumos Networks Savings and Security Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

### ***General***

The Plan is a defined contribution plan covering substantially all employees of Lumos Networks Operating Company (the "Company" or "Employer"). Excluded employees include union employees, nonresident aliens, leased employees, interns and residents of Puerto Rico. An employee becomes eligible to participate in the Plan upon attainment of age 18 and completion of 30 days of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Effective December 31, 2024, assets of \$23,017,219 from the Unite Retirement Savings Plan were merged into the Plan.

### ***Contributions***

Participants may elect to have a percentage deducted from their compensation as defined by the Plan document. Participant contributions may be deducted in "pre-tax" dollars for the 401(k) and "post-tax" dollars for the Roth 401(k). The Plan includes an auto enrollment provision whereby all eligible employees that have not made an affirmative election are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default rate set at 3% of their eligible compensation which will increase by 1% each year until the maximum contribution of 10% is reached. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. A participant may elect to increase, decrease or suspend deductions according to procedures established by the Company. There is an annual limit as to the amount that can be deducted from compensation that is determined by the Internal Revenue Code ("IRC").

The Company will make a safe harbor matching contribution in the amount of 100% of a participant's contributions that do not exceed 1% of eligible compensation plus 50% of a participant's contributions that exceed 1% of a participant's eligible compensation but do not exceed 6% of eligible compensation.

### ***Participant Accounts***

Each participant's account is credited with the participant's contribution and allocations of (a) the Employer's contribution and (b) Plan earnings (losses) thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All investments are participant directed.

## 1. Description of Plan (*continued*)

### ***Vesting***

A participant is 100% vested in his or her deferral and rollover accounts including allocated earnings thereon at all times. For any Employer contributions, participants are 100% vested after completion of 2 years of service. Effective January 1, 2023, participants are 100% vested upon entering the Plan in their Employer contributions.

### ***Forfeitures***

If a participant terminates their employment with the Company, the non-vested contributions plus allocated earnings thereon may be used to reduce future Employer contributions or Plan expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$97,699 and \$27,703. During 2024, \$27,703 was used to reduce Employer contributions.

### ***Notes Receivable from Participants***

The Plan offers a loan feature whereby a participant (borrower) enrolled in the Plan may borrow a minimum amount of \$500 up to a maximum amount of 50% of their vested account balance or \$50,000 (whichever is less). Loans are collateralized by the balance in the participant's account and bear interest at prime rate plus one percent. The loan must be repaid within a five-year period, unless the loan is used to acquire the principal residence of the borrower which must be repaid within a fifteen-year period. A participant may not have more than two loans outstanding at any one time.

### ***Payment of Benefits***

Upon termination of service due to death, disability, retirement, age 59 1/2 or other reason, a participant is entitled to receive a lump-sum amount equal to the value of the participant's vested interest in their account. Benefits can also be distributed in the event of a participant's immediate and heavy financial need. Such distributions, which are considered hardship withdrawals, cannot exceed the amount required to relieve the financial need.

## 2. Summary of Significant Accounting Policies

### ***Basis of Accounting and Use of Estimates***

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### ***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

### 2. Summary of Significant Accounting Policies *(continued)*

#### ***Fair Value Measurements (continued)***

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the net asset value (“NAV”) per share as a practical expedient are not categorized within the fair value hierarchy.

#### ***Investment Valuation and Income Recognition***

All of the Plan’s investments are stated at fair value except for the pooled separate account, which is stated at contract value. Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The common/collective trusts are valued at the NAV of units held by the Plan. The NAV, as provided by the trustee of the trusts, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The pooled separate account is valued at contract value, which represents contributions plus credited interest less participant withdrawals and fees.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the participant loan balance is reduced and a benefit payment is recorded upon a distributable event.

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### ***Expenses***

Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

#### ***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 6, 2025.

#### ***Common/Collective Trusts***

The Plan invests in 8 common/collective trusts (the "Trusts") with Northern Trust, Capital Group and MFS. The NAV for each of these Trusts is determined each business day. Issuances and redemptions of units may be made on such days, based upon the NAV per unit as of the Trusts valuation date last proceeding the date on which such order to contribute or redeem assets is received. There are no unfunded commitments on the Plan's investments in common/collective trusts.

### 4. Investments (*continued*)

#### *Pooled Separate Account*

The New York Life Anchor Account (the "Account") is a pooled separate account group annuity contract seeking to provide a low-risk, stable investment option. The Account offers participants competitive yields and limited volatility with a guarantee of principal and accumulated interest. Interest is accrued daily and credited monthly. The daily rate fluctuates based on the underlying separate account investments. The balance at contract value, at December 31, 2024 and 2023 amounted to \$5,484,383 and \$5,655,883.

No direct transfers from the Account to competing investment options are allowed. Competing options generally include money market funds, other guaranteed funds and bond funds with a duration of less than 3 years. Participants may deposit and withdraw on a daily basis at contract value.

Because the Account is benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the Account. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

### 5. Tax Status

The Plan's prototype plan document preparer has obtained an opinion letter dated June 30, 2020 from the Internal Revenue Service ("IRS") stating that the Plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

### 6. Party-in-Interest Transactions

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

Certain employees of the Employer, who may also be participants in the Plan, perform administrative services for the Plan at no cost to the Plan.

### 7. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants would become 100% vested in their Employer contributions.

### **8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
