INDEPENDENT AUDITORS' REPORT

**To the Benefits Plan Committee of the
Epstein Becker & Green, P.C. 401(k) Retirement Savings Plan:**

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Epstein Becker & Green, P.C. 401(k) Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTES TO THE FINANCIAL STATEMENTS

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Epstein Becker & Green, P.C. 401(k) Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan, which was established July 1, 1991 as a Section 401(k) Savings Plan that covers all employees except non-partner attorneys and leased employees (and effective May 1, 2024, excludes part time employees who have a job title of “Summer Associate” and work fewer than 1,000 hours) of Epstein Becker & Green, P.C. (the “Employer”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Benefits Plan Committee is responsible for oversight of the Plan and determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Contributions

The Plan provides employees who have attained the age of 21 to be eligible to participate as of the first day of the payroll period coinciding with or next following such employee’s employment commencement date. Each year, participants may make pre-tax and Roth elective contributions up to 100% of compensation, as defined in the plan document. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participant contributions are subject to Internal Revenue Service (“IRS”) limitations. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation and their contributions invested in a designated target date fund until changed by the participant. A participant’s default percentage will increase by 1% each year up to a maximum default percentage of 10%. An employee has 30 days from the date they are entered into payroll to opt out of the automatic enrollment feature.

After one year of service, the non-attorney employees become eligible to receive Employer discretionary non-elective contributions (7.00% of compensation in 2024, subject to IRS limit on compensation).

Contributions (Continued)

All other participants become eligible to receive Employer discretionary non-elective contributions after completing two years of service (7.00% of compensation in 2024, subject to IRS limit on compensation).

Both non-elective contributions consider each participant as a separate group when determining the allocation of the discretionary contribution to eligible employees.

Participants direct contributions credited to their accounts into various investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions, allocation of the Employer's discretionary non-elective contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Employer discretionary non-elective contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested at the earlier of two years of credited service or attaining age 65.

NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED)

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested portion of their account balance. Notes receivable terms may not exceed five years unless the note receivable is for the purpose of acquiring a principal residence in which case the term of the note receivable may not exceed ten years. The notes receivable are secured by the vested balance in the participant's account. The notes receivable bear interest at the Wall Street Journal Prime Rate at the time of the note receivable application plus 1%. Notes receivable outstanding during the year had interest rates which ranged from 4.25% to 9.50%. Principal and interest are paid ratably through semi-monthly payroll deductions or directly from the borrower and credited to the borrower's account balance.

Payment of Benefits

The Plan provides for benefits to be paid upon termination of service, death, disability or retirement. Payments can be made in the form of installments in accordance with minimum distribution requirements of the Internal Revenue Code ("IRC") or lump-sum payments as prescribed in the Plan. In service withdrawals are permitted by the Plan and are subject to certain restrictions.

Forfeited Accounts

These accounts are utilized first to reinstate participant accounts, as applicable, then to reduce plan expenses, if any, and then to reduce future Employer discretionary non-elective contributions to the Plan. Plan expenses and certain employer contributions were reduced by \$4,632 and \$1,050, respectively, from forfeited non-vested accounts in 2024. At December 31, 2024 and 2023, there were no forfeited non-vested accounts

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates. There were no significant estimates during the Plan year ended December 31, 2024.

Investment Valuation

Investments are reported at fair value except for the fully benefit-responsive investment contract, which is valued at contract value as described in Note 5. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Benefits Plan Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Fully Benefit Responsive Investment Contract

Investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The statements of net assets available for benefits presents the investment contract at contract value. Contract value, as reported to the Plan by the trustee/custodian, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The statement of changes in net assets available for benefits is prepared on a contract value basis for such investment.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Contributions

Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation.

Contributions from the employer are recorded in the year in which the participant compensation is earned.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are recorded as distributions based upon the terms of the plan document.

Payment of Benefits

Benefit payments are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

NOTE 3 - CERTIFIED INVESTMENT INFORMATION

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information prepared by Transamerica Retirement Solutions, LLC, the record keeper, which is certified as complete and accurate by State Street Bank and Trust Company, a qualified institution. In addition, the Plan Administrator/Employer has obtained certifications from Transamerica Financial Life Insurance Company (“TFLIC”), the issuer of the Plan’s Guaranteed Investment Option (See Note 5), and Transamerica Trust Company, the trustee of the Plan’s Collective Trust investments (See Note 4).

NOTE 4 - FAIR VALUE MEASUREMENTS (UNAUDITED)

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The Plan also utilizes a practical expedient to estimate the fair value of investments that have calculated net asset value (“NAV”) per share. Accordingly, the Plan estimates the fair value of an investment using the NAV of the investment (or its equivalent) without further adjustment unless the Plan determines that the NAV is deemed to be not reflective of fair value.

The three levels of the fair value hierarchy under the framework are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. In evaluating the level at which the Plan's investments have been classified, the Plan has assessed factors including, but not limited to price transparency, the ability to redeem at NAV at the year-end and the existence or absence of certain restrictions at year-end.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds and money market fund: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trusts: Valued based on the NAV of the collective trust's underlying investments. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. There are no unfunded commitments with respect to the common collective trusts. The fund generally provides for daily redemptions by the Plan at reported NAV per share, without any advance notification. The Plan invests in one type of common collective trust at December 31, 2024; the Target Retirement Funds. The Target Retirement Funds have an objective to provide maximum return based on risk profiles for selected target retirement dates. Generally, there are no restrictions on a participant's ability to redeem their investment in the common collective trust or collective investment funds. However, withdrawals prompted by certain events may restrict a participant's ability to redeem the investment. The plan administrator does not believe that the occurrence of any such event is probable.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table sets forth by level, within the fair value hierarchy, the Plan's investments at fair value as of December 31, 2024 and 2023, excluding investments in common collective trusts. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

NOTE 5 - FULLY BENEFIT RESPONSIVE INVESTMENT CONTRACT

The Plan has a guaranteed investment contract related option, the Guaranteed Investment Option, issued by Transamerica Financial Life Insurance Company (“TFLIC”). The contract underlying this investment option is considered to be fully benefit-responsive and therefore it is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus interest, less participant withdrawals, and administrative expenses.

TFLIC is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed. The crediting rate is based on a formula established by TFLIC but may not be less than 0.00 %. The crediting interest rate to participants for the contract as of December 31, 2024 and 2023 was 3.30% and 2.55%, respectively.

The Plan’s ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on TFLIC’s ability to meet its financial obligations. TFLIC’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

NOTE 5 - FULLY BENEFIT RESPONSIVE INVESTMENT CONTRACT (CONTINUED)

Certain events might limit the ability of the Plan to transact at contract value with TFLIC. A market value adjustment may apply to withdrawals, other than benefits as defined in the contract, at the request of the Plan. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the IRC or the failure of the trust to be tax-exempt under Section 501(a) of the IRC
2. Premature termination of the contracts
3. Plan termination or merger
4. Changes to the Plan's prohibition on competing investment options
5. Bankruptcy of the Employer

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the TFLIC and that also would limit the ability of the Plan to transact at contract value with the participants.

NOTE 6 - PLAN TERMINATION

Although it has not expressed an intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, or partial termination of the Plan, participants' accounts shall be fully vested as of the date of such termination. The Employer determines the date and manner in which participants' accounts will be distributed in accordance with ERISA.

NOTE 7 - TAX STATUS

The Employer has adopted a pre-approved plan document that has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with applicable requirements of the IRC. Although the Plan has been amended since adopting the pre-approved plan document, the Plan Administrator/Employer believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

NOTE 7 - TAX STATUS (CONTINUED)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator/Employer has analyzed potential tax positions, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require adjustment to or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Transamerica Retirement Solutions LLC. Transamerica Retirement Solutions LLC is the recordkeeper for the Plan and, therefore, these transactions qualify as party in interest transactions. Fees paid by the Plan for investment management services are included in net appreciation (depreciation) in fair value of investments.

A money market fund account is held at State Street Bank and Trust Company and is comprised of unallocated accounts including funds earned by the Plan from the recordkeeper based on a percentage of the participant account balances to be utilized against future Plan expenses and are maintained in an account managed by the trustee/custodian. Accordingly, these transactions qualify as party-in-interest transactions.

NOTE 9 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 10 - SUBSEQUENT EVENTS

Subsequent events have been evaluated through October 6, 2025, which is the date the financial statements were available to be issued.
