Notes to the Financial Statements

Note 1: Description of Plan

The following description of JLB Corporation 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

SECURE 2.0 Act

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. Each of the provisions in SECURE 2.0 has its own effective date ranging from the date of enactment to 2028 and beyond, with the bulk of the provisions taking effect in 2023 and 2024. In accordance with SECURE 2.0, the Plan increased the age for required minimum distributions (RMD) from age 72 to age 73 effective January 2023. Further changes set forth in the SECURE 2.0 Act include eliminating pre-death RMD rules for Roth accounts and several voluntary changes to distribution provisions, effective January 2024. The Plan is in the process of evaluating other voluntary provisions. The Plan is required to be amended in regard to other requirements of SECURE 2.0 by December 31, 2026.

General

The Plan, which was adopted on January 1, 2006, and last restated on May 1, 2023 by JLB Corporation (the "Plan Sponsor" or "Employer"), is a defined contribution plan covering all eligible employees of the Plan Sponsor who have completed six months of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Participants may defer salary up to 75% of their total compensation or the Internal Revenue Service (IRS) limits for the year ended December 31, 2024. The total of employee and employer contributions for a given year cannot exceed the lesser of the IRS limits or 100% of the employee's annual compensation. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also defer Roth contributions.

Before January 1, 2023, the Employer made discretionary matching contributions, which were determined by the participant's eligible compensation and deferrals. On January 1, 2023, the Employer amended the Plan to no longer allow future employer contributions.

For the year ended December 31, 2024, the Employer made a Qualified Non-Elective Contribution (QNEC) to the Plan in accordance with Internal Revenue Code Section 401(k) and ERISA requirements.

Rollover

Participants who are currently employed or an eligible employee may be permitted to deposit into the Plan distributions that the participants have received from other retirement plans and certain IRAs. In 2024, there were no rollover contributions to the Plan.

Note 1: Description of Plan (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions, employer contributions, and an allocation of the Employer's nonelective contribution, if any, and plan earnings. Each account is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in their contributions and any employer's contributions, upon enrollment in the Plan, plus actual earnings (losses) thereon.

Investment Options

Participant contributions and employer contributions are allocated among the available investment options as directed by each participant. By designating these investment alternatives for participants, allowing frequent fund transfers, and providing the necessary fund information to participants, it is intended that the Plan be treated as an ERISA 404(c) Participant-Directed Account Arrangement.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan interest is determined at the time the loan is taken out and is paid back to the participants' accounts. Loans are due immediately upon the participant's termination. Loans must be fully repaid through payroll deductions within five years. If a loan is entered into for the purchase of a primary residence, it may be paid back over a period of 30 years. The participant loans are party-in-interest transactions. The loans are secured by the vested balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates at the time the loans were granted, as determined by the Plan Sponsor. A participant can have only one loan at any given time.

Hardship Withdrawals

Participants may withdraw from the Plan that portion of their account resulting from salary deferrals in the event of undue financial hardship. The maximum hardship withdrawal is equal to a participant's vested account balance.

Payment of Benefits

The Plan provides for retirement benefits to begin upon retirement. Retirement age for the Plan is 59 1/2 or upon death, total, or permanent disability of a participant while employed.

Note 1: Description of Plan (Continued)

Payment of Benefits (Continued)

On termination of service, participants with account balances less than \$5,000 will receive a lump sum amount equal to the value of their vested account balance. The distribution will be made as soon as administratively feasible. Participants with account balances greater than \$5,000 may elect for an immediate lump sum distribution, annuity distributions, or distributions received in substantially equal installments of the value of their vested account balance. During the year ended December 31, 2024, the Plan increased the dollar limit for mandatory distributions to individual retirement accounts for balances between \$1,000 and \$5,000 to balances between \$1,000 and \$7,000.

Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their employer contributions.

In 2023, the Employer experienced a significant downturn in its operations, primarily attributed to prevailing market conditions. This downturn resulted in a substantial reduction in the number of employees who were eligible to participate in the Company's employee benefit plan. As a consequence of this event, the Internal Revenue Service (IRS) deemed the occurrence as a partial plan termination, as defined by applicable regulations, requiring all participant balances to become 100% vested. This partial plan termination did not have a direct financial impact on the Plan due to the current vesting schedule at the time the event occurred.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses of the Plan are paid both by the Plan Sponsor and participants of the Plan.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates in Preparation of Financial Statements

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Subsequent Events

The Plan has evaluated subsequent events through October 7, 2025, which is the date the financial statements were available to be issued.

Note 3: Information Prepared and Certified by the Trustee

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends and interest income from notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Ascensus, LLC, as an agent for Ascensus Trust Company and Newport Trust Company, LLC.

Note 4: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Note 4: Fair Value Measurements (Continued)

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Money market fund: Valued at the daily closing price reported by the fund, which is the quoted net value (NAV) of shares.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The following tables set forth by level, within the fair value hierarchy, the Plan's investment assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement:

Note 5: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 6: Party-In-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, a person who owns 50% or more of such an employer or relatives of such persons.

Certain plan investments are shares of mutual funds and a money market fund managed by Ascensus LLC, the Trustee of the Plan. Therefore, these transactions qualify as party-in-interest transactions. The fees paid by the Plan for the investment management services are netted with the investment income (loss) on each investment option of the Plan for the year ended December 31, 2024.

Also, certain administrative functions are performed by employees of the Plan Sponsor on behalf of the Plan at no cost to the Plan. The Plan paid investment advisor fees of \$57,614 to UBS Financial Services for the year ended December 31, 2024. The remaining administrative expenses of \$2,520 were paid to Vanguard Group in exchange for platform access.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note 7: Tax Status

The employer adopted a nonstandard prototype document with an IRS notification letter, dated March 31, 2008, updated on June 30, 2020, which states the prototype plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, it believes Plan was qualified and the related trust was tax-exempt as of the financial statement date.

GAAP requires plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
