Report on the Audit of the Financial Statements

Opinion

We have audited the accompanying financial statements of Retirement Plan of the I.B.E.W Local 76 Retirement Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of Retirement Plan of the I.B.E.W Local 76 Retirement Trust as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). 

NOTE 1 DESCRIPTION OF PLAN

The following description of Retirement Plan of the I.B.E.W Local 76 Retirement Trust (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was established in January 1981 as a defined contribution plan as a result of collective bargaining agreements between the union and various employers to provide retirement benefits to eligible participants. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Effective January 1, 2018, the Plan was amended to change from a Money Purchase Plan to a 401(k) Safe Harbor Plan, as such terms are defined in Section 401(k) of the Internal Revenue Code. Effective January 1, 2018, a participant may elect to have their employer defer a designated amount of their pre-tax compensation into the participant's 401(k) account within the Plan. Employer contributions made on or after January 1, 2018, will be accounted for in the non-elective employer contribution account within the Plan.

Eligibility

An employee shall become a participant as of the date his or her employer is required to contribute to this Plan on the employee's behalf by the terms of a collective bargaining agreement or special agreement.

Employer Contributions

Employer contributions to the Plan are based on hours worked by covered employees. The rate per hour is set by collective bargaining agreements.

Participant Contributions

Participants may elect to defer a flat dollar amount per hour (in one dollar increments to not more than \$6.00 per hour) of their compensation, not to exceed limits set by law. Effective January 1, 2018, the Plan was also amended to auto-enroll participants at a \$1.50-per-hour deferral rate if no affirmative election is made. Participants can elect to have benefits that were earned under another eligible retirement plan transferred or rolled over to their account under this Plan. Effective for all hours worked on or after June 1, 2020, the hourly deferral cap was increased to not more than \$8.00 per hour. Effective April 1, 2023, the hourly deferral cap was increased to not more than \$10.00 per hour for participants under age 50 and to \$13.00 per hour for participants age 50 and older.

Participant Accounts

Each participant's account is credited with the contributions paid on their behalf and any additional voluntary employee contributions and earnings on the investments in the participant's account. Each account will also be charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

NOTE 1 DESCRIPTION OF PLAN (CONTINUED)

Vesting

Participants are vested immediately in all contributions and earnings thereon.

Investment Options

Contributions to the Plan are invested as directed by the participant in various investment options. Participants must evaluate their own investment goals and objectives and choose the investment options best suited to achieve those goals and objectives. Poor investment performance by the investment options selected by the participants may cause their balances to be lower than the amount contributed to the Plan on their behalf.

Benefit Payments

Participants may receive a distribution from their account: (a) if age 62 has been attained and there have been no contributions to the participant's individual account for at least three consecutive months, or they are receiving a pension from the I.B.E.W.. Pacific Coast Pension Fund; (b) if, regardless of age, no contributions have been made to the participant's account under the Plan for at least 12 consecutive months, and the participant is not working or seeking employment in the electrical industry (however, if the amount in their individual account is less than \$500 and there have been no contributions recorded in the past 12 months, their balance may be withdrawn); (c) in the event of a disability; (d) following attainment of age 70½, even though they continue to work (if they are a 5% owner of their employer or if they have retired, payment of their account will commence automatically at age 70½; effective January 2020, payment will automatically commence at age 72); or (e) upon their death, their account will be paid to their designated beneficiary in either a lump sum or an annuity, at the election of their beneficiary.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investment Valuation and Income Recognition

The Plan's investments are valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions Receivable

Employer and participant contributions due but not paid at year-end are recorded as employer contributions receivable and participant contributions receivable. The estimate for expected credit losses considers historical loss experience, current economic conditions, and forward-looking information, including factors such as payment history, employer financial condition, and labor trends. As of December 31, 2024 and 2023, the allowance for credit losses was insignificant. Contributions due as a result of payroll audits have been recorded net of an allowance equal to the amount due because collectability is uncertain. Therefore, delinquent contributions are recorded when received.

Benefit Payments

Benefits are recorded when paid.

Administrative Fee Credits

Fee rebates received by John Hancock Retirement Plan Services (John Hancock), the Plan's record keeper, in excess of their required fee revenue are refunded back to the Plan and recorded as investment income when earned. Revenue sharing income received by John Hancock is credited back to the individual participant accounts.

Subsequent Events

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through September 18, 2025, the date the financial statements were available to be issued.

NOTE 3 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Mutual Funds: The fair value of mutual funds is based on quoted prices in active markets (Level 1).

Collective Trust: The fair value of the NECA-I.B.E.W. Equity Index Fund has been estimated using the net asset value per share of the investment. The net asset value is being used as a practical expedient to estimate fair value. Participants can redeem daily at net asset value. This investment is a direct filing entity with the Department of Labor; therefore, information regarding the investment strategy is not disclosed. NOTE 4 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 5 PLAN TERMINATION

It is the intent of the Trustees to continue the Plan in full force and effect; however, to safeguard against any unforeseen contingencies, the right to discontinue the Plan is reserved to the Trustees. In the event of termination, the Trustees shall apply the assets and shall distribute and allocate all assets of the trust in accordance with the provisions of the trust to pay, or provide for the payment of, any and all obligations of the trust and Plan. In no event shall any of the assets remaining be paid to or be recoverable by any employer or the union.

NOTE 6 PLAN TAX STATUS

The Plan obtained its latest determination letter, dated August 7, 2015, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan's administrator and the Plan's legal counsel believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require management to evaluate the tax positions taken by the Plan and to recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the Internal Revenue Service. Management has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by the taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by John Hancock. John Hancock is a qualified institution, as defined by the Plan, and, therefore, the investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 8 LATE PARTICIPANT CONTRIBUTIONS

According to Prohibited Transaction Exemption ("PTE") 76-1, neither the failure of a participating employer to make a contribution to the Plan when due nor the failure of the Plan to collect such a delinquent contribution constitutes a prohibited transaction under Code Section 4975 if the Plan is making a systematic, reasonable and diligent effort to collect delinquent contributions. The Plan has written procedures for the collection of delinquent contributions and assesses liquidating damages and interest in accordance with PTE 76-1. As such, the late participant contributions are not reported as a prohibited transaction. The total amount of known late participant contributions totaled \$67,159 for the year ended December 31, 2024. The total of late contributions for the year ended December 31, 2023 was \$68,875.

NOTE 9 RECIPROCAL CONTRIBUTIONS

The Plan has Reciprocity Agreements with certain other funds. In accordance with these agreements, the Plan is required to remit funds received and is entitled to receive funds from participating employers on behalf of employees who are working outside of their local union jurisdiction.

For the years ended December 31, 2024 and 2023, the Plan paid \$1,046,888 and \$757,967, respectively, and received \$1,744,990 and \$1,662,307, respectively, of reciprocal cash payments in accordance with these agreements. Reciprocal contributions paid and received are included in the employer's contributions in the statements of changes in net assets available for benefits.
