Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of CSAA Insurance Group Retiree Health Reimbursement Arrangement (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year from the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Description of the Plan

The following is a brief description of the CSAA Insurance Group Retiree Health Reimbursement Arrangement (the Plan), which is provided for general information purposes only. The Plan is sponsored by CSAA Insurance Services, Inc. (herein referred to as the "Company"). The Company is the sponsor and administrator of the Plan. This Plan supersedes the CSAA Insurance Group Health and Welfare Plan (H&W Plan, the "Prior Plan") provisions with respect to Medicare eligible retirees. Participants should refer to the Plan document for more complete information.

General

The Plan is a defined contribution plan and provides reimbursements for certain healthcare expenses, which are not otherwise reimbursed, to eligible retirees and their eligible spouse or domestic partner. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Company has reserved the right to amend or terminate the Plan at any time subject to the provisions of ERISA. Rights to benefits under the Plan will never vest nor is there a provision to continue benefits coverage in the future. If the Plan is terminated, no participant shall have any guaranteed or vested right to any benefits provided by the Plan. Consent of any participant or retiree is not necessary for the Company to modify or amend the Plan.

On January 1, 2016, the Plan was amended to include pre-65 Retirees and pre-65 Spouse/Domestic Partner and eligible dependents. The retirees are reimbursed for medical expenses up to a fixed dollar portion based on year of retirement, years of service and other factors.

Plan Changes

There were no changes to the Plan in 2024 and 2023.

Company Contributions

Company contributions are recorded at the time participant expenses are approved for payment.

Eligibility and Contributions

Eligibility in the Plan commences for post-65 retirees and pre-65 retirees on effective dates of January 1, 2014 and January 1, 2016, respectively, subject to meeting eligibility requirements in accordance with the Plan. Retiree eligibility is effective upon qualification in accordance with the terms and conditions in the Plan for retirees and their eligible spouse or domestic partner. Participants of the Prior Plan enrolled immediately before the effective date, who enroll in an individual supplemental Medicare plan in accordance with the requirements of the Plan guidelines, are eligible to participate in the Plan.

A retiree or spouse/domestic partner, who is eligible to participate in the Plan, shall become a participant in the Plan on the first of the month following the date when the enrollment requirements are met in accordance with Plan requirements.

The Plan may be funded through the use of a 401(h) account, by the Company out of its general assets, or another funding method, in accordance with the Plan's documents. Plan contributions are credited in accordance with levels and tiers which vary according to the retirees' age and years of service. Individuals that become participants in the middle of a plan year will receive a prorated contribution. Plan contributions will be available annually each January 1st, or the first day of the month in which the individual becomes a participant within that plan year.

Plan Benefits

The Company will credit a participant's Health Reimbursement Arrangement (HRA) account with HRA contributions. The HRA account is a notional account and does not bear interest or accrue earnings of any kind. The Plan will reimburse participants for eligible health care expenses up to the unused amount in the participant's HRA account. Amounts remaining at the end of the Plan year shall be carried over to the following Plan years. The Plan is intended to be a "Health Reimbursement Arrangement" as defined in Internal Revenue Service (IRS) Notice 2002-45, such that the Plan's reimbursements of participants' eligible expenses are excludable from participants' gross income under Internal Revenue Code (IRC) sections 106 and 105(b). Health expenses not eligible for payments from the 401(h) account, such as executive payments, can be reimbursed through the Company's general assets account. These payments are designated as "Company contributions" for reporting purposes. No participant contributions are permitted.

401(h) Account

The Company's pension plan, the CSAA Insurance Group Cash Balance Retirement Plan (Pension Plan), includes a health benefit component in addition to normal retirement benefits to fund a portion of the health expenses for pre-65 and post-65 retirees and their dependents in accordance with Section 401(h) of the IRC. In accordance with IRC Section 401(h), investments in a 401(h) account may not be used for, or diverted to, any purpose other than providing health benefits for retirees and their beneficiaries. The related health expenses for health benefits are not included in the Pension Plan's accumulated plan benefits, but are reflected as health expenses in the financial statements of the Plan. Plan participants are not permitted to contribute to the 401(h) account. Employer contributions or qualified transfers to the 401(h) account are determined annually and are at the discretion of the Plan sponsor.

Benefits Paid

Payments are made at the direction of the claims administrator, following the provisions of the Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared and presented in conformity with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates and Assumptions

The preparation of the Plan's financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from those estimates.

Risks and Uncertainties

The Plan provides for various investment options. The underlying investments are exposed to various risks, such as interest rate, market, liquidity, and credit risks including risks related to a global pandemic. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Company pays a fee based on participant counts to a third party administrator to administer participant claims and reimbursements.

3. 401(h) Account

A portion of the Plan's health expenses are funded through contributions to the Company's Pension Plan, in accordance with IRC Section 401(h). The tables below show the net assets and change in net assets as of December 31, 2024 and 2023.

4. Certified Investments

Certain information related to investments disclosed in the accompanying financial statements, including investments held on December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by The Northern Trust Company (the custodian of the Plan).

5. Party-In-Interest Transactions

Parties-in-interest are defined under the Department of Labor's regulations as any fiduciary of the plan, any party rendering service to the plan, the employer, and certain others. Certain professional fees for the administration and audit of the Plan were paid by the Company. Various administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

6. Tax Status

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. There are currently no audits for any tax periods in progress.
