Independent Auditors' Report

***Opinion***

In our opinion, based on our audits and the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

NOTE 1 • DESCRIPTION OF THE PLAN

The following description of Jackson Academy, Inc. 401(k) Plan (hereafter referred to as the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible full-time employees of Jackson Academy (hereafter referred to as the "Academy"). The Academy's Board of Trustees and the Plan Administrator control and manage the operation and administration of the Plan. Securian is the Trustee of the Plan. Minnesota Life Insurance Company serves as the custodian of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Organization and Operations

The Academy was organized as a corporation under the laws of the State of Mississippi on May 25, 1959, for the purpose of operating a school as a non-profit institution of learning exclusively for educational purposes. The Academy offers classes to students from pre-school through the twelfth grade in facilities located in Jackson, Mississippi.

Academy Contributions

Participants may contribute a percentage of pre-tax annual compensation, as defined in the Plan. There are no limitations on the percentage the participant can defer; however, the participant is limited by law as to the total contribution amount per year of \$23,000 for 2024, and \$22,500 for 2023. This amount is adjusted by the Secretary of the Treasury for the percentage increase in the Consumer Price Index each year. Additionally, participants age 50 and older can elect to make additional catch-up deferrals as described in the Plan, but not to exceed the limitation imposed by law of \$7,500 for 2024 and 2023. During 2024 and 2023, the Academy elected to match 100 percent of elective deferrals up to four percent contributed by the participant. Additional amounts may be contributed at the option of the Academy's Board of Trustees.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Academy's contributions and Plan earnings and charged with an allocation of administrative Plan expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Participants are immediately vested in their voluntary contributions, plus actual earnings thereon. Vesting in the remainder of their account is based on years of continuous service. A participant is 100 percent vested after four years of credited service.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions to any investment option offered by the Plan. Participants may change their investment options daily.

Participant Loans

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account and bear interest at a fixed rate determined by the Administrative Committee, which is commensurate with local prevailing rates charged for similar types of loans by other lenders which are commercially reasonable rates of interest.

Payment of Benefits

Upon termination of service, a participant may elect to receive an amount equal to the value of the participant's vested account balance in a lump-sum amount, annual installments or a combination of single sums of not less than \$100 per distribution.

Plan Termination

Although it has not expressed any intent to do so, the Academy has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Administrative Expenses

During 2024 and 2023, administrative fees payable to the custodian of the investments were paid by the Plan and all other expenses related to the administration of the Plan were absorbed by the Academy.

Forfeited Accounts

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$54,086 and \$18,853, respectively. Forfeitures are used first to offset Plan administrative expenses and are then added to any employer matching contributions and allocated as additional matching contributions.

NOTE 2 • SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the modified cash basis of accounting. The modified cash basis of accounting differs from accounting principles generally accepted in the United States of America, in that contributions and interest income are recorded when received and administrative expenses are recorded when disbursed.

Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires the Plan Administrator to make estimates and assumptions that affect certain reported assets, liabilities and changes therein and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates. Significant estimates include the fair value measurement of investments. It is at least reasonably possible that the significant estimates used will change within the next year.

Employee and Employer Contributions

Employee and employer contributions are recognized as additions to net assets when received. Employee rollover contributions are recognized as additions to net assets when received from other qualified plans.

Investment Valuation and Income Recognition

Investments are stated at year-end fair value (except for the fully benefit-responsive investment contract which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Any unrealized appreciation or depreciation for the year is reflected in the statements of changes in net assets available for benefits on a modified cash basis. See Note 5 for a discussion of fair value measurements.

Investment Valuation and Income Recognition (continued)

Purchases and sales of investments are recorded on a trade-date basis. Interest income and dividends are recorded when received. Any dividends received from the underlying funds are reinvested on behalf of the Plan. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Participant loans are measured at their unpaid principal balance and interest income is recorded when received. Delinquent loans are treated as distributions based upon the terms of the Plan document. The loans are collateralized by the balance in the participant's account and bear interest between 3.75 and 9.00 percent for 2024 and 2023, which are commensurate with local prevailing rates as determined by the Plan Administrator. Participant loans have various maturity dates ranging from 2025 through 2029.

Concentration of Market Risk

The Plan assets include a significant amount of pooled separate accounts, which invest primarily in marketable equity securities and fixed income securities. Accordingly, the performance of the investments is dependent on the equity and debt securities markets which involve price volatility. Additionally, the pooled separate accounts may invest in securities with contractual cash flows, such as asset backed securities, collateralized mortgage obligations and commercial mortgage-backed securities, including securities backed by subprime mortgage loans. The value, liquidity and related income of these securities are sensitive to changes in economic conditions, including real estate value, delinquencies or defaults, or both, and may be adversely affected by shifts in the market's perception of the issuers and changes in interest rates.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

Subsequent events were evaluated by the Plan on October 8, 2025, which is the date the financial statements were available to be issued.

NOTE 3 • INVESTMENT CONTRACTS WITH INSURANCE COMPANIES

The Plan's investments include investment contracts with Minnesota Life Insurance Company (the "Insurer"). The Insurer maintains the Plan's contributions in their general accounts. The investment contracts are credited interest and charged for participant withdrawals and administrative expenses.

The guaranteed investment contract insurers are contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

This guaranteed investment contract meets the fully benefit-responsive criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the Insurer, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contracts at December 31, 2024 and 2023, was \$1,609,219 and \$1,422,596, respectively. The crediting interest rate is based on a formula agreed upon by the issuers.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

NOTE 4 • INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN

Pursuant to the provisions of 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan's independent accountants did not perform any auditing procedures with respect to the information certified by Minnesota Life Insurance Company, the Custodian, except for comparing the information to the related financial

statements and supplemental schedules. All information included in the financial statements and the accompanying notes and supplemental schedules relating to investments, notes receivable, appreciation and depreciation of investments and interest income was obtained from the Custodian's certification and is unaudited.

NOTE 5 • FAIR VALUE MEASUREMENTS

Fair value measurements define fair value as the price that would be received for an asset or paid to transfer a liability in an orderly transaction between market participants on the measurement date. Fair value measurements establish a fair value hierarchy that prioritizes the observable and unobservable inputs used to measure fair value into three broad levels:

- Level 1: Quoted prices in active markets that are accessible at the measure date for identical assets and liabilities. The fair value hierarchy gives the highest priority to Level 1 inputs.
- Level 2: Observable inputs other than quoted prices in active markets.
- Level 3: Unobservable inputs for which there is little or no market data available. The fair value hierarchy gives the lowest priority to Level 3 inputs.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled separate accounts:* Primarily valued at net asset value per share based on quoted market prices of underlying investments, which are substantially open-end mutual funds that are registered with the Securities and Exchange Commission and are required to publish their daily net asset value.

The preceding methods may produce a fair value calculation that may not be indicative of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6 • PARTY-IN-INTEREST TRANSACTIONS

Plan investments include pooled separate accounts, and a guaranteed investment contract managed by Minnesota Life Insurance Company, Plan custodian. Fees incurred by the Plan for the investment management services qualify as party-in-interest transactions and amounted to \$4,080 and \$5,640 for 2024 and 2023, respectively. Such fees are based on customary and reasonable fees for such services.

NOTE 7 • INCOME TAX STATUS

The Plan adopted a volume submitter plan sponsored by Minnesota Life Insurance Company - Securian Financial Group. The volume submitter plan has received an opinion letter from the Internal Revenue Service as to the prototype plan's qualified status. The volume submitter plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

The modified cash basis of accounting requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan recognizes interest and penalties, if any, related to unrecognized tax benefits as a component of income tax expense. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 • SECURE 2.0 ACT

On December 29, 2022, the Securing a Strong Retirement Act of 2022 ("SECURE 2.0") was signed into law. Secure 2.0 has key effective dates which vary by provision. The plan has adopted and implemented all mandatory provisions to date with other provisions to be phased in over the next few years in accordance with applicable law and IRS guidance. Written amendments to the Plan to reflect these operational changes will be adopted at a later date.

NOTE 9 • NON-EXEMPT TRANSACTIONS

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets, but no later than the 15<sup>th</sup> business day of the month following the month in which the participant contributions are withheld by the employer. While the Plan remitted all employee contributions to the Plan, contributions of \$46,500 were not remitted within the required time period for the year ended December 31, 2023. As of December 31, 2024, the Plan has corrected \$46,500. In 2024 contributions of \$14,667 were not remitted within the required time period for the year ended December 31, 2024. As of December 31, 2024, the Plan has corrected \$14,420 of the employee contributions through the Voluntary Fiduciary Correction Program and made the participant accounts whole.
