### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

### 1. Description of Plan

The following description of Fogle's Inc. 401(k) Savings and Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all employees of Fogle's Inc. 401(k) Savings and Retirement Plan (the "Company") who are age eighteen or older and have been employed by the Company a minimum of three consecutive months. Participants may enter the Plan on the first day of the quarter after which the participant meets the Plan's eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). The Plan is administered by the Retirement Plan Committee of the Company. The Retirement Plan Committee of the Company acts as trustee and is responsible for the custody and management of the Plan's assets.

During 2023, the Plan was formally amended to comply with the SECURE 1.0 Act. The provisions were adopted prior to the amendment, as allowed by the SECURE 1.0 Act, and therefore the Plan was retroactively amended as of the various effective dates of each new provision. The Plan has been amended to require complete required minimum distributions to some beneficiaries of deceased participants within 10 years after death. Additionally, the Plan amendment stipulates that part-time employees will be considered long-term part-time employees, and be eligible for participation in the Plan, once the following requirements are satisfied: being credited with at least three consecutive years of service beginning January 1, 2021, with at least 500 hours of service in each year, and having attained age 21.

#### **Contributions**

Each year, participants may contribute an elected amount of pretax annual compensation, as defined in the Plan. Participants who are age fifty or older by the end of the year are eligible to make an additional catch-up contribution to the Plan. With the Trustee's consent, participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover contributions).

The Company may provide a discretionary matching contribution and an additional non-elective contribution, which may be made on a discretionary basis, dependent on the Company's operating results. Company contributions are invested into the investment options elected by the participant. For the plan years ended December 31, 2024 and 2023, the Company elected to make a discretionary matching contribution equal to 100 percent of each participant's contribution up to a maximum of six percent of the participant's eligible compensation.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of the Company's contribution and Plan earnings and charged with an allocation of administrative expenses. Allocations of Company's contributions are based on a match of participant deferral contributions. Allocations of Plan earnings and administrative expenses are based on account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are immediately vested in their elective contributions plus actual earnings thereon. Vesting in the Company's discretionary contribution plus actual earnings thereon is based on years of credited service. A participant vests according to the following schedule:

<u>Years of Service</u>	<u>Vesting Percentage</u>
Less than three years	0%
More than three years	100%

### **Investment Options**

Upon enrollment in the Plan, a participant may direct employee contributions and employer matching contributions into any of the available investment options offered under the Plan. The Plan currently offers various mutual funds and a fixed interest investment contract as investment options for participants. Participants may change their investment options as often as permitted under the investment vehicles chosen by the participant.

### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Participant loans are valued at their unpaid principal balances, plus all accrued but unpaid interest. The loans are secured by the balance in the participant's account and bear interest at prime rate plus 2%. The interest rate on all outstanding participant loans at December 31, 2024 range from 5.25% to 10.5%. Principal and interest is paid ratably through weekly payroll deductions.

### **Payment of Benefits**

On retirement, death, disability, or termination of service, a participant (or participant's beneficiary in the event of death) receives a lump sum distribution equal to the participant's vested account balance. On termination of service due to death, the surviving spouse or other beneficiary may elect to receive the value of the vested interest in his or her account as a lump sum distribution or in annual installments if required minimum distributions to the Participant have already begun. Hardship distributions are permitted if certain criteria are met.

### **Forfeitures**

At December 31, 2024 and 2023, there were \$3,426 and \$5,696, respectively of unused forfeitures to be used to offset future plan administrative expenses. During 2024, forfeitures generated totaled \$24,416 and \$21,318 and \$5,502 of forfeitures were used to pay administrative expenses and offset employer contributions of the Plan, respectively.

## **2. Summary of Significant Accounting Policies**

### **Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting.

#### **Use of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the Plan's investment advisors and custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative Expenses**

Certain expenses incurred in connection with the general administration of the Plan are paid by the Plan and are recorded in the accompanying statement of changes in net assets available for benefits as administrative expenses. Expenses of maintaining the Plan that are paid directly by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

#### **Subsequent Events**

The Plan has evaluated subsequent events through October 2, 2025, the date the financial statements were available to be issued.

### 4. Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

#### Basis of Fair Value Measurement

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2 Inputs to the valuation methodology include
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability; and
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment, and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*PSA - Mutual Funds:* The Plan's assets are held in a group annuity unallocated contract offered as a pooled separate account (PSA). The PSA invests in mutual funds that are valued based on the market value of the underlying net asset in each separate account. The majority of the underlying net assets have observable Level 1 and/or 2 quoted pricing inputs which are used to determine the unit value of the PSA which is not publicly quoted.

The preceding methods described may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Deemed Distributed Notes Receivable from Participants

As of December 31, 2024, defaulted notes receivable from participants totaled \$754. These loans have been deemed distributed to the participants for tax reporting purposes but continue to be reported as outstanding notes receivable in the Statements of Net Assets Available for Benefits until the participant incurs a distributable event. These defaulted loans are secured by the vested portion of the participant's account balance and are considered fully collectible once a distributable event occurs.

### 6. Insurance Company General Account

As of December 31, 2024 and 2023, the Plan held fixed interest investments under an Agreement with Massachusetts Mutual Life Insurance Company (Mass Mutual) with a declared rate of interest equal to 1.0%. The Fixed Interest Account, backed by Mass Mutual's general assets, is designed to provide stable, long-term investment growth. The diversified portfolio is composed primarily of high-quality, fixed-income investments including public bonds, private placements, commercial mortgage loans and short-term investments. Investments are made using a conservative approach by matching assets to liabilities.

Participants are guaranteed preservation of principle and a stated rate of return regardless of economic events while their investment is active. The guaranteed interest rate is determined in advance thus allowing plan sponsors and participants to make informed decisions regarding current allocations of their investment holdings.

Participants' accounts invested in the Fixed Interest Account are available for participant-initiated transactions at book value, including transfers to other investment options, loans and distributions in the event of hardship and upon a participant's retirement, death, disability and certain separations from service. Because these participant-initiated transactions occur at book value, participants' investments are not subject to changes in value due to market conditions. Mass Mutual backs its commitments with its own surplus and capital.

If the Agreement is fully or partially terminated, participants will receive the liquidation value of the Fixed Interest Account instead of the book value. The liquidation value is determined in accordance with a formula contained in the Agreement, which is designed to reflect the value of the assets in the account. The liquidation value may be more or less than the book value of the plan's investments in the account. This means that upon partial or full termination of the Agreement, a participant's account balance in the Fixed Interest Account may be either increased or decreased.

The fixed interest investment account is considered fully-benefit responsive. As such, the investment has been reported at contract value in the statement of net assets available for benefits at December 31, 2024 and 2023.

#### **7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the plan to discontinue its contributions at any time and to terminate the plan, subject to plan provisions and ERISA. In the event of plan termination, participants would become 100% vested in the company contributions portion of their account.

#### **8. Related Party and Party-in-Interest Transactions**

Empower Trust Company (Empower) is the custodian of the plan at December 31, 2024 and 2023. Fees incurred by the Plan for the custodial services provided by Empower are included in the net depreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The Company pays directly any other fees related to the Plan's operations.

The Company provides certain accounting, administrative and investment management services to the Plan for which no fees are charged.

#### **9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the individual participant account statements and the statement of net assets available for benefits.

#### **10. Tax Status**

The Plan is a volume submitter profit sharing plan offered by Ascensus, LLC, the plan's third-party plan administrator. The IRS has issued an advisory opinion to the third-party plan administrator by a letter dated June 30, 2020, stating that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since issuance of the advisory opinion, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the notes to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
