Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audits of the Financial Statements

Except as described in the **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit** section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control related matters that we identified during the audits.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Notes to Financial Statements

Note 1 - Description of Plan

The following description of the Delta Engineers, Architects & Land Surveyors, DPC (the “Company”) Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General - The Plan is a defined contribution profit sharing plan under Section 401(a) of the Internal Revenue Code and has a Section 401(k) salary deferral arrangement. Employees (excluding employees classified as “interns”) are eligible to participate in the Plan when they reach three months of service. There is no age requirement. Once eligible, employees can begin participating in the Plan on the first day of the month following the date eligibility requirements are met. Participants are automatically enrolled in the Plan; see contributions below. All assets acquired under the Plan are the result of employee and employer contributions thereto and all income and other additions thereto are administered, distributed, forfeited or otherwise governed by the provisions of the Plan and ERISA.

Plan amendments - Effective November 1, 2023, Section 1.09 - Rollover Contributions, was amended to allow in-plan Roth conversions for match-discretionary subaccounts. Effective January 1, 2023, the Plan was amended and restated for certain technical corrections and miscellaneous updates.

Plan provisions - The Plan has implemented certain required provisions of the Setting Every Community Up for Retirement Enhancement Act of 2019 (the “SECURE Act”), a law which, among others, extends the age for required minimum distributions to seventy-two. A written amendment to the Plan to reflect this operational change will be adopted at a later date in accordance with applicable law and Internal Revenue Service guidance.

Contributions - Participants are allowed to make elective salary deferral contributions up to the maximum amount allowed by the Internal Revenue Code and may direct their contributions, as well as employer contributions, in any of the investment options offered by the Plan. Participants are automatically enrolled in the Plan with an initial deferral rate of 6% of their annual compensation to the 401(k) plan, which is increased automatically by 1% each year, up to a maximum of 10%, unless the participant elects a different percentage or expressly elects not to participate in the Plan. Participants are also allowed to make rollover contributions to the Plan.

Each year the Company may contribute for each participant, a discretionary matching contribution. The Company’s discretionary matching contribution was equal to 50% of the participant’s elective contributions, up to 3% of eligible compensation, with a maximum contribution of 1.5% of the participant’s compensation. Discretionary matching contributions amounted to \$114,527 for the year ended December 31, 2024, of which the Company accrued \$84,527 as an employer contribution receivable as of December 31, 2024, and used \$30,000 of forfeited accounts to fund the remaining balance, as explained below in forfeitures. Discretionary

matching contributions amounted to \$118,739 for the year ended December 31, 2023, of which the Company accrued \$105,918 as an employer contribution receivable as of December 31, 2023, and used \$12,821 of forfeited accounts to fund the remaining balance, as explained below in forfeitures. The Company may also elect to make discretionary profit-sharing contributions. There were no discretionary profit-sharing contributions made for the years ended December 31, 2024 or 2023.

Participant accounts - Each participant's account is credited with the participant's elective deferral contribution, the Company's discretionary contributions and plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined by the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants can access their account information via Fidelity's website where they have the ability to change their elective deferrals and investment options as well as apply for participant notes receivable and request distributions.

Investment options - Upon enrollment in the Plan, participants may direct contributions in any of the investment options offered by the Plan. Participants may change their investment options any time through online access.

Vesting of benefits - Participants are immediately vested in their elective salary deferral contributions, rollover contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of credited service. Participants vest at a rate of 20% after two years of service and 20% each year thereafter with full vesting upon completion of six years of service for any discretionary employer matching and discretionary profit-sharing contributions.

Forfeitures - Forfeitures may be used to pay future administrative expenses or reduce future employer discretionary profit-sharing contributions. Forfeited non-vested accounts totaled \$23,207 and \$13,145 as of December 31, 2024 and 2023, respectively. The Company used \$30,000 of available forfeitures in 2025 to fund a portion of the employer discretionary matching contribution for the year ended December 31, 2024, as discussed above in contributions. The Company used \$12,821 of available forfeitures in 2024 to fund a portion of the employer discretionary matching contribution for the year ended December 31, 2023, as discussed above in contributions.

Payment of benefits - Upon termination of service, a participant or beneficiary may receive a lump-sum amount equal to the vested value of his or her account or installment payments under a systematic withdrawal plan.

Notes receivable from participants - Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The note will bear a reasonable rate of interest, similar to that which a bank or other professional lender would charge for making a similar note. The interest rates for outstanding notes range from 5.25% to 10.50%. The notes are collateralized by the balance in the participant's account. Principal and interest are paid ratably through payroll deductions. The notes receivable and interest thereon shall be repaid over a period not to exceed five years unless the note is used

to acquire a personal residence. The plan administrator will consider a note in default if any scheduled payment remains unpaid at the end of the cure period or there is an outstanding principal balance existing on a loan after the last scheduled repayment date. Any notes that are in default as defined by the plan document, are reported as either deemed distributions or benefit payments; see below.

Deemed distributions - Deemed distributions represent the amount of unpaid principal on notes receivable from participants who are actively participating in the Plan and have not continued to make payments on their outstanding notes, as required under the plan document. There were no deemed distributions for the years ended December 31, 2024 and 2023.

Hardship withdrawals - A participant may apply for a hardship withdrawal to assist in the payment of several types of personal hardships, as defined by the plan agreement. However, a participant must first take any other available distribution and borrow the maximum amount allowed by the plan agreement. Any hardship distribution is limited to the amount necessary to meet the financial need and must be approved by the plan administrator.

Plan termination - Although it has not expressed any intent to do so, the Company has the right, under the plan agreement, to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, all participants will become 100% vested in their accounts.

Note 2 - Summary of accounting policies

Method of accounting - The Plan maintains its accounting records and financial statements on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of plan income and expenses during the reporting period. Actual results could differ from those estimates.

Risks and uncertainties - The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, credit and overall market risk. Market risks include domestic and global events which could impact the value of investment securities. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

Investment valuation and income recognition - Investments are stated at fair market value (see Note 4), with the exception of the common collective trust funds, which are valued at the net asset value (NAV) as a practical expedient as reported by the sponsor of the fund, as explained below. All investment values have been determined and certified by Fidelity Management Trust Company, the Trustee of the Plan (see Note 3). Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

The Plan has investments in Putnam Stable Value Fund, which is a common collective trust fund that is made up of various investment and security-backed contracts. Common collective trust funds are valued at NAV per share, which serves as a practical expedient to estimate its fair value. The NAV of common collective trust funds is not publicly quoted in the active markets and is based on the fair value of the underlying investments held by the funds less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trusts, the investment adviser reserves the right to temporarily delay withdrawal from the trusts in order to ensure that securities liquidations will be carried out in an orderly business manner. There were no redemption restrictions or unfunded commitments as of December 31, 2024 and 2023. Investments measured at net asset value per share used as a practical expedient are not required to be classified in the fair value hierarchy.

Notes receivable from participants - Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Management individually reviews all notes receivable balances that exceed ninety days from the date of the most recent payment and based on the assessment of credit worthiness, estimates the portion, if any, of the balance that will not be collected. Currently, there is no valuation allowance recorded; however, management will record an allowance if and when potentially uncollectible participant notes receivable become material. If a participant defaults on a note receivable and distribution from the participant's account has been made during the plan year because the participant has left the Plan, the defaulted note receivable will be reported as benefits paid to participants on the statements of changes in net assets available for benefits and deducted from the receivable balance.

Economic dependency and concentration of credit risk - Approximately 81% of the Plan's investments were invested with Fidelity Investments as of December 31, 2024 and 2023, respectively. Accordingly, the Plan is dependent upon the financial condition of Fidelity Investments.

Payment of benefits - Benefits are recorded when paid.

Administrative costs - Administrative costs, including maintaining participant accounts, legal costs and accounting costs, are the obligation of the Plan; however, the plan sponsor may pay for such expenses or reimburse the Plan for any payment of these expenses. Costs of managing the investments are paid directly out of the Plan's assets (see Note 6).

Subsequent events - Management has evaluated subsequent events through September 30, 2025, the date that the financial statements were available for issue.

Note 3 - Information certified by the Trustee of the Plan

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, the Plan's Trustee. Furthermore, the Plan's independent accountants did not perform auditing procedures with respect to the information except to compare such information to the related information included in the financial statements and ERISA-required supplemental schedule.

Note 4 - Fair value measurements

The Financial Accounting Standards Board's authoritative guidance on fair value measurements provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the authoritative guidance are described as follows:

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for the Plan's assets measured at fair value.

Registered Investment Companies (i.e., Mutual Funds) - The investment portfolios consist of mutual funds, which are valued at the closing price reported on the active market on which the individual security is traded (Level 1).

Self-Directed Brokerage Investments - The investment portfolios consist of equities, which are valued at the closing price reported on the active market on which the individual security is traded (Level 1).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in methodologies used as of December 31, 2024 and 2023.

Note 5 - Tax status of the Plan

The Plan adopted a Fidelity Volume Submitter Plan, Adoption Agreement No. 001 for use with Fidelity Basic Plan Document No. 17. The Internal Revenue Service has ruled that this volume submitter plan is acceptable under the applicable sections of the Internal Revenue Code. Accordingly, the Plan has been accounted for as a tax-exempt plan. The Plan has been amended since receiving the determination letter. The management of the Company and the plan administrator are not aware of any matters that would disqualify the Plan.

The Plan has reviewed its operations for uncertain tax positions and believes there are no significant exposures. The Plan will include penalties and interest on income tax liabilities in administrative expenses if such amounts arise. The Plan did not incur any penalties and/or interest for the years ended December 31, 2024 and 2023. The Plan is no longer subject to regulatory examinations by tax authorities for the closed tax years before 2021.

Note 6 - Related party transactions

The Plan's investments are managed by Fidelity Management Trust Company, the Trustee of the Plan. Fees paid for these services qualify as party-in-interest transactions and are included in the net appreciation in investments in the accompanying statements of changes in net assets available for benefits.

The Plan pays for certain expenses related to plan operations and investment advisory to various service providers, which are party-in-interest transactions under ERISA and are included in administrative expenses on the accompanying statements of changes in net assets available for benefits as follows: the Plan has contracted with the Fidelity Investments Institutional to provide recordkeeping and third-party administrative services. Fees paid for these services amounted to \$20,144 and \$19,942 for the years ended December 31, 2024 and 2023, respectively. The Plan contracts with Northwestern Mutual Investments to provide investment management services. Fees paid for these services amounted to \$46,250 and \$44,809 for the years ended December 31, 2024 and 2023, respectively. The Plan contracts with Dannible & McKee, LLP to provide auditing services, which qualifies as party-in-interest transactions. Fees for these services were paid for by the Company for the years ended December 31, 2024 and 2023.
