To the Plan Administrator of

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of TenoVA, Inc. 401(k) Plan, (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in assets available for benefits for the years then ended, and the related notes to the financial statements.

Management has obtained certifications from Empower Trust Company, LLC, a qualified institution, as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### NOTES TO FINANCIAL STATEMENTS

---

#### 1. DESCRIPTION OF THE PLAN AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following brief description of Tenova, Inc. 401(k) Plan (the "Plan") is provided for general information purposes only. Plan participants should refer to the plan agreement or summary plan description for more complete information.

*General* - The Plan is a contributory, defined contribution plan established to provide benefits upon retirement or permanent disability to eligible participating employees of Tenova, Inc. (the "Company") or to their beneficiaries upon death of the participant. The Plan is administered by the Company and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*Basis of Accounting* - The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

*Use of Estimates* - The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the dates of the financial statements and the reported amounts of changes in assets during the reporting periods. Actual results could differ from the estimated amounts.

*Risks and Uncertainties* - Plan assets are composed of various investment securities, which are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of assets available for benefits and the statements of changes in assets available for benefits.

*Eligibility* - The Plan is available to all employees of the Company. Employees become eligible to make elective deferrals on the first day of the calendar quarter following their hire date provided they have attained the age of 21.

*Contributions* - Eligible employees who elect to participate in the Plan may make pre-tax or after-tax contributions of 1% to 60% of their annual eligible compensation (as defined by the plan agreement) to their account, up to the limit established in the Internal Revenue Code.

The Plan provides for Company contributions equal to a percentage of employees' elective deferrals. For the years ended December 31, 2024 and 2023, the Company matched 100% of a participant's deferral up to 5% of compensation. The Company may also make discretionary profit sharing contributions, which are allocated to participant accounts in the ratio of participant compensation to total participant compensation. There were no profit sharing contributions for the year ended December 31, 2024 or 2023. Employer matching contributions are available to all participants who have completed one year of service, as defined in the plan agreement. Eligibility for profit sharing contributions also requires one year of service and employees have to be employed on the last day of the plan year.

*Participant Accounts* - Each participant's account is credited with participant contributions, Company matching contributions and an allocation of earnings of the elected investment fund(s). Allocations of fund earnings to the participant accounts are based upon the ratio of each participant's account balance to the total of all participant account balances in the fund. The benefit to which a participant is entitled is the value of the participant's vested account.

*Vesting* - Participants are immediately vested (100%) in their elective contributions. The Company matching and profit sharing contributions vest in accordance with the following schedule:

*Payment of Benefits* - Upon termination of service due to death, disability, retirement or other termination, participants or their beneficiaries may elect to receive an amount equal to the value of their vested account interest or direct such to an IRA rollover. If a participant's vested account balance exceeds \$5,000, he or she may elect to receive a distribution in a lump-sum payment (or rollover to an IRA) or receive partial withdrawals. If a participant's vested account balance is less than \$5,000, his or her account balance will be automatically distributed.

Benefits are recorded when they have been approved for payment and are paid by the Plan.

*Plan Expense Account* - Revenue sharing income from plan assets is credited to the plan expense account. The plan expense account may be used to pay the Plan's administrative expenses; residual amounts may be allocated to participant accounts. Revenue sharing income was \$52,905 and \$45,526 for the years ended December 31, 2024 and 2023, respectively. Administrative expenses of \$10,343 and \$23,586 were paid

from this account for the years ended December 31, 2024 and 2023, respectively. No allocations to participant accounts were effected from the plan expense account for the year ended December 31, 2024. During the year ended December 31, 2023, \$127,537 was allocated to participant accounts from the plan expense account. Other activity in the plan expense account consisted of interest income.

The plan expense account balance, which is included in investments on the statements of assets available for benefits, was \$62,906 and \$19,719 at December 31, 2024 and 2023, respectively.

*Forfeiture Account* - When a participant withdraws from the Plan prior to becoming fully vested, the nonvested portion of the participant's account related to Company matching and profit sharing contributions is transferred to the Plan's forfeiture account. The forfeiture account may be used to pay the Plan's administrative expenses or to reduce future Company contributions. Forfeitures from nonvested participant accounts were \$7,341 and \$10,009 for the years ended December 31, 2024 and 2023, respectively. Forfeitures of \$4,648 and \$9,295 were utilized to reduce Company matching contributions during the years ended December 31, 2024 and 2023, respectively. Forfeitures of \$1,513 were used to pay administrative expenses during the year ended December 31, 2023. Other activity in the forfeiture account consisted of interest income.

The forfeiture account balance, which is included in investments on the statements of assets available for benefits, was \$4,456 and \$1,704 at December 31, 2024 and 2023, respectively.

*Administrative Expenses* - Administrative expenses are paid by the Company or the Plan as provided by the plan agreement; see Plan Expense Account description above. Participant loan and distribution charges are paid from the account of the participant taking the loan or distribution. Investment management fees are charged to participant accounts. The majority of the investment management fees are reflected as a component of net appreciation (depreciation) in fair value of investments rather than as administrative expenses in the statements of changes in assets available for benefits.

*Investment Valuation and Income Recognition* - Investments are carried at their fair values based on published quotations or, in the absence of readily ascertainable market values, at such values as the custodian determines. The net appreciation (depreciation) in fair value of investments is determined by the change in market value from the beginning of the year (or date of purchase, if purchased during the year) to the end of the year (or date of sale, if sold during the year). Gains and losses on securities sold or redeemed are determined on the basis of specific identification. Purchases and sales of securities are recorded on a trade-date basis. Interest, dividends and capital gain distributions are recorded as earned.

U.S. GAAP establishes a framework for measuring fair value of financial assets. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The Plan's investments in mutual funds are valued using quoted prices in an active market (Level 1).

This method may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the plan administrator believes the valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting dates.

The Plan's group annuity contract is reported at contract value, which is the relevant measurement attribute because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan (see Note 2). Because it is reported at contract value rather than fair value, the group annuity contract is not included in the fair value hierarchy.

There have been no changes in the valuation methodologies at December 31, 2024 or 2023.

*Investment Options* - Participants may direct their contributions, as well as employer contributions and any related earnings, into various investment options maintained by the custodian. Participants may change their investment options at any time.

*Notes Receivable from Participants* - The plan administrator may generally authorize a loan to a participant for an amount not to exceed the lesser of 50% of the vested balance of the participant's account or

\$50,000, as reduced by the highest outstanding participant loan balance in the prior twelve-month period. Loans must be at least \$1,000 and are secured by the balance in the participant's account. Loans bear interest at the prime rate on the origination date of the loan. At December 31, 2024 and 2023, the interest rate on outstanding loans ranged from 3.25% to 8.50%. Loans are generally required to be repaid over a five-year period in equal installments; however, the term of the loan may be extended if the intended use of the funds is to acquire a principal residence.

*Subsequent Events* - Management has evaluated subsequent events through September 22, 2025, the date which the financial statements were available to be issued.

## **2. GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY**

A portion of the Plan's assets are invested in the Empower Trust Company, LLC (Empower) Key Guaranteed Portfolio Fund, a general account group annuity contract, which the Plan has determined to be fully benefit-responsive with respect to participant-initiated transactions. Because the group annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute. Contract value represents contributions made under the contract, plus earnings using the interest crediting rate, less participant withdrawals and administrative expenses. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The interest crediting rate is reset quarterly. The average and actual yield earned by the Plan was 1.41% and 1.23% for the years ended December 31, 2024 and 2023, respectively.

Certain events limit the Plan's ability to transact at contract value with Empower. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the Employee Retirement Income Security Act of 1974. The plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are probable of not occurring.

The group annuity contract does not permit Empower to terminate the agreement prior to the scheduled maturity date.

### **3. INCOME TAX STATUS**

The Plan is a standardized, pre-approved plan for which the sponsoring organization obtained a favorable opinion letter as of November 14, 2022, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements. Management believes that there is no liability related to uncertain tax positions at December 31, 2024 or 2023. The Plan is no longer subject to tax examinations for years before December 31, 2021.

### **4. CERTIFIED FINANCIAL INFORMATION**

Empower, the custodian, has certified that the following data included in the accompanying financial statements is complete and accurate:

- Investments and notes receivable from participants, as shown in the statements of assets available for benefits, as of December 31, 2024 and 2023.
- Income on investments and notes receivable from participants, as shown in the statements of changes in assets available for benefits for the years ended December 31, 2024 and 2023.
- The schedule of assets held for investment purposes as of December 31, 2024, as shown on the accompanying schedule.

### **5. PLAN TERMINATION**

Although it has not expressed any intention to do so, the Company reserves the right under the Plan to discontinue its contributions at any time and to terminate the Plan. Any termination of the Plan cannot adversely affect the vested benefits accrued by the participants prior to the date of termination. The participants' interests in the Plan as of the date of the termination become fully vested and nonforfeitable.

### **6. RELATED PARTIES AND PARTIES-IN-INTEREST**

Empower serves as custodian of the Plan. Additionally, it is the issuer of the Key Guaranteed Portfolio Fund (see Note 2) and, accordingly, is considered a party-in-interest.

Neither the Company nor employees involved in the administration of the Plan receive compensation from the Plan.
