Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of Polaris 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

NOTE A – PLAN DESCRIPTION

The following description of the Polaris 401(k) Plan (the Plan) is provided for general information purposes only. More complete information regarding the Plan's provisions may be found in the plan document.

General

The Plan is a defined contribution plan established by Polaris Home Funding Corporation (the Company) under the provisions of Sections 401(a) and 401(k) of the Internal Revenue Code (IRC), for the benefit of eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

An employee is eligible to participate on the first day of the month following the date the employee attains age 21 and completes ninety days of qualified service.

Plan Contributions

Eligible participants may make voluntary contributions through salary reductions from 1 percent to 100 percent of their annual pre-tax compensation. The Plan also allows participants to defer funds into a “Roth 401(k) deferral”, which are subject to federal income taxes. These contributions combined are limited to the maximum amounts allowed under the provisions of the IRC (\$23,000 in 2024). Further, participants who are 50 years of age or older as of December 31, 2024 may contribute an additional “catch up” contribution (\$7,500 in 2024). Participants direct the investment of their contributions into various investment options offered by the Plan.

Employer contributions are made without regard to current or accumulated net income but are designed to qualify as a safe harbor match plan under the Internal Revenue Code. Plan contributions consist of the following:

- (a) A safe harbor matching contribution equal to 100 percent of the matched employee contributions that are not in excess of 3 percent of employee compensation plus 50 percent of the amount of matched employee contributions that exceed 3 percent of employee compensation but that do not exceed 5 percent of employee compensation. The Company may make safe harbor matching contributions in addition to the preceding. Safe harbor matching contributions are immediately 100 percent vested and non-forfeitable.

Plan Contributions – Continued

- (b) Employer discretionary contributions in an amount determined by the employer. Discretionary contributions are subject to vesting percentages based on years of service and are fully vested after 6 years. The discretionary contribution is allocated to each participant based on the ratio of each participant's compensation to the total compensation of all participants.

Contributions of no more than the lesser of \$69,000 (\$76,500, if eligible for a catch-up contribution) or 100 percent of an employee's taxable compensation may be contributed to the Plan in 2024. This limit is set by law and is subject to change each year for cost of living changes.

Participants' Accounts

Each participant's account is credited with their respective contribution and their allocation of (a) employer contributions and (b) Plan earnings and losses.

Benefits

Upon termination of service due to death, disability, or retirement, or upon reaching age 59 1/2 and continuing employment, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account. Employees are 100 percent vested in the part of their account resulting from elective deferral contributions, rollovers, and safe harbor matching contributions. For the remainder of the account, an employee becomes 20 percent vested after two years of service and is vested an additional 20 percent for each year of service thereafter or is immediately fully vested upon death, disability, retirement or attainment of normal retirement age while an employee.

Forfeitures

Forfeitures of non-vested participants' accounts as a result of ending employment may be used first to pay administrative expenses. Any remaining amount is deemed to be employer contribution.

Participant Loans

Participants may borrow a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50 percent of the present value of their vested account balances. The loans are secured by the balance in the participants' accounts and bear interest at rates which are commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest are paid through payroll deductions.

Plan Administration

The plan administrator and the custodian are appointed by the Company. The plan administrator is a Company employee, and John Hancock Life Insurance Company (U.S.A.) is the custodian.

Amendment and Termination of the Plan

The Company has the right to amend the Plan if it determines that it is necessary or desirable to do so. Further, the Company reserves the right to terminate the Plan. If the Plan is completely terminated, all participants will become fully vested in their accounts.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Investment Valuation

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's sponsor determines the Plan's valuation policies utilizing information provided by the investment advisors and custodian.

Realized gains and losses on investments sold and the unrealized appreciation and depreciation of investments held are reported on an average current cost basis, based on fair market value of the investments at the beginning of the Plan year or at the time of purchase during the Plan year. Purchases and sales of securities are recorded on a trade-date basis.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investment Valuation - Continued

Accounting standards provide a common definition of fair value and establish a framework to make the measurement of fair value in GAAP more consistent and comparable. Accounting standards also require expanded disclosures to provide information about the extent to which fair value is used to measure certain financial assets and liabilities, the methods and assumptions used to measure fair value, and the effect of fair value measures on earnings.

All investments of the Plan are stated at fair value. The plan reports its fair value measures using a three-level hierarchy that prioritizes the inputs used to measure fair value. This hierarchy, established by GAAP, requires that entities maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The three levels of inputs used to measure fair values are as follows:

- *Level 1* – Quoted prices for identical assets or liabilities in active markets to which the organization has access at the measurement date.
- *Level 2* – Inputs other than quoted prices included in level 1 that are observable for the asset or liability, either directly or indirectly.
- *Level 3* – Unobservable inputs for the asset or liability. Unobservable inputs should be used to measure the fair value to the extent that observable inputs are not available.

When available, the Plan measures fair value using level 1 inputs as they generally provide the most reliable evidence of fair value.

Administrative Expenses

The Company may, at its discretion, pay the expenses incident to administering the Plan. In the event that the Company does not pay Plan expenses, the expenses shall be paid by the Plan.

Reclassification

Certain amounts in the prior-year financial statements have been reclassified for comparative purposes to conform with the presentation in the current-year financial statements.

NOTE C – RELATED PARTY TRANSACTIONS

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

NOTE C – RELATED PARTY TRANSACTIONS (CONTINUED)

Certain Plan investments are pooled separate accounts managed by John Hancock Life Insurance Company (U.S.A.) (John Hancock). As John Hancock is the custodian of the Plan, recordkeeping and other administrative fees paid to John Hancock qualify as party-in-interest transactions, which are exempt from the prohibited transactions rules, as defined by ERISA.

NOTE D – INVESTMENTS

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Valued based on the published value of the underlying assets adjusted for distributions, reinvested dividends, and expenses. The net asset value (NAV) of the units of the accounts is used to determine fair value.

Common/collective trusts: Valued based on the underlying unit value of the assets held. The assets of the underlying fund are invested primarily in certain publicly traded bonds. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

The fair value methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E – TAX STATUS

The Plan has obtained its latest determination letter dated March 31, 2008, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code.

The plan administrator and management believe that the Plan was designed and is currently operated in compliance with the applicable provisions of the Internal Revenue Code, and they believe that the Plan was qualified and the related trust was tax-exempt through the year ended December 31, 2024.

Accounting principles generally accepted in the United States of America require the plan administrator and management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service.

The plan administrator and management have concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE F – CERTIFIED INFORMATION

The Company, acting in its capacity as the plan administrator, has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The investment assets, investment transactions and investment income presented in the Plan's financial statements and supplemental schedule was prepared by or derived from information prepared by John Hancock, the custodian of the Plan, and furnished to the Company. The Company has obtained a certification from the custodian as of December 31, 2024 and 2023, and for the year ended December 31, 2024, that such information is complete and accurate. The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

NOTE G – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

NOTE H – SUBSEQUENT EVENTS

Subsequent events have been evaluated through October 8, 2025, which is the date the financial statements were available to be issued. Events occurring after that date have not been evaluated to determine whether a change in the financial statements would be required.
