Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Kukurin Contracting, Inc. Prevailing Wage Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Kukurin Contracting, Inc. Prevailing Wage Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

NOTE 1 - PLAN DESCRIPTION

The following description of the Kukurin Contracting, Inc. Prevailing Wage Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan, as established on July 7, 1987, is a profit-sharing plan which is available to all eligible employees of Kukurin Contracting, Inc. (the “Company”). Employees must work on contracts governed by the Davis-Bacon Act or prevailing wage law and attain the age of 18 to be eligible. Eligible employees may become participants upon completion of a two-week probationary employment period along with meeting the minimum age requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Administrative Committee is responsible for the oversight of the Plan and determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Contributions

The employer makes contributions to the Plan in accordance with contracts subject to the Davis-Bacon Act or any other governmental prevailing wage contracts. Participants direct the investment of their contributions into various investment options offered by the Plan. The employer contribution amount is based on the hourly contribution rate that applies for each participant’s employment classification over the amount of Safe Harbor Matching Contributions made to the Kukurin Contracting, Inc. 401(k) Profit Sharing Plan on behalf of the participant. There is no employee voluntary or salary deferral contributions permitted under the Plan but transfer and rollover contributions are permitted. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant’s account is adjusted by the participant’s transfer and rollover contributions (if any), employer contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately and always fully vested in their transfer or rollover contributions, plus or minus actual earnings or losses thereon. Participants vest in accordance with the Plan in their respective employer contributed accounts. The Plan provides 100% vesting for a participant upon entering the Plan.

Notes Receivable from Participants

Participants may borrow a maximum from their fund accounts equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participants' accounts and bear interest at prime rate as defined. Principal and interest are paid ratably through weekly payroll deductions.

NOTE 1 - PLAN DESCRIPTION - CONTINUED

Payment of Benefits

Upon termination of service, distributions from the Plan will be made in a single lump-sum cash payment. The Plan provides that if your interest in the Plan is \$7,000 or less, a distribution will be made regardless of whether the participant or participant's spouse consents to the distribution. If the participant's interest in the Plan exceeds \$7,000, then the participant's consent is generally needed in order to make a distribution. Any amounts that were rolled over into the Plan will not be taken into account when determining the \$7,000 amount. In addition, the Plan allows for hardship distributions if certain criteria are met. In-service distributions are also permitted for participants that have attained age 59 ½.

Forfeiture

Any forfeited amounts can be used to restore forfeitures, reduce employer contributions, or to pay Plan expenses. Forfeited non-vested amounts totaled \$0 at December 31, 2024 and 2023. No forfeitures were used during the years ended December 31, 2024 and 2023.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract through June 28, 2024, which was reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from the employer are recorded in the year in which it is earned.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Expense Budget Account

The Expense Budget Account was established for the purpose of paying Plan expenses and is considered an unallocated Plan holding account. Per the Expense Budget Account Agreement, the amounts in the Expense Budget Account shall be invested in the existing Plan forfeiture account. The Expense Budget Account had a balance of \$1,084 and \$2,050 as of December 31, 2024 and 2023, respectively. The Expense Budget Account Agreement was established with Empower Trust Company, LLC. As the Plan changed service providers from Empower Trust Company, LLC to Capital Bank and Trust Company effective June 29, 2024, there has been no additional deposits into the Expense Budget Account since the change in service providers. The Plan will utilize the remaining account balance until liquidated.

The Expense Budget Account agreement stated that for each calendar quarter, Empower would pay to the Plan an "EBA Credit." EBA Credits were funded by revenue Empower received that exceeded its revenue requirements for the Plan. Total deposits in the form of EBA Credits to the account totaled \$21,376 and \$24,888 for the years ended December 31, 2024 and 2023, respectively. Total expenses paid from the account totaled \$22,439 and \$24,888 for the years ended December 31, 2024 and 2023, respectively. For each year the Plan's Expense Budget Account Agreement is in effect, the Plan may use the EBA Credits to pay reasonable Plan administrative expenses or allocate the EBA Credits among the accounts of the Plan participants. To the extent that the amount of qualified expenses for the applicable year is less than the amount held in the Expense Budget Account at the end of the year, the excess held in the account shall be considered a surplus. Any surplus remaining in the Expense Budget Account at the end of the year may be allocated to participant accounts in accordance with terms of the Plan and ERISA. No surplus amounts were reallocated back to participant accounts for the years ended December 31, 2024 and 2023.

Subsequent Events

The Plan has evaluated events through September 2, 2025, the date the financial statements were available to be issued.

NOTE 3 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money Market Fund - Valued at a stable \$1.00 per share which approximates fair value. The money market fund held by the Plan is actively traded.

NOTE 3 - FAIR VALUE MEASUREMENTS - CONTINUED

Collective Trust Fund - Valued at net asset value ("NAV") of units of a common collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) occur daily. At December 31, 2024, there were no unfunded commitments and investments are redeemable on a daily basis and without restriction.

NOTE 4 - RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Empower Trust Company, LLC served as the trustee of the Plan through June 28, 2024. Effective June 29, 2024, Capital Bank and Trust Company assumed the role of trustee. Plan assets are held in separate trust or custodial accounts maintained by each respective trustee. These services constitute party-in-interest transactions as defined under ERISA.

The Plan's investments are held by Capital Bank and Trust Company, the Plan's trustee as of June 29, 2024. Capital Bank and Trust Company is an affiliate of Capital Group, the investment manager of the American Funds mutual funds offered as investment options under the Plan. Because Capital Bank and Trust Company and Capital Group are affiliates, transactions involving investments in American Funds mutual funds are considered party-in-interest transactions under the Employee Retirement Income Security Act of 1974 ("ERISA").

During the year, the Plan invested in various American Funds mutual funds managed by Capital Group. The Plan also paid certain custodial and recordkeeping fees to Capital Bank and Trust Company, which may be paid either directly by the Plan or through revenue-sharing arrangements with the investment funds.

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

NOTE 6 - TAX STATUS

The Company has a Non-Standardized Pre-Approved Profit Sharing Plan with CODA sponsored by Empower Retirement LLC. The pre-approved profit sharing plan has received an opinion letter from the Internal Revenue Code (IRC) dated November 14, 2022, as to the pre-approved profit sharing plan's qualified status. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, and therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - CERTIFIED INVESTMENTS

Certain information in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held at December 31, 2024, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period June 29, 2024 through December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Capital Bank and Trust Company, the current trustee of the Plan.

Certain information in the accompanying financial statements, related to investments and notes receivable from participants held as of December 31, 2023, and net appreciation in the fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2023 and for the period January 1, 2024 through June 28, 2024 was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC, the prior trustee of the Plan. The contract value of the fixed income investment contract was certified by Empower Annuity Insurance Company of America.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9 - GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY

The Plan held an investment contract comprised of a fixed income account through June 28, 2024. This contract met the fully benefit-responsive investment contract criteria and therefore was reported at contract value. Contract value was the relevant measure for fully benefit-responsive investment contracts because this was the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represented contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

The fixed income account was provided through a Group Annuity Contract. Under the terms of the Group Annuity Contract, a crediting rate was established for amounts invested in the fixed account. Participants may direct permitted withdrawals and/or transfer transactions of all or a portion of their account balance at contract value.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts was dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may have been affected by future economic and regulatory developments.

Certain events limited the ability of the Plan to transact at contract value. Such events included, but were not limited to the following:

1. The complete or partial termination of the Plan.
2. The establishment or activation of, or material change in, any Plan investment fund, or an amendment to the Plan or a change in the administration or operation of the Plan, including the removal of a group of employees from Plan coverage as a result of the sale or liquidation of a subsidiary or division or as a result of group layoffs or early retirement programs.

No events were probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allowed the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

- An uncured violation of the Plan's investment guidelines.
- A breach of material obligation under the contract.
- A material misrepresentation.
- A material amendment to the agreements without the consent of the issuer.
