### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Disher Corp. Employee 401(k) and Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Disher Corp. Employee 401(k) and Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Disher Corp. Employee 401(k) and Profit Sharing Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Disher Corp. Employee 401(k) and Profit Sharing Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**NOTE A: DESCRIPTION OF PLAN**

The following description of the Disher Corp. (“Company”) Employee 401(k) and Profit Sharing Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General** - The Plan is a defined contribution plan covering substantially all employees of the Company who have attained age 20. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Plan management is responsible for oversight of the Plan, determining the appropriateness of the Plan’s investment offerings, and monitoring investment performance.

**Contributions** - For the years ended December 31, 2024 and 2023, participants were able to contribute up to 100% of their annual compensation, as defined in the Plan. Plan participants who have attained age 50 before the end of the year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation with automatic 1% increases annually on January 1 to a maximum deferral rate of 10%. The contributions of those who are automatically enrolled are invested in a designated balanced fund until changed by the participant.

The Company may also make a discretionary matching and profit sharing contribution each year. For the year ended December 31, 2024, the Company contributed a safe harbor matching contribution of 3% of plan compensation. For the year ended December 31, 2023 the Company made matching contribution of 50% of the first 4% of compensation that a participant contributed to the Plan. For the years ended December 31, 2024 and 2023 matching contributions totaled \$372,837 and \$202,422, respectively. The Company did not make profit sharing contributions for the years ended December 31, 2024 and 2023. Contributions are subject to certain limitations.

**Participant Accounts** - Each participant’s account is credited with the participant’s contribution, the Company’s contributions on behalf of the participant and an allocation of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting** - Participants are immediately vested in their contributions plus actual earnings thereon and any rollover contributions from other plans. Vesting in the Company’s contributions portion of their accounts plus actual earnings thereon is based on years of continuous service. Participants become 20% vested in the Company’s profit sharing and matching contributions after one year of service, and 20% each successive year through year five, at which time the participant is fully vested. A participant is also 100% vested in the Company’s profit sharing and matching contributions upon attainment of normal or early retirement age, upon retirement due to disability, or upon death. Forfeited balances of terminated participants’ non-vested accounts are allocated to remaining participants according to profit sharing and match contributions, used to reduce employer profit sharing or match contributions, or used to reduce Plan expenses at the discretion of the Plan administrator.

**NOTE A: DESCRIPTION OF PLAN (CONTINUED)**

**Notes Receivable from Participants** – Participants are eligible to borrow up to 50% of their vested account balance up to \$50,000. The loans are secured by the balance in the participant’s account. Loans are required to be repaid over a period not to exceed five years (longer for a purchase of a principal residence) and will bear interest at a fixed rate equal to 1% over the prime rate. Principal and interest are paid ratably through bi-weekly payroll deductions.

**Payment of Benefits** - On termination of service due to death, disability or retirement, or termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account either as a lump-sum distribution or annual installments over a period of years such that the minimum distributions requirement, as defined by the Plan, is met. The Plan also allows in-service distributions and “hardship” withdrawals for participants with immediate financial need.

**Forfeited Accounts** - At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$24,355 and \$3,604, respectively. Forfeitures are allocated to remaining participants according to profit sharing and match contributions, used to reduce employer profit sharing or match contributions, or used to reduce Plan expenses at the discretion of the Plan administrator. For the years ended December 31, 2024 and 2023, employer contributions were reduced by forfeited non-vested accounts by \$0 and \$38,448, respectively.

**NOTE B: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting** - The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates** - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan’s valuation policies utilizing information provided by investment advisers, custodians, and the insurance company. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments purchased and sold as well as held during the year.

**Notes Receivable from Participants** – Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**Excess Contributions** - Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributes excess contributions, if any, prior to March 15 of the following year.

**NOTE B: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**Contributions** – Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation

**Payment of Benefits** - Benefits are recorded when paid.

**Administrative Expenses** – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses.

**Subsequent Events** - Subsequent events were evaluated through September 30, 2025, which is the date the financial statements were available to be issued.

**Reclassification** – Certain prior year amounts have been reclassified to conform to the current year presentation.

**NOTE C: INFORMATION CERTIFIED BY CUSTODIAN (UNAUDITED)**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and investment income for the years then ended, was obtained by Plan management and agreed to or derived from information certified as complete and accurate by Ascensus Trust Company, a qualified institution.

**NOTE D: FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical asset or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - inputs to the valuation methodology include:

- quoted prices for similar assets and liabilities in active markets
- quoted prices for identical or similar assets or liabilities in inactive markets
- inputs other than quoted prices that are observable for the asset or liability
- inputs that are derived principally from or corroborated by observable market data by correlation or other means

**NOTE D: FAIR VALUE MEASUREMENTS (CONTINUED)**

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Cash equivalents:* Valued based on the closing price for underlying securities, reported on the active market on which underlying securities are traded. Cash and cash equivalents are classified in Level 2 of the fair value hierarchy.

*Collective investment trusts:* Valued using the net asset value (NAV) provided by the administrator of the fund. The NAV, as provided by the administrator, is used to estimate fair value. The NAV is based on the value of the underlying assets owned by the fund. Participant transactions (purchases and sales) may occur daily. Collective investment trusts are classified in Level 2 of the fair value hierarchy.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded and are classified in Level 1 of the fair value hierarchy.

**NOTE E: RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are held in mutual funds owned by Vanguard Investment Group. Ascensus Trust Company, a related entity to Vanguard Investment Group, provides custodian and record-keeping services for the Plan and, therefore, these transactions qualify as party-in-interest. Fees paid by the Plan for professional services rendered by parties-in-interest amounted to \$38,745 and \$38,552 in 2024 and 2023, respectively. The Plan has other service providers, and such parties are parties-in-interest under ERISA.

**NOTE F: PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the provisions of the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their employer contributions.

**NOTE G: REPORTABLE TRANSACTIONS**

In order to comply with the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974, it is necessary to provide a schedule of reportable transactions. However, for the year ended December 31, 2024, there were no reportable transactions, and accordingly, no schedule is provided.

**NOTE H: TAX STATUS**

The Plan is a prototype plan. The prototype plan has received a favorable opinion letter from the Internal Revenue Service that the plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

The Plan has been amended since receiving the favorable opinion letter. However, the plan administrator and the Plan's tax counsel believe the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United State of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE I: RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE J: PLAN AMENDMENTS**

Effective January 1, 2024, the Plan was amended to include an employer safe harbor matching contribution of no less than 3% of eligible compensation.

There were no other significant amendments adopted by the Plan for the years ended December 31, 2024 and 2023.
