INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and participants of the
Purchasing Power 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed an audit of the financial statements of the Purchasing Power 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) which comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements (the 2024 financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from a qualified institution as of December 31, 2024, and for the year then ended, stating that the certified investment information, as described in Note 3 to the 2024 financial statements is complete and accurate.

Opinion on the 2024 Financial Statements

In our opinion, based on our audit and the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section of the report,

- the amounts and disclosures in the accompanying 2024 financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying 2024 financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the 2024 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section of our report. We are required to be independent of the Plan and to meet our ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is responsible for maintaining a current Plan instrument, including all Plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the 2024 Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the 2024 financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is substantial likelihood that, individually or in the aggregate, they would influence the judgement made by a reasonable user based on the 2024 financial statements.

Our audit did not extend to the certified investment information except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the 2024 financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the 2024 financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – 2024 Supplemental Schedule Required by ERISA

The 2024 supplemental schedule, Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the 2024 financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the 2024 financial statements. The information included in the 2024 supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the 2024 financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the 2024 financial statements or to the 2024 financial statements themselves, and other additional procedures in accordance with GAAS. 1. Description of Plan

The following description of the Purchasing Power 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement, copies of which are available from the plan administrator, for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering eligible employees of Purchasing Power, LLC (the Company). All employees except those who are leased employees, nonresident aliens, or independent contractors are eligible to participate in the Plan. Employees become eligible to participate in the Plan on the first day of the month after attaining age 21 and 3 months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Eligible employees are automatically enrolled into the Plan, and pre-tax contributions are withheld at 6% of eligible compensation unless the employee elects differently. Under an automatic savings increase program, once an employee is automatically enrolled, the deferral percentage will automatically increase by 1% on an annual basis until the deferral percentage reaches 12%; however, eligible employees can opt out of the automatic increase program. Each participant may elect to make pre-tax and/or Roth contributions of up to 75% of eligible compensation as defined by the Plan document, not to exceed a maximum of \$23,000 in 2024, plus catch-up contributions of \$7,500 for those participants who are at least 50 years of age.

The Company may make a discretionary non-elective contribution as well as a discretionary matching contribution. The Company made a discretionary matching contribution equal to 50% of up to 6% of eligible compensation that a participant contributes to the Plan. No discretionary non-elective contributions were made during 2024.

Subsequent to year-end, the Plan discovered an error in the Plan related to the definition of compensation used in determining participant and discretionary matching contributions from 2020-2024. The Company has corrected this error and accrued the corrections as of December 31, 2024 as shown in the employer contributions receivable on the statement of net assets available for benefits.

Participant Accounts

Each participant's account is credited with the participant's contributions, rollovers, the Company's contributions, and earnings and losses on the investments in their account and is charged with participant transaction fees. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan also offers a self-directed brokerage account as an additional investment option for participants. As of December 31, 2024

and 2023, no participants have elected to enroll in the self-directed brokerage account. Participants may change their investment options on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and earnings and losses thereon. Participants vest in the discretionary matching and discretionary non-elective contributions at 25% per year beginning at the completion of their first year of service and each year thereafter and are fully vested after four years of service.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to a lesser of \$50,000 reduced by the highest outstanding note balance in the previous 12 months or 50% of the participant's vested account balance. A participant may have one note outstanding at any time. The notes are secured by the participant's account and bear interest at the Prime Rate plus 1.00%. During 2024, notes had fixed interest rates between 4.25% and 9.50% for their terms, not to exceed five years or an extended term length if used for the purchase of a principal residence. Principal and interest are paid through payroll deductions.

Payment of Benefits

At the time of death, disability, termination of service, or retirement, the participant or their beneficiary may receive payment of the vested interest in their account in a lump-sum amount, equal to the value of the participant's vested interest in their account or in installment payments. In-service withdrawals of all or part of the participant's vested account, are also permitted for participants who have attained age 59½. The participant's contributions may also be withdrawn for certain hardship situations. If a participant terminates employment and has an account balance less than \$200, the participant will automatically receive a lump-sum payment equal to the value of their account. If a participant terminates employment and has an account balance greater than \$200 but less than \$7,000, the participant's balance will be rolled over to an individual retirement plan account.

Forfeited Accounts

Forfeited non-vested accounts totaled \$90,169 and \$57,374 at December 31, 2024 and 2023, respectively. Forfeited amounts are included in the guaranteed investment contract on the statements of net assets available for benefits and may be used to reduce administrative expenses or to fund employer matching contributions. During 2024, \$25,197 of forfeitures were used to pay administrative expenses and \$122,093 of forfeitures were used to reduce employer contributions.

Administrative Expenses

Certain participant transaction fees are charged directly to the participant. These expenses are paid to a service provider of the Plan and therefore qualify as party-in-interest transactions. The Company pays all other administrative expenses not paid by participants or paid through forfeitures. The Company does not expect reimbursement from the Plan for any expenses paid on behalf of the Plan.

The Plan has an ERISA spending account where the qualified institution deposits revenue sharing payments that are used to pay certain Plan administrative expenses. During 2024, \$28,253 was deposited to the account and \$26,830 used to pay administrative expenses during the year. Deposits to this account are included in net change in fair value of investment in the accompanying statement of changes in net assets available for benefits. The account had a balance of \$6,275 and \$4,852 as of December 31, 2024 and 2023, respectively. Expenses are recorded in the year paid.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements have been prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Contributions

Participant contributions are considered payable to the Plan upon the withholding of contributions from the participant's paycheck. The discretionary matching contributions are considered payable to the Plan when the related participant's contributions are payable to the Plan and approved by the plan administrator. The discretionary non-elective contributions are considered payable to the Plan when approved by the plan administrator. Any unfunded participant or employer contribution would be included in the participant or employer contributions receivable on the statements of net assets available for benefits as of December 31, 2024 and 2023, if applicable.

In accordance with Financial Accounting Standards Board Accounting Standards Codification 326, *Financial Instruments—Credit Losses*, the Plan estimated the current credit risk associated with the employer receivables. After giving consideration to the risk characteristics, including

historical payment experience, the Plan determined that no allowance for credit loss was necessary and there was no current year activity in the allowance for credit losses.

Valuation of Investments and Recognition of Income

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Net change in fair value and contract value of investments includes interest, dividends, and realized and unrealized gains and losses and fees charged for investment and administrative services on those investments. Interest income is recorded when received.

Notes Receivable from Participants

Notes receivable from participants are carried at their outstanding balances. Interest income is recognized when received by the Plan. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make note repayments and the plan administrator deems the participant note to be in default, the participant note balance is reduced, and a benefit payment is recorded as a deemed distribution. Notes receivable from participants also qualify as party-in-interest transactions.

Payment of Benefits

Benefits are recorded when paid.

Reclassifications

Certain 2023 amounts have been reclassified to conform to the 2024 presentation. The effects of the reclassifications are not considered material to the financial statements taken as a whole.

Subsequent Events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 6, 2025, which is the date the financial statements were available to be issued.

3. Information Certified by the Qualified Institutions

All investment information in the accompanying financial statements and supplemental Schedule of Assets (Held at End of Year), including investments held and notes receivable from participants at December 31, 2024 and 2023, and net change in fair value and contract value of investments, and interest income for the year ended December 31, 2024, was obtained or derived

from information supplied to the plan administrator and certified as complete and accurate by Reliance Trust Company for 2024 and Transamerica Financial Life Insurance Company, Inc. (TFLIC) for 2023, the Plan's qualified institutions.

4. Investments

All Plan investments are managed by Transamerica Retirement Solutions LLC (Transamerica). Transamerica is an affiliate of the qualified institution of the Plan; therefore, transactions in these investments qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are netted with net changes in fair value of investments and net change in contract value of investments on the accompanying statement of changes in net assets available for benefits as they are paid through revenue sharing rather than as a direct payment.

Investments are exposed to various risks such as interest rate, market, currency, and credit risks. Market risks include U.S. and global events which could impact the value of Plan investments. Such events would include healthcare crises, such as a pandemic, international conflicts, supply chain disruptions, global monetary policy decisions, significant exogenous economic influences, and significant cybersecurity attacks, among others. It is at least reasonably possible that changes in their fair value will occur in the near term and that such changes could materially affect participants' account balances.

The Financial Accounting Standards Board established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three levels. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 – unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 – other observable data, including quoted prices for identical assets in inactive markets

Level 3 – unobservable inputs

Observable inputs are those based on market data obtained from sources independent of the Plan, and unobservable inputs reflect the Plan's own assumptions based on the best information available. The input levels are not necessarily an indication of the risk or liquidity associated with financial instruments at that level but rather the degree of judgment used in determining those values.

Following is a description of the valuation methodologies used for assets measured at fair value.

Investments in pooled separate accounts are valued daily using net asset value (NAV). The NAVs are based on the fair value of the underlying mutual funds, stocks, debt instruments, and other securities in the accounts. Participants can trade the pooled separate accounts daily at the published NAV, but the market is considered inactive, therefore, management has categorized them as Level 2.

The following table summarizes the Plan's investments carried at fair value based on the inputs used to determine their fair values as of December 31, 2024 and 2023:

The Plan has a fully benefit-responsive investment contract through the stable value core account issued by Transamerica. This is an investment based on the general unallocated account of Transamerica. Transamerica pays interest and guarantees the Plan's capital deposit regardless of the activity in the general account. The investment, as a deposit liability of Transamerica has no direct investments on behalf of the Plan. The investment value is based on the general unallocated account of Transamerica and the risk of investment is based on Transamerica's insurance ratings. The effective annual interest rate is established every six months. Interest is credited, based upon the daily balance, at a rate that is the daily equivalent of the effective annual rate of interest applicable for the six-month period.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Transamerica, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of the investment at contract value.

The contract does not have a maturity date and there are no contract provisions that require a distribution at contract value at any specified time. Although Plan participants may direct withdrawals at any time without restrictions, a hold can apply in the event the Company requests a full distribution from the investment. The Plan has no intention to request a full distribution at this time.

The Plan's ability to receive amounts due is dependent on Transamerica's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the Plan

to transact at contract value with the issuer. At this time, the plan administrator is not aware of any events that may limit the ability of the Plan to transact at contract value with the contract issuer or limit the ability of the Plan to transact at contract value with the participants.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their employer contributions.

6. Income Tax Status

The Plan is a non-standardized pre-approved profit sharing plan created by Transamerica. The Internal Revenue Service has determined and informed Transamerica by a letter dated June 30, 2020, that the non-standardized pre-approved profit sharing plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan's income tax returns for the past three years are subject to examination by taxing authorities and may change upon examination.
