## Note 1 - Plan Description

The following description of Winland Foods, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

### **General**

The Plan is a defined contribution plan covering all eligible employees of Winland Foods, Inc. and its participating wholly owned subsidiaries (collectively, the "Company"). The Plan does not cover employees who are at the former Pittsburgh location of TreeHouse Foods, Inc.; employees acquired in an asset or stock acquisition, merger, or similar transaction until coverage is extended to them; and special status employees. Employees covered by the Plan are eligible to participate immediately upon hire and enter upon employment commencement date.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

### **Contributions**

The Plan provides for employee salary deferral contributions and/or Roth contributions up to a maximum of 80 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants who have attained age 50 may make catch-up contributions in addition to their regular deferral contributions. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Company provides for employer safe harbor matching contributions of 100 percent of the participant's deferral contribution, not in excess of 5 percent of the participant's eligible compensation during the plan year.

For participants who were part of the transfer described above, the Company also makes quarterly nonelective fixed contributions for those that are part of the Local 688 Union and hired before June 1, 2010. The amount is dependent on the age range category that a participant falls in, as specified in the plan document.

### **Vesting**

All participants' contributions, safe harbor matching contributions, and nonelective employer contributions and related earnings are fully vested at all times and are not subject to forfeiture for any reason.

### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

### **Participant Notes Receivable**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of 50 percent of their vested account balances, not to exceed \$50,000, reduced by the highest outstanding balance of notes receivable during the one-year period prior to the date the notes receivable are made from the Plan or any existing loan balances on the date a new loan is made, whichever is greater. Notes receivable are collateralized by the participant's account balance, bear interest at a market rate, and are repaid ratably through payroll deductions.

## Note 1 - Plan Description (Continued)

### ***Benefit Payments***

Distributions are payable upon termination of service due to death, disability, or retirement in the form of lump-sum, partial, or installment amounts equal to the value of the vested balance of a participant's account. The Plan also allows for age 59½ withdrawals.

### ***Hardship Withdrawals***

Participants may request that a portion of their accounts, as permitted by the Plan, be distributed in the case of severe financial hardship, as defined in the plan document.

### ***Termination***

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA.

## Note 2 - Summary of Significant Accounting Policies

### ***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value.

The common/collective trust funds are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying net assets. There are no redemption restrictions or unfunded commitments on these investments. All other investments are valued based on quoted market prices reported in active markets. See Note 5 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

### ***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

### ***Benefit Payments***

Benefits are recorded when paid.

### ***Administrative Expenses***

Various administrative costs are paid by the Plan and the Company.

### ***Use of Estimates***

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain amounts and disclosures at the date of the financial statements and during the reporting period. Actual results could differ from those estimates.

### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

## Note 2 - Summary of Significant Accounting Policies (Continued)

### *Subsequent Events*

The financial statements and related disclosures include evaluation of events up through and including October 2, 2025, which is the date the financial statements were available to be issued.

Winland Foods, Inc. 401(k) Plan was restated effective January 1, 2025, which incorporated SECURE Act 2.0 provisions to allow automatic enrollment for all new hires starting at 3 percent, increasing by 1 percent annually up to 10 percent.

Effective March 2025, participants and related account balances of \$5,135,000 related to the Atlanta facility were transferred out of the Plan.

## Note 3 - Certified Information

Empower Trust Company, LLC (the "Trustee") holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

## Note 4 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

## Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

### *Level 1*

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

### *Level 2*

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

### *Level 3*

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
