Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of C & C Sales, Inc. Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF THE PLAN

The following description of the C & C Sales, Inc. Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan covering eligible employees of C & C Sales, Inc. (the "Company"). Employees become participants in the Plan if they have attained the age of 21 and complete 45 days of service. Employees may enter the Plan on the first day of the month following the date on which the eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Empower Trust Company, LLC ("Empower") serves as the custodian of the mutual funds and the common collective trusts. Putnam Investor Services, Inc. serves as the Plan's recordkeeper. Putnam Fiduciary Trust Company serves as the Plan's trustee. Northwestern Mutual Life Insurance Company ("Northwestern Mutual") serves as custodian of the life insurance policy.

Plan Amendment – The Plan was amended effective July 1, 2024, to change the eligibility requirements for the Plan. Effective July 1, 2024, employees become participants in the Plan if they have attained the age of 21 and completed 45 days of service. Employees may enter the Plan on the first day of the month following the date on which the eligibility requirements are met.

Contributions – Participants may contribute up to 100% of eligible compensation subject to Internal Revenue Code ("IRC") limitations. The Plan has an automatic enrollment feature. New employees are automatically enrolled in the Plan, and contribute 5% of their eligible wages, unless the employee opts out of participation, or chooses a different deferral rate. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Company may make discretionary matching contributions to contributing employees. For 2024, the Company made discretionary matching contributions of 50% of elective deferrals contributed, up to a maximum of \$4,000 of elective deferrals matched. The maximum discretionary matching contribution for each participant is \$2,000. The Company's discretionary match of \$230,477 was paid subsequent to year end. The Company may also make a discretionary profit sharing contribution. No such contribution was made in 2024.

Participant Accounts – Each participant's account is credited with the participant's contribution and an allocation of (a) Company contributions and (b) Plan earnings or losses, less distributions and expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investments – Participants direct their contributions into various mutual funds or common collective trusts. Previously, participants could invest in life insurance. Any existing policies remain in force, but no new policies may be issued.

Vesting – Participants are 100% vested at all times in both employer and participant contributions.

Forfeitures – Forfeited balances of terminated participants' nonvested accounts are used to reduce future Company contributions. The balance in forfeitures at December 31, 2024 and 2023, was \$2,742 and \$2,639, respectively. No forfeitures were used in 2024.

Notes Receivable from Participants – Participants may obtain a Plan loan for no less than \$1,000 and no more than the lesser of \$50,000 or one-half the employee's account balance. Participant loans may be repaid over a term of up to five years, unless the proceeds are used for a home purchase, which may be repaid over 10 years, in accordance with Plan provisions. A participant may not have more than two loans outstanding at any given time.

Participant loans are drawn from participant account balances. Interest charged on loans is established at 1% over the Prime Rate published in the *Wall Street Journal* on the first business day of the month before a loan is originated. Principal and interest payments are made by the participants through payroll deductions. A participant is charged \$50 for the initial loan set-up. Delinquent loans from participants are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits – Upon termination of employment, the participant, or in the case of death, the participant's beneficiary, will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. In the event the participants account balance is less than \$1,000, the account is subject to involuntary distribution.

In-Service Withdrawals – Certain participants may make withdrawals prior to termination of employment. Hardship withdrawals are available to Plan participants, as defined by the Plan Document and permitted by the IRC. Hardship withdrawals are limited to the participant's account balance.

Administrative Expenses – Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Certain other administrative expenses are paid directly by the Plan.

Other Income – A revenue sharing agreement is in place whereby fees earned by the mutual fund companies are shared with the recordkeeper based upon a percentage of assets under management. These amounts are used for the benefit of the Plan to pay administrative expenses. During 2024, \$35,127 was received by the Plan under this revenue sharing agreement. As of December 31, 2024 and 2023, the revenue sharing account had a balance of \$0.

Termination of the Plan – Although the Company has not expressed any intent to do so, it has the right to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, all participants will become fully vested in their account balances.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The financial statements and supplemental schedule of the Plan are prepared under the accrual basis of accounting in accordance with accounting practices generally accepted in the United States of America.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Contributions – Company and employee contributions are reported in the year services are rendered to the Company by the Plan participants.

Investment Valuation and Income Recognition – The Plan’s investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

A portion of the management fees and operating expenses charged to the Plan for investments in mutual funds and common collective trusts are deducted from income earned on a daily basis and are not separately reflected. Consequently, a portion of management fees and operating expenses are reflected as a reduction of investment return for such investments.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance is considered necessary.

Excess Refundable Contributions – Amounts payable to participants for contributions in excess of amounts allowed by the IRC are recorded as a liability with a corresponding reduction to contributions.

Payment of Benefits – Benefit payments are reported in the year of payment.

Date of Management’s Review – Management has evaluated subsequent events through September 28, 2025, the date the financial statements were available to be issued, and there were no material events requiring recognition or disclosure.

3. FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The hierarchy consists of three broad levels, described as follows:

Level 1 – Inputs consist of unadjusted quoted prices for identical assets in active markets that the plan has the ability to access.

Level 2 – Inputs consist of 1) quoted prices for similar assets in active markets, 2) quoted prices for identical or similar assets in inactive markets, 3) inputs other than quoted prices that are observable, and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term.

Level 3 – Inputs consist of unobservable inputs where there is little or no market activity, and the reporting entity makes estimates and assumptions related to the pricing of the asset including assumptions regarding risk.

The assets fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual Funds – Valued at the published net asset value (“NAV”) of shares held by the plan at year end.

Common Collective Trusts – Valued at the NAV of units of a bank collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimated fair value. The NAV is based on the fair value of the underlying investments held in the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Life Insurance Policy – Valued at the cash surrender value, as provided by Northwestern Mutual.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. The Plan’s investments are reported at fair value as follows at December 31, 2024 and 2023:

(a) Certain investments are measured at fair value based on the NAV per share practical expedient at December 31, 2024 and 2023. These investments have not been classified in the fair value heirarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value heirarchy to the line items presented in the statement of net

assets available for benefits. These investments are valued daily, may be redeemed daily without restrictions, and with no notice requirements. Additionally, there are no unfunded commitments.

4. RISKS AND UNCERTAINTIES

The Plan invests in investment securities, which hold securities including U.S. Government securities, corporate debt instruments, and corporate stocks. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

5. INFORMATION CERTIFIED BY CUSTODIAN

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC, one of the custodians of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments as of December 31, 2024 and 2023, and for the year ended December 31, 2024:

- Investments, at fair value (excluding Life Insurance)
- Net appreciation in fair value of investments (excluding Life Insurance)
- Interest and dividend income (excluding Life Insurance)
- Notes receivable from participants and related interest income
- Schedule of Assets (Held at End of Year) (excluding Life Insurance)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

6. TAX STATUS

The Company adopted a Prototype Non-Standardized Profit-Sharing Plan with CODA which received a favorable opinion letter from the IRS on June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Company believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that, therefore, the Plan qualifies under Section 401(a) and the related trust is tax-exempt as of December 31, 2024. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Generally accepted accounting principles requires Plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments include mutual funds and collective investment trusts managed by Putnam Fiduciary Trust Company, and an insurance policy managed by Northwestern Mutual. Putnam is the trustee of the Plan, and Northwestern Mutual is a custodian as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions.

The Plan pays certain fees to Putnam to administer the Plan. These transactions qualify as party-in-interest. Notes receivable from participants are party-in-interest transactions.
