INDEPENDENT AUDITOR'S REPORT

To the Participants and Plan Administrator of the Broadcom U.S. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of the Broadcom U.S. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements ("2024 Financial Statements").

Plan management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 Financial Statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Plan management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the 2024 Financial Statements* section:

- the amounts and disclosures in the 2024 Financial Statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the 2024 Financial Statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that Plan management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the 2024 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the 2024 Financial Statements* section of our report. We are required to be independent of the Broadcom U.S. 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Plan Management for the Financial Statements

Plan management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Plan management's election of the ERISA Section 103(a)(3)(C) audit does not affect Plan management's responsibility for the financial statements.

In preparing the financial statements, Plan management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Broadcom U.S. 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Plan management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the 2024 Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Broadcom U.S. 401(k) Plan Notes to Financial Statements

NOTE 1 – DESCRIPTION OF PLAN

The following description of the Broadcom U.S. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General – The Plan is a qualified defined contribution plan sponsored by Avago Technologies U.S. Inc., a Broadcom Inc. company, (the “Company”) covering all employees of the Company, except leased employees, employees who are covered by a collective bargaining agreement, residents of Puerto Rico, nonresident aliens who receive no earned income from the Company within the United States, and employees who do not appear on the United States payroll of the Company. An eligible employee may participate in the Plan as of the entry date, as defined in the Plan document, after completing one hour of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

The Company has appointed the Benefits and Investment Committee (the “Committee”) to manage the operation and administration of the Plan. The Company has appointed Fidelity Management Trust Company (“Fidelity”) to act as the trustee and custodian of the Plan assets.

Effective April 1, 2024, the Plan was amended to merge the VMware Inc. 401(k) Savings Plan and related trust with and into the Plan and the Plan’s related trust, with the Plan and the Plan’s related trust being the surviving plan and trust (See Note 10). As a result, net plan assets of \$4,080,343,222 were transferred from the VMware Inc. 401(k) Savings Plan to the Plan.

Contributions

Participant contributions – Eligible participants are automatically enrolled at a 6% pre-tax contribution rate unless they elect otherwise. A 1% automatic increase to participant’s salary deferral contribution percentage is applied on the first pay period after each July 1st of each Plan year, until the participant’s contribution percentage reaches the maximum of 10%, unless elected otherwise. Participants may elect to contribute up to 90% of their compensation to the Plan, subject to the limits of the Internal Revenue Code (the “Code”) (\$23,000 for 2024). Participants may request changes in their contribution percentages and in their allocation of investment funds at any time.

Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions subject to the limits of the Code (\$7,500 for 2024).

Participants may also elect to defer Roth 401(k) contributions and after-tax contributions. Roth 401(k) contributions and after-tax contributions are subject to the same Plan limits and tax law limits applicable to pre-tax deferral contributions. Participant contributions are deposited in the appropriate investment funds in accordance with the participant’s direction and the Plan’s provisions.

Participants are also permitted to make rollover contributions of amounts received from other qualified employer-sponsored retirement plans.

Employer match contributions – The Company makes non-discretionary matching contributions in an amount equal to 100% of each participant’s pre-tax and Roth contributions, including catch-up contributions, up to the first 6% of the participant’s eligible compensation.

The Company may make additional discretionary nonelective contributions, subject to Internal Revenue Service ("IRS") limitations. The Company did not make any discretionary nonelective contributions during the year ended December 31, 2024.

Participant accounts – Upon enrollment, participants can elect various investment options provided by the Plan. Participants may change their investment elections at any time. Participant and employer contributions, unless otherwise elected by the participant, are automatically invested in the qualified default investment alternative which is a target date investment based on based on the participant's age.

Each participant's accounts is credited with the participant contributions, the Company's non-discretionary matching contributions, as well as allocation of the Company's discretionary nonelective contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are immediately vested in their contributions and employer contributions plus actual earnings thereon. Prior to November 33, 2024, certain historical vesting schedules remained in place for accounts transferred from merged plans, as defined in the Plan document. Effective November 22, 2024, all accounts that were less than 100% vested were fully vested (See Note 10).

Notes receivable from participants – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loan terms range up to 5 years or up to 15 years for the purchase of a primary residence. Participants may not have more than two loans outstanding at any time. The loans are secured by the balance in the participant's accounts. The loan interest rate, determined monthly, is set at the prime rate plus 1%, as established by the Plan administrator. Principal and interest is paid ratably through payroll deductions. At December 31, 2024, notes receivables from participants carried an interest rate range of 4.25% to 9.50%, maturing through December 2039.

Payment of benefits – Upon termination of service due to severance of employment, death, disability, or retirement, a participant may elect to receive either a lump sum amount, installments or partial payments equal to the vested value of the participant's account. Should an election not be received, the Plan will distribute balances of less than \$1,000 in lump-sum distributions. Balances over \$1,000 but less than \$5,000, unless specified by the terminated participants, will be paid to the participants in a direct rollover to an individual retirement plan designated by the plan administrator. In-service distributions are available in limited circumstances, as defined in the Plan document.

Forfeitures – At December 31, 2024 and 2023, forfeited amounts totaled approximately \$4,643,000 and \$1,050,000, respectively. These accounts may be used to reduce future employer contributions. In 2024, \$1,244,000 of forfeitures were used to reduce employer contributions.

Revenue credit payments – Fidelity, the trustee, may receive revenue sharing payments from registered investment companies and common/collective trusts in which the Plan invests. To the extent revenue sharing payments are received by the trustee, a Plan account will be established to receive these amounts which are to be used to pay administrative expenses. If such amounts remain after the payment of administrative expenses, the plan administrator is to allocate such amounts to participants as additional earnings of the Plan.

At December 31, 2024 and 2023, the unallocated balances of revenue sharing amounts were approximately \$1,377,000 and \$351,000, respectively. During 2024, the Plan received approximately \$1,019,000 of revenue credits, which is included in net appreciation in fair value of investments in the accompanying statement of changes in net assets available for benefits. During 2024, approximately \$32,000 of revenue credits were used to pay Plan's administrative expenses.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting – The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of estimates – The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition – The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Contributions – Contributions from Plan participants and the employer non-discretionary matching contributions are recorded in the year in which the employee contributions are withheld from compensation. Discretionary nonelective employer contributions, if any, are recorded in the year in which the related participant compensation is earned.

Payment of benefits – Benefits are recorded when paid.

Administrative Expenses – A portion of the Plan's administrative expenses are paid by the Company. Expenses paid by the Company are not included in these financial statements. Fees related to the administration of notes receivable and distributions from participants are charged directly to the participants' accounts and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies – Valued at the daily closing price as reported by the fund. Registered investment companies assets held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The registered investment companies assets held by the Plan are deemed to be actively traded.

Money market funds – Valued at a quoted price which represents the net asset value ("NAV") of shares held by the Plan at year end. The quoted price is considered a Level 1 input.

Self-directed brokerage accounts – Consist of common and preferred stocks, exchange traded funds, options, mutual funds, and units of investments purchased on the open market. These investments are valued on the basis of readily determinable market prices and considered Level 1 investments. Stocks, exchange traded funds and options are valued at the closing price reported on the active market in which the individual securities are traded. Mutual funds and units are valued at NAV of shares held by the Plan at year end. The account also includes corporate bonds, U.S. government securities, and certificates of deposit which use significant inputs, including benchmarks, yields, broker-dealer quotes, issuer spreads, bids, offers and measures of volatility, obtained by third-party dealers or independent pricing services to determine fair values and are classified within Level 2.

Common stock – Valued at the closing price reported on the active market on which the individual securities are traded.

Common/collective trusts: Units held in common/collective trusts (CCT) are valued using the NAV practical expedient of the CCT as reported by the CCT managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the CCT, minus its liabilities, and then divided by the number of units outstanding. The NAV practical expedient of a CCT is calculated based on a compilation of primarily observable market information. The CCTs may be redeemed daily.

Stable value fund: The stable value fund (also a CCT) is composed primarily of fully benefit-responsive investment contracts and is valued using the NAV practical expedient, an estimate of fair value. This NAV practical expedient would not be used if it is determined to be probable that the Plan will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily at NAV. If the Plan initiates a full redemption of the trust, the issuer reserves the right to require 12 months notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(*) In accordance with Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") Subtopic 820-10, certain investments that were measured at NAV as a practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statements of net assets available for benefits.

NOTE 4 – TAX STATUS

The Internal Revenue Service ("IRS") has determined and informed the Company by a letter dated April 19, 2016, that the Plan and related trust are designed in accordance with applicable sections of the Code. Although, the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and, therefore, believe that the Plan is qualified, and the related trust is tax- exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 5 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect participants' account balances and amounts reported in the statement of net assets available for benefits.

NOTE 6 – INFORMATION CERTIFIED BY THE TRUSTEE

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, the trustee of the Plan, has certified to the completeness and accuracy of:

- Investments, at fair value, notes receivable from participants and non-interest bearing cash, as reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023
- Net appreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- The information for all investments and participant loans listed in the schedule of assets (held at end of year) as of December 31, 2024, as shown in the ERISA-required supplemental schedule.

NOTE 7 – RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by an affiliate of Fidelity. Fidelity is the trustee for the Plan and, therefore, these transactions qualify as party-in-interest transactions. The Plan paid administrative expenses to Fidelity totaling approximately \$2,834,000 during the year ended December 31, 2024. The Plan extends loans to participants who are considered parties-in-interest; therefore, these transactions qualify as party-in-interest transactions.

The Plan includes a self-directed brokerage account (“brokerage accounts”) option through Fidelity. Included in the brokerage accounts are investments in common stocks of Broadcom Inc. at December 31, 2024 and 2023, totaling approximately \$0 and \$285,000, respectively.

NOTE 8 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will be entitled to receive the full value of their individual participant accounts.

NOTE 9 – RECONCILIATION TO FORM 5500

The Form 5500 has certain items that differ from amounts shown on the accompanying financial statements. These differences related to classification only and have no effect upon net assets available for benefits for either period.

NOTE 10 – PLAN AMENDMENTS

Effective January 1, 2024, the Plan was amended to permit rollover contributions to the VMware Inc. 401(k) Savings Plan between January 1, 2024 and April 1, 2024.

Effective April 1, 2024, the VMware Inc. 401(k) Savings Plan and related trust was merged with and into the Plan and the Plan’s related trust, with the Plan and the Plan’s related trust being the surviving plan and trust.

Effective July 1, 2024, the Plan was amended to allow participants affected by the divestiture of the End User Computing division to have their outstanding loans treated as eligible rollover distributions to the plan of the purchaser of the End User Computing division.

Effective November 22, 2024, all accounts that were less than 100% vested were fully vested.

NOTE 11 – SUBSEQUENT EVENTS

During 2025, the Plan changed service providers from Fidelity Management Trust Company to Charles Schwab Trust Bank. This change in service providers initiated a “Black Out” period beginning March 3, 2025 and continuing through the week of March 23, 2025. During this period, participants’ plan accounts were not available for investment fund exchanges and distribution requests. During the “Black Out” period, funds were transferred to the new service provider and were invested into investment options with similar strategies to those previously available.

The Plan has evaluated subsequent events through October 9, 2025, the date that these financial statements were available for issuance.
