**NOTE 1 – DESCRIPTION OF PLAN**

The following description of the North Cobb Christian School (“School”) 403(b) Plan (“Plan”) provides general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering employees of the School. Eligible employees of the School who have attained age 18 are able to enroll in the Plan on their hire date. Employees are eligible to receive employer contributions after attaining age 18 and one year of service with a minimum of 1,000 hours of service. The Plan was originally adopted on September 1, 2000 and restated on April 1, 2020. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The School is the Plan Administrator.

Contributions

Each year, participants may contribute pre-tax annual compensation, as defined in the Plan, and participants may make Roth contributions. Participants who have attained age 50 by the end of the plan year are eligible to make catch-up contributions. Transfers from qualified plans (and rollovers) are allowed. The School will provide a 100% matching contribution for the first 2% and a 50% matching contribution on the next 2% of compensation deferred by eligible employees. Contributions are subject to certain limitations.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) the School’s matching contribution and, (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations of earnings are based on actual investment experience of individual accounts. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment Options

Upon enrollment in the Plan, a participant may direct employee contributions in any investment options offered by the Plan. Participants may change their investment options as often as they desire.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon and the School’s matching contribution portion of their accounts plus actual earnings thereon.

**NOTE 1 – DESCRIPTION OF PLAN (CONTINUED)**

Notes receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from 1-5 years. Loans are secured by the balance in the participant's account and bear interest at a rate commensurate with rates of prime plus 2%. Generally, loans are to be repaid on the basis of substantially level amortization over the term of the loan with payments made through salary reduction each pay period. Additional loan payments may be made through salary reduction.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or installments under a variety of annuity forms available for election by the participant or beneficiary. Additionally, if the vested account is \$5,000 or less, the vested account will be paid in a lump-sum.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value (not including investments in fully benefit-responsive insurance contracts, more fully described in Note 5). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for a further discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

Contributions

Contributions from Plan participants and the matching contributions from the School are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expense and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the School. Expenses that are paid by the School are excluded from these financial statements. Fees related to the administration of the notes receivable from participants are charged directly to the participant's account and are included in the administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by American United Life Insurance Company ("OneAmerica") and Teachers Insurance and Annuity Association of America ("TIAA") (the custodians of the Plan). This information has not been audited by the Plan's independent auditors.

**NOTE 4 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 5 – INSURANCE CONTRACTS WITH INSURANCE COMPANY**

The following contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the custodians, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

In 2000, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with TIAA CREF (TIAA). TIAA maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 3%. The crediting rate is reviewed on an annual basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. As of December 31, 2024 and 2023, the contract value was \$104,686 and \$121,706, respectively.

In 2020, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with OneAmerica Financial Partners, Inc. (OneAmerica). OneAmerica maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 0%. The crediting rate is reviewed on an annual basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. As of December 31, 2024 and 2023, the contract value was \$71,249 and \$58,822, respectively.

In 2023, the Plan converted a traditional fully benefit-responsive guaranteed investment contract with TIAA CREF (TIAA) to an ERISA Section 103(a)(3)(C) investment. TIAA maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 3%. The crediting rate is reviewed on an annual basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. The contract value was \$111,052 and \$127,627 as of December 31, 2024 and 2023, respectively.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

**NOTE 6 – FAIR VALUE MEASUREMENTS**

The Plan utilizes Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements. FASB ASC 820 establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of the three broad levels: Level 1 inputs consists of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs are unobservable and have the lowest priority. The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include: a) quoted prices for similar assets or liabilities in active markets; b) quoted prices for identical or similar assets or liabilities in inactive markets; c) inputs other than quoted prices that are observable for the asset or liability; d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled Separate Accounts:* As of December 31, 2024, pooled separate accounts were valued by using the net asset value (NAV) of the funds held by the Plan at year-end as a practical expedient. The NAV is determined by the custodian of the fund and is based upon the fair value of the underlying assets held by the fund. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan. As of December 31, 2023, these investments were traded and valued daily using their NAV at level 2.

*Variable Annuities:* Valued based on the performance of the underlying investment options.

**NOTE 7 – TAX STATUS**

The Plan sponsor adopted a simplified ERISA volume submitter 403(b) plan which received a favorable opinion letter from the Internal Revenue Service dated November 22, 2017, which states the Plan is designed in accordance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the volume submitter, the Plan administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

**NOTE 7 – TAX STATUS (CONTINUED)**

U.S. GAAP require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by the Plan’s custodians, OneAmerica and TIAA-CREFF, and, therefore, these transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rule under ERISA. Notes receivable from participants are also defined by ERISA as party-in-interest transactions.

**NOTE 9 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the School has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

**NOTE 11 – OPERATIONAL ISSUES**

During 2024, Nichols Cauley noted the exclusion of eligible compensation for one participant. The exclusion of eligible compensation caused the participant to have missed deferrals for the plan year ending December 31, 2024. The missed deferrals resulted in lost earnings and interest for the participant. As of the report date, the School is working with Paycom, the payroll provider, to determine if other participants were affected and working with OneAmerica to determine the corrective action needed related to the exclusion of eligible compensation and missed deferrals.

**NOTE 12 – SUBSEQUENT EVENTS**

Management has evaluated subsequent events through September 19, 2025, the date these financial statements were available to be issued. The Securing a Strong Retirement Act of 2022 (SECURE 2.0 Act) was signed into law on December 29, 2022, and includes mandatory and optional provisions with varying dates in 2025 and later. The Plan Administrator will determine the optional provisions to elect and amend the Plan document accordingly. No other events have occurred that would require adjustment to or disclosure in the financial statements which were available to be issued on September 19, 2025.
