Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of The Springs Company 401(K) Savings and Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of The Springs Company 401(K) Savings and Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. NOTE 1: DESCRIPTION OF THE PLAN

The following description of The Springs Company 401(K) Savings and Retirement Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan was established effective July 1, 1997, and is a defined contribution plan which covers substantially all employees of The Springs Company, Inc., who are at least 21 years of age and have completed one year of service. The Plan is subject to other provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Each year, participants may contribute up to 50% of pretax annual compensation which includes overtime, bonuses and commissions, subject to the dollar limit set by law. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company will match, annually, 100% of the participant’s contribution up to a maximum of 4% of compensation. The employees’ and the Company’s contributions are made each pay period and are invested as directed by the Plan participants.

Upon enrollment in the Plan, a participant may direct employer and employee contributions in any of the Plan’s fund options. Participants may change their investment options at any time. Participant forfeitures are used to reduce employer matching contributions and nonelective contributions for the plan year immediately following the plan year in which the forfeiture occurs.

Participant accounts and vesting

Each participant’s account is credited with contributions and Plan earnings in the following manner:

Employer Account: Amounts credited to the employer account consist of the Company’s monthly contributions and proportionate allocation of investment earnings (losses) based on each participant’s weighted average monthly account balance.

NOTE 1: DESCRIPTION OF THE PLAN (CONTINUED)

Participant accounts and vesting (Continued)

Amounts credited to the employer account are immediately vested if the participant has met the Plan eligibility and accrual tests. Full vesting occurs upon a participant's retirement or death, regardless of years of credited service.

Contribution Account: Voluntary contributions by participants and investment earnings (losses) which are allocated proportionately based on the participant's weighted average monthly account balance are credited to the contribution account and are immediately vested.

Vested benefits are paid as follows:

Employer account: Upon retirement at normal age 65, death, or termination of employment provided that the participant has incurred a one-year break in service.

Contribution account: Participant contributions are 100% vested on the date of enrollment. Vested benefits are payable on retirement, disability, death or termination on an installment or lump sum basis. Loans and hardship withdrawals may be made at the discretion of the Advisory Committee in accordance with the loan and/or hardship distribution policy under the plan. In-service distributions are allowed under certain Plan provisions.

Participant loans

Participants may borrow from their fund account a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance. Loan terms range from 1-5 years or longer for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local rates as determined by the Advisory Committee. The Advisory Committee must reevaluate interest rates for loans made more than one month since the last loan made by the Plan. Interest will be charged at a reasonable rate. Principal and interest are paid ratably through payroll deductions.

Payment of benefits

Upon termination of service, or upon death, disability or retirement, a participant may receive an amount equal to the vested value of his or her account payable on an installment or lump sum basis.

If vested benefits exceed \$5,000 (excluding amounts attributable to rollovers), the participant can elect how to receive benefits. Account balances under \$5,000 will be paid out within a reasonable time after termination of employment.

Plan termination

Although it has not expressed any intent to do so, the Company retains the right under the Plan to discontinue employer contributions at any time and terminate the Plan. In the event of a termination of the Plan, participants are immediately 100% vested in their account.

NOTE 2: SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of estimates

The preparation of the financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and the accompanying notes. Such estimates and assumptions could change in the future as more information becomes known, which could impact the amounts reported and disclosed herein.

Investment valuation and income recognition

The Plan's investments are stated at fair market value. Shares of registered investment companies and common collective trust funds are valued at quoted market prices which represent the net asset value of shares held by the Plan at year end. The participant loans are valued at their outstanding balances, which approximate fair value.

Purchases and sales of securities are recorded on a trade-date basis.

Payment of benefits

Benefits are recorded when paid.

Subsequent events

Management has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.

NOTE 3: INVESTMENTS

Principal Trust Company, trustee of the Plan's assets, holds the Plan's investment assets and executes transactions thereon. All investment information disclosed in the accompanying financial statements and schedule, including investments held at December 31, 2024 and 2023, investment income and net appreciation in fair value of investments for the years then ended, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by the trustee.

For the years ended December 31, 2024 and 2023, the Plan's investment assets (including investments bought, sold, as well as held during the period) appreciated (depreciated) in fair value by \$1,839,529 and \$2,089,883 respectively.

NOTE 4: RELATED PARTY TRANSACTIONS

Certain plan investments are shares of mutual funds managed by Principal Trust Company. Principal Trust Company is the trustee as defined by the Plan, and, therefore, these transactions qualify as party-in-interest. Fees paid by the Plan for the investment management services amounted to \$37,570 and \$34,712 for the years ended December 31, 2024 and 2023, respectively. The Plan Sponsor has elected to pay substantially all of the administrative expenses incurred by the Plan.

NOTE 5: INCOME TAX STATUS

The Plan has received a determination letter from the Internal Revenue Service dated March 31, 2014, stating that the Plan qualifies under Section 401(a) of the Internal Revenue Code (Code), and therefore, the Plan is exempt from taxation under present income tax law. Once qualified, the Plan is required to operate in conformity with the code to maintain its qualification. The Plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by the Internal Revenue Service; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to the year ended December 31, 2021.

NOTE 6: OTHER MATTERS

Effective January 1, 2007, the Plan was amended to allow all employees who are not eligible to participate in the Noncontributory Pension Plan, who meet the eligibility and accrual requirements, to receive a fixed 3% nonelective contribution. Only non-highly compensated employees may receive this special fixed contribution.

NOTE 7: FAIR VALUE MEASUREMENTS

The Plan adopted the provisions of FASB ASC 820-10, "Fair Value Measurements". FASB ASC 820-10 defines fair value, establishes a framework for measuring fair value in generally accepted accounting principles, and expands disclosures about fair value measurements.

Fair Value Hierarchy

Under FASB ASC 820-10, the Plan groups assets at fair value in three levels, based on the markets in which the assets are traded and the reliability of the assumptions used to determine fair value. These levels are:

Level 1: Valuation is based upon quoted prices for identical instruments traded in active markets.

Level 2: Valuation is based upon quoted prices for similar instruments in active markets, quoted prices for identical or similar instruments in markets that are not active, and model-based valuation techniques for which all significant assumptions are observable in the market.

Level 3: Valuation is generated from model-based techniques that use at least one significant assumption not observable in the market. These unobservable assumptions reflect estimates of assumptions that market participants would use in pricing the asset. Valuation techniques include use of option pricing models, discounted cash flow models and similar techniques.
