INDEPENDENT AUDITORS' REPORT

To the Plan Administrator
Extreme Engineering Solutions, Inc. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Extreme Engineering Solutions, Inc. 401(k) Plan ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audits"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor ("DOL")'s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audits does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Accordingly, the objective of the ERISA Section 103(a)(3)(C) audits is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings and certain internal control related matters that we identified during the audits.

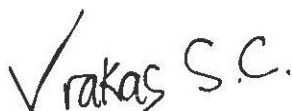

Notes to Financial Statements

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of accounting - Extreme Engineering Solutions, Inc. 401(k) Plan ("the plan") follows the accrual method of accounting wherein additions and deductions are reflected in the period earned or incurred.

Accounting estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Risks and uncertainties - The plan invests in various investments. Investments are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent events - The financial statements include management's evaluation of the events and transactions occurring subsequent to December 31, 2024 through October 8, 2025, which is the date the financial statements were available to be issued.

Key parties of the plan - Extreme Engineering Solutions, Inc. is the plan sponsor, employer and plan administrator. Fidelity Management Trust Company is the trustee that holds custody of the plan's investment assets and the plan's investment advisor. Fidelity Workplace Services, LLC is the third party administrator that maintains plan and participant records and tax counsel that performs various compliance tests and prepares the Form 5500. The two Fidelity entities are collectively referred to as "Fidelity".

Investments - The plan sponsor determines the investments available to plan participants. The participants allocate their contributions and transfer existing balances among the available investment options. The net appreciation (depreciation) in fair value of investments bought, sold and held during the years is reflected in the statements of changes in net assets available for benefits. Participants should refer to the prospectuses and annual reports of the investments for more information.

Fair value measurements - GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 - Valuation is based upon quoted prices in active markets for identical investments.
- Level 2 - Valuation is based upon other significant observable inputs (including quoted prices for similar investments).
- Level 3 - Valuation is based upon significant unobservable inputs (including the plan's assumptions in determining the fair value of investments).

Following is a description of the valuation methodologies used for investments measured at fair value.

Money market fund and mutual funds - Valued at the daily quoted market prices reported by the funds. The funds held by the plan are registered with the U.S. Securities and Exchange Commission, are required to publish their daily net asset value and are deemed to be actively traded.

2. DESCRIPTION OF PLAN

The following brief description of the plan is provided for general information purposes only. Participants should refer to the summary plan description and plan documents for more complete information.

General - The plan was established on January 1, 2006 as a defined contribution plan and has a 401(k) salary deferral arrangement. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments.

Eligibility - Participants are eligible for participation in the plan once they have completed one month of service and have reached 21 years of age and are eligible to receive employer safe harbor matching contributions once they have completed six months of service and have reached 21 years of age. An employee is allowed to enter the plan on the first day of the month immediately following the date the plan's eligibility requirements are met.

Contributions - Contributions are recorded in the year in which the eligible compensation is paid. Contributions to the plan can be made as follows:

- Participants may contribute a percentage of their annual wages or a set amount per pay period, subject to certain limitations (elective deferral contributions). The plan also permits Roth elective deferral contributions.
- Participants may make rollover contributions to the plan.
- Employer safe harbor matching contributions are paid semi-weekly coinciding with the employer's payroll. The employer safe harbor matching contributions are equal to 100% of the first 3% of compensation and 50% of the next 2% of compensation that a participant contributes to the plan.

Participant accounts - Contributions are remitted to the trustee who invests them in accordance with the investment options selected by the participant. The value of the investments is adjusted daily to reflect the earnings plus the fair value appreciation (depreciation). Participants can change their investment options daily and change their deferral percentages each month. Participants can stop making deferral contributions at any time.

Vesting - Participant account balances are always 100% vested.

Administrative fees - Certain administrative fees of the plan are paid by the employer and not included in these financial statements. Participants are charged individually for benefit payment and loan processing fees. Such fees totaled \$10,000 in 2024 and \$9,000 in 2023 and are recorded net of service credits received recorded as other income (see Note 3) in the accompanying statements of changes in net assets available for benefits.

Benefits to participants - Benefits are recorded when paid. Benefit payments may commence upon death, disability, retirement or termination of employment. Participants generally receive distributions of their accrued benefits in the form of lump sum payments. In-service withdrawals can commence upon reaching age 59 ½. Hardship withdrawals are also permitted under certain circumstances.

Notes receivable from participants - Participants may obtain loans from their accounts with approval of the plan administrator. Each participant may only have one loan outstanding at any time. The minimum loan amount is \$1,000 and the loans cannot exceed the lesser of 50% of the participant's vested account balance or \$50,000. Loans must generally be paid back over a period not to exceed five years, unless used to purchase a primary residence. As of December 31, 2024, loans outstanding had various repayment schedules through July 2031 with interest rates ranging from 3.25% to 10.50%. The notes receivable from participants are valued at their unpaid principal balances plus any accrued but unpaid interest, which approximates fair value.

3. OTHER INCOME AND PARTY-IN-INTEREST TRANSACTIONS

Fidelity receives indirect compensation from mutual fund service providers in the form of service credits for services Fidelity provides to the funds. These service credits received by Fidelity are used to offset amounts that would otherwise be owed by the plan to Fidelity for administrative services Fidelity provides to the plan. Service credits that are received by Fidelity in excess of fees charged to the plan are remitted to the plan, recorded as other income and allocated to participants on an account value basis.

Activity related to notes receivable from participants also qualify as party-in-interest transactions.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

4. TERMINATION OF PLAN

Although it has not expressed any intent to do so, the employer has the right to discontinue its contributions at any time and terminate the plan subject to the provisions of ERISA.

5. INCOME TAX STATUS

The plan is operating under a Fidelity non-standardized pre-approved profit sharing plan that received a favorable opinion letter on June 30, 2020. The opinion letter from the Internal Revenue Service stated that the plan, as then designed, were in compliance with the applicable requirements of the Internal Revenue Code. The plan administrator has not obtained a separate Internal Revenue Service opinion or determination letter for the plan; however, the plan administrator and tax counsel believe the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and, therefore, believes the plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize tax liabilities (or assets) for any uncertain tax positions taken by the plan that more likely than not would not be sustained upon examination by the applicable authorities. Plan management analyzed the requirements for accounting for such uncertain tax positions taken and determined the plan was not required to recognize any tax liabilities (or assets) related to uncertain tax positions taken as of December 31, 2024 and 2023. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress.
