Note 1 - Plan Description

The following description of Norican Group US 401(k) Plan (the "Plan") provides only general information. Participants and all others should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan with profit-sharing provisions established effective August 7, 2003 by Wheelabrator Group, Inc.; Castalloy, Inc.; StrikoWestofen GmbH; DISA Holding LLC; and Simpson Technologies Corporation (collectively, the "Company"). Generally, employees of the Company and its subsidiaries are eligible upon the date of hire with immediate entry. The Plan is intended to constitute a qualified plan and trust under Section 401(a) of the Internal Revenue Code (IRC) and includes provisions under Section 401(k) of the IRC. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration

The Company is the sponsor of the Plan. The 401(k) committee is the plan administrator and has responsibility for the administration of the Plan. Vanguard Fiduciary Trust Company (Vanguard) functions as trustee and third-party administrator and maintains the Plan's records.

Contributions

The Plan provides for employee salary deferral contributions up to a maximum of 100 percent of eligible annual compensation subject to maximum tax-deferred limitations established by the IRC. The Plan allows participants to contribute up to 100 percent of their eligible compensation on an after-tax basis. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

Certain participant contributions in 2023 were paid after the time frame required by the Department of Labor. The Company remitted these contributions during 2024 and remitted some of the lost earnings in 2024 and plans to remit the remaining related lost earnings to the Plan in 2025.

The Company is required to make qualified automatic contribution arrangement (QACA) matching contributions of 100 percent of the first 1 percent of eligible compensation deferred and 50 percent of the next 5 percent of eligible compensation deferred by the participants.

The Company may also make annual discretionary contributions to the Plan, as approved by the Company's board of directors. There were no discretionary employer contributions during 2024.

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balances. The notes receivable are secured by the balance in the participant's account and bear interest at rates that range from 4.25 percent to 9.5 percent, which are commensurate with local prevailing rates determined quarterly by the plan administrator. Loans have a maximum term of 5 years, unless such loan is for the purchase of the participant's primary residence, in which case the repayment period may not exceed 10 years (previously 20 years) from the date of the loan origination. Principal and interest are paid ratably through monthly payroll deductions.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of plan losses and administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Note 1 - Plan Description (Continued)

Vesting

Participants are immediately 100 percent vested in employee salary deferral, rollover, discretionary qualified nonelective employer, and discretionary qualified matching contributions and any income or loss thereon. Vesting in the QACA and discretionary contribution portion of their accounts, plus actual earnings thereon, is based on years of service. Participants vest in QACA contributions made by the Company 100 percent after two years of service.

The Company's discretionary contributions, if any, vest according to the following schedule:

Benefit Payments

On termination of service due to death, disability, retirement, or termination of employment, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document. The plan administrator must approve any such hardship withdrawals.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions into the Plan. At December 31, 2024 and 2023, forfeited account balances totaled \$63,709 and \$54,906, respectively.

The Plan used \$67,095 for the year ended December 31, 2024 to reduce plan expenses.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by Vanguard or its affiliates. Vanguard is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

The Plan provides for loans to participants, which are party-in-interest transactions, as defined under ERISA guidelines.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value.

December 31, 2024 and 2023

Note 2 - Summary of Significant Accounting Policies (Continued)

The common collective trust funds are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying net assets. There are no redemption restrictions or unfunded commitments on these investments. All other investments are valued based on quoted market prices reported in active markets. See Note 4 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Various administrative costs are paid by the Company.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including October 6, 2025, which is the date the financial statements were available to be issued.

During 2025, the Company went through a reorganization and the participating employers DISA Holding LLC ceased participation in the Plan effective April 1, 2025, and Striko-Westofen GmbH and Simpson Technologies Corporation ceased participation in the plan effective August 1, 2025.

Note 3 - Certified Information

Vanguard holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by Vanguard.

Note 4 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
