NOTES TO FINANCIAL STATEMENTS

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Beitzel Group 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions. The Companies who have adopted the Beitzel Group 401(k) Plan are Beitzel Corporation, Pillar Innovations, LLC, and Beitzel Corporate Services, LLC (collectively referred to as “Companies”).

General

The Plan is a defined contribution plan covering all full-time employees of the Companies who have at least 60 days of service and are age eighteen or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to the maximum allowed under the Internal Revenue Code. Effective as of January 1, 2020, the Plan Sponsor amended the provisions of employer contributions to allow both pre-tax and after-tax (Roth) deferrals. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

Effective as of January 1, 2022, the Companies contribute 50% of the first 6% of base compensation for any eligible employee with at least one year of service that contributes to the Plan. Additional amounts may be contributed at the option of the Companies’ boards of directors. Contributions are subject to certain statutory limitations.

Effective as of February 1, 2022, the Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation and their contributions invested in a designated fund until changed by the participant. Contributions are subject to certain limitations as defined in the Plan agreement, and as limited by statute.

Participant Accounts

Each participant’s account is credited with the participant’s voluntary contribution and allocations of (a) the Companies’ contribution and, (b) Plan earnings (losses), and charged with the participant’s distributions, withdrawals, and an allocation of administrative expenses, at the direction of the plan administrator. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

NOTE 1 - DESCRIPTION OF PLAN (Continued)

Vesting

Participants are immediately vested in their voluntary contributions and rollover contributions plus actual earnings thereon. Vesting in the Companies' matching and discretionary contributions portion of their accounts plus earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service.

Participant Notes Receivable

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan terms range from 1 - 5 years. The loans are secured by the balance in the participant's account and bear interest commensurate with local prevailing rates as determined by the plan administrator. The interest rate on new loans is presently 8.75%. Principal and interest is paid ratably through weekly payroll deductions.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant or beneficiary may choose from various methods by which benefits are to be distributed as defined by the plan.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,878 and \$1,326 respectively. Forfeitures were used to reduce employer contributions in the amount of \$30,870 and \$55,707 at December 31, 2024 and 2023, respectively.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”) requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Participant Notes Receivable

Participants notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan did not have any excess contributions for the plan year ended December 31, 2024. The 2023 excess contributions were distributed to the applicable participants prior to December 31, 2024.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the fixed investment account which is a fully benefit-responsive investment contract and is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

The value of a unit in a pooled separate account is the fair market value of investments in the account as of the valuation date, plus cash balances and accruals less accounts payable, expenses and taxes that are allocable to the account, divided by the number of outstanding participation units in the account. Securities held in the pooled separate accounts are valued based on quoted market prices. If there is no readily available market value for a particular security, the investment manager will determine the fair market value of such investment in accordance with accepted practices and applicable laws and regulations. As of any date, the value of the Plan’s share of a separate account will equal the number of participation units held by the Plan multiplied by the participation unit value.

The Plan does not require collateral to secure investment instruments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation or depreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

All operating expenses of maintaining the Plan are paid by the Companies and therefore excluded from these financial statements.

Subsequent Events

The Plan has evaluated subsequent events through September 26, 2025, the date the financial statements were available to be issued. There has been no material event noted during the period that would either impact the results in the report or the Company's results going forward.

NOTE 3 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan holds a fixed investment contract that is a traditional investment contract. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses.

The investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer. The crediting rate is reviewed on a quarterly basis for resetting.

The Plan's ability to receive amounts due in accordance with fully benefit responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Examples of such events include the following:

- 1) The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code.
- 2) Premature termination of the contracts.
- 3) Plan termination or merger.
- 4) Changes to the Plan's prohibition on competing investment options.

- 5) Bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Those events include the following:

- 1) An uncured violation of the Plan's investment guidelines.
- 2) A breach of material obligation under the contract.
- 3) A material misrepresentation.
- 4) A material amendment to the agreements without the consent of the issuer.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023, was \$937,506 and \$1,287,383, respectively.

NOTE 4 - FAIR VALUE MEASUREMENTS

Investments in the Plan's variable investment account (pooled separate account) are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels.

Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable quoted prices in inactive markets for identical or similar assets or liabilities. Level 3 inputs are unobservable and have the lowest priority.

The Plan's investments held in the Flexible Advantage Account are valued entirely using Level 2 inputs (observable inputs other than quoted prices for identical assets).

At December 31, 2021, the Plan's variable investment accounts were transferred to a pooled separate account. The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels. The Plan's investments in the pooled separate account and administered by Voya are valued entirely using Level 2 inputs (observable inputs other than quoted prices for identical assets).

NOTE 5 - RELATED PARTY TRANSACTIONS

Principal owners of Beitzel Corporate Services (the plan sponsor) are also the trustees of the Beitzel Group 401(k) Plan. Pillar Innovations, LLC and Beitzel Corporate Services, LLC are wholly owned subsidiaries of Beitzel Corporation. Beitzel Corporate Services, LLC provides certain accounting and administrative services to the Plan for which no fees are charged. These transactions are exempt party in interest transactions.

Beitzel Corporation (the plan sponsor) has elected to absorb the cost of the audit of the Plan’s annual report. During the plan year this cost was approximately \$9,500.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 7 - TAX STATUS

The Internal Revenue Service has determined and informed the plan sponsor by a letter dated March 19, 1992, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United State of America required the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain positions taken by the Plan that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

NOTE 8- RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

NOTE 9 - ERISA SECTION 103(a)(3)(C) AUDIT DISCLOSURE

The investment asset values, transactions, and income, and the schedules of assets held for investment purposes and reportable transactions were certified by Voya Retirement Insurance and Annuity Company, third party plan custodian, as of December 31, 2024 and 2023 to be complete and accurate.

NOTE 10 - ERISA FIDELITY BOND COVERAGE

The amount of the Plan's ERISA Fidelity Bond coverage as of December 31, 2024 was sufficient in relation to the Plan's assets. The IRS/DOL requires the bond to be at least equal to the lesser of 10% of plan assets or \$500,000. The Plan's policy is \$500,000 as of December 31, 2024 and therefore, provides compliance.

NOTE 12 – SECURE ACT AND SECURE ACT 2.0

The Plan has implemented requirements of the Setting Every Community Up for Retirement Enhancement Act of 2019 (SECURE Act), which laws change the Plan to, among others, allow in-service withdrawals for childbirth and adoption expenses, allow retirees to delay taking RMD until age 72, and increase the maximum amount of the automatic contribution from 10% to 15%. Written amendments to the Plan to reflect these operational changes will be adopted at a later date in accordance with applicable law and IRS guidance.

The Plan has implemented requirements of the Setting Every Community Up for Retirement Enhancement Act 2.0 of 2022 (SECURE Act 2.0), which laws change the Plan to, among others, allows retirees to delay taking RMD until age 73. Written amendments to the Plan to reflect these operational changes will be adopted at a later date in accordance with applicable law and IRS guidance.
