INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Participants
BakerRipley 403(b) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the BakerRipley 403(b) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Note 1 - Description of the Plan

General

The BakerRipley 403(b) Plan (the Plan) is a defined contribution plan that was established effective January 1, 2004 covering eligible employees of BakerRipley (the Organization) and its eligible subsidiaries. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The following description of the Plan provides only general information and is as of December 31, 2024, unless otherwise noted. Participants should refer to the Plan Adoption Agreement for a more complete description of the Plan's provisions.

Plan Administration

The Organization serves as the Plan Sponsor and has established the 403(b) Plan Committee to serve as the Plan Administrator. The Custodian of the Plan is State Street Bank and Trust Company. Among other duties, the Custodian receives contributions, holds and invests the Plan's assets in accordance with the direction of the participants, and makes disbursements as directed by the Plan Administrator. Transamerica Retirement Solutions, LLC (TRS) is the Recordkeeper for the Plan. The Plan uses a third-party as an investment advisor.

Eligibility

All employees of the Organization are eligible to participate in the Plan immediately upon hire, excluding those employees who normally work less than twenty hours per week and employees who are nonresident aliens. Employees are not eligible for employer contributions until they have completed six months of service.

Participant Contributions

Each year, participants may contribute pre-tax and after-tax (Roth) up to 100% of their annual compensation, as defined in the Plan Adoption Agreement and allowed by the Internal Revenue Code (the Code). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

Upon meeting the eligibility requirements, unless the participant elects otherwise, the newly eligible participant is automatically enrolled and a deferral deduction is made each pay period at the Plan's automatic deferral percentage of 2%, with an annual 1% contribution increase until the Plan's maximum automatic deferral percentage of 5% is reached.

The Plan also allows rollover contributions to the Plan from other qualified defined benefit plans, defined contribution plans, or amounts previously contributed to a traditional Individual Retirement Account.

Employer Contributions

The Organization makes a fully vested safe harbor employer matching contribution each payroll period for eligible participants, which is equal to 100% of the first 3% of the participant's contributions, plus 50% of the next 2% of the participant's contributions, up to a maximum of 4% of the participant's eligible compensation.

Discretionary employer contributions may be made for each Plan year in an amount determined by the Organization and are allocated monthly to participants based on compensation and active participation in the Plan. The Organization made no such discretionary employer contributions for the year ended December 31, 2024.

Vesting

Participants are immediately 100% vested in their employee contributions, the safe harbor employer matching contributions and discretionary employer contributions, plus actual earnings thereon.

Participant Accounts

Separate accounts are maintained for each participant. Participants direct the investment of their contributions as well as employer contributions into various investment options offered by the Plan. Participants may modify the allocation of their elections at any time. Each participant's account is credited with the participant's contribution and an allocation of (1) the employer safe-harbor matching contribution, (2) the employer discretionary contribution, and (3) Plan earnings or losses.

Benefit Payments

Distributions are payable upon termination, death, or normal retirement age. The available distribution options are lump sum cash distributions and optional life annuities (subject to spousal consent). The Plan allows for in-service distributions. Hardship withdrawals are permitted and may be sourced from employee pre-tax elective deferral accounts. A participant who terminates employment with a vested balance of \$7,000 or less may receive a lump sum distribution of his or her vested account balance within a reasonable period following the date the participant terminates employment.

Expense Budget Account

The Plan has an expense budget account (EBA) that is funded by an annual charge to participant accounts of 0.20%. Effective February 2024, the annual charge to participant accounts was lowered to 0.18%. EBA funds may be used to pay Plan related expenses approved by the Organization or may be allocated to Plan participants at the end of the year. At December 31, 2024 and 2023, the EBA totaled \$31,222 and \$29,613, respectively. During the year ended December 31, 2024, \$72,082 was used to pay Plan expenses from the EBA.

Participant Notes Receivable

Participants are allowed to borrow a minimum of \$1,000, up to the lesser of \$50,000 or 50%, of their vested account balance reduced by the highest outstanding loan balance within the previous twelve-month period, if any. Participants may not have more than three outstanding loans at one time. Participants must wait thirty calendar days after a loan is paid off before initiating a new loan. The loans are secured by the balance in the participant's vested account and bear interest at prime plus 2%. The loans require level payments over a period generally not to exceed five years, except for the purchase of a primary residence, in which case loan terms can reach thirty years; however, the loan terms may have been extended for one year related to suspension of loan payments as allowed under the CARES Act. Principal and interest are paid ratably through payroll deductions.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements have been prepared on the accrual basis and present the net assets available for benefits and changes in those net assets in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expense and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Adoption Agreement.

Contributions

Contributions from Plan participants and the matching contributions from the Organization are recorded in the year in which participant compensation is earned.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Organization and are excluded from these financial statements. The Organization receives no compensation for services provided to the Plan. Fees related to the administration of the Plan, investment advisory services and auditing are paid by the Plan and are included in administrative fees and expenses. Investment expenses are included in the net appreciation or depreciation in fair value of the respective investment. Indirect compensation, which is netted against investment income on the statement of changes in net assets available for benefits, was paid to an investment brokerage services firm and ranged between 0.00825% and 0.01650% of the balance of certain funds.

Subsequent Events

Effective January 1, 2025, a formal amendment was made to the Plan to adopt an optional amendment of the SECURE Act 2.0, which addresses the long-term part-time requirements. The amendment allows all employees to be eligible for participation in the Plan; however, the employer match will remain applicable to employees meeting the full-time definition under the Plan.

The financial statements and related disclosures include evaluation of events up through August 20, 2025, the date on which the financial statements were available to be issued.

Note 3 - Unaudited Information Certified by Custodian

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the following information has been certified by State Street Bank and Trust Company as to its completeness and accuracy and was not subjected to any auditing procedures performed by the Plan's independent auditor:

- Investments and notes receivable from participants reflected in the statements of net assets available for benefits as of December 31, 2024 and 2023 and notes to financial statements,
- Investment interest and dividend income, net appreciation in fair value of investments, and interest income on notes receivable from participants reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024, and
- All information included in the supplemental schedule of assets (held at end of year) as of December 31, 2024.

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value at December 31, 2024 and 2023. There have been no changes in methodologies used at December 31, 2024 or 2023.

Mutual funds: The fair value is based on quoted net asset values of the shares reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while management of the Plan believes the valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value.

Note 5 - Fully Benefit-Responsive Investment Contract

The Transamerica Guaranteed Investment Option is a fully benefit-responsive investment contract with Transamerica Life Insurance Company (TLIC) and as such, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the Recordkeeper represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. As of December 31, 2024 and 2023, the contract value of this investment was \$1,073,810 and \$1,499,362, respectively.

TLIC maintains the contributions in a general account. The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against contract value for the credit risk of the issuer or otherwise.

Certain events may limit the ability of the Plan to transact at contract value with TLIC. Such events include termination of the contract, merger, layoffs, bankruptcy, the creation of a new competing fund, partial or total plan termination and retirement incentive programs. Upon occurrence of any of these events, a market value adjustment may apply. The Plan Administrator believes that any events that would limit the Plan's ability to transact at contract value are remote.

Note 6 - Tax Status

The Plan has adopted a pre-approved 403(b) plan document that received an opinion letter from the Internal Revenue Service dated March 31, 2017, stating that the form of the pre-approved 404(b) plan document was in compliance with applicable requirements of the Code. Although the Plan has been amended since adopting the pre-approved 403(b) plan document, the Plan Administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the Code, and therefore believes that the Plan is qualified.

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

The Plan has adopted the applicable mandatory provisions of the SECURE Act 2.0. along with certain optional provisions. Written amendments to the Plan document to reflect these operational changes will be executed at a later date in accordance with deadlines pursuant to applicable laws and IRS guidance.

Note 7 - Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA.

Note 8 - Related Party and Party-in-Interest Transactions

The Plan invests in the Transamerica Guaranteed Investment Option in which contributions and earnings thereon are held in the general account of TLIC, which is a related party to the Recordkeeper of the Plan. These investment transactions are considered party-in-interest transactions as defined by ERISA; however, these transactions are not considered prohibited transactions under 29 CFR 408(b) of the ERISA regulations. During the year ended December 31, 2024, the Plan paid direct compensation to the recordkeeper of approximately \$145,000 and paid \$55,000 to a professional services firm related to investment advisory services. Certain costs of administering the Plan are borne directly by the Organization.

Note 9 - Risks and Uncertainties

The Plan provides for investment in various investment options. Investment securities are exposed to risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.
