## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator  
Windings, Inc. 401(k) Salary Savings & Retirement Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(c) Audit**

We have performed audits of the accompanying financial statements of Windings, Inc. 401(k) Salary Savings & Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(c) (ERISA Section 103(a)(3)(c) audit). **Note 1 DESCRIPTION OF THE PLAN**

The following description of Windings, Inc. 401(k) Salary Savings & Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**GENERAL**

The Plan is a defined contribution plan covering all eligible employees of Careen, Inc. d/b/a Windings, Inc. (the Company) who are at least 21 years of age, as defined in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Investment Committee is responsible for the oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

**CONTRIBUTIONS**

Each year, participants may contribute up to 50 percent of eligible compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6 percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Company contributes a discretionary matching contribution. For the year ended December 31, 2024, the discretionary matching contribution was equal to 100 percent of the first 4 percent of eligible compensation that a participant contributes to the Plan. Additional discretionary contributions may be contributed at the option of the Company. There were no additional discretionary contributions for the year ended December 31, 2024. Contributions are subject to certain IRS limitations.

**PARTICIPANT ACCOUNTS**

Each participant's account is credited with the participant's contributions and Company contributions, as well as allocations of the Company's discretionary contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which the participant is entitled is the benefit that can be provided from the participant's vested account.

**VESTING**

Participants are vested immediately in their contributions plus actual earnings thereon. Participants become 100 percent vested in the Company's contributions after one year of service.

**NOTES RECEIVABLE FROM PARTICIPANTS**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is commensurate with local prevailing rates. The term of the loan cannot exceed

five years unless the loan is for the purchase of a participant's primary residence. Principal and interest are paid ratably through payroll deductions.

**PAYMENT OF BENEFITS**

Upon death, disability, retirement, or termination of service, subject to the terms of the Plan, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or installment payments. The Plan generally requires distributions of account balances less than \$5,000 upon termination without the participant's consent. In-service distributions are allowed for participants who are age 59½ or older from their vested account balances.

**FORFEITURES**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0. These accounts will be used to reduce future Company's discretionary contributions or to pay Plan administrative expenses. During 2024, the Company's discretionary matching contributions were reduced by \$20,786 from forfeited nonvested accounts and administrative expenses were reduced by \$452.

**Note 2 SUMMARY OF ACCOUNTING POLICIES**

**BASIS OF PRESENTATION**

The financial statements of the Plan have been prepared on the accrual basis of accounting.

**USE OF ESTIMATES**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**INVESTMENT VALUATION AND INCOME RECOGNITION**

Investments are reported at fair value (except for the fully benefit responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**CONTRIBUTIONS**

Contributions from Plan participants and Company contributions are recorded in the year in which the employee contributions are withheld from compensation.

**NOTES RECEIVABLE FROM PARTICIPANTS**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**PAYMENT OF BENEFITS**

Benefits are recorded when paid.

**ADMINISTRATIVE EXPENSES**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expense. Investment related expenses are included in net appreciation of fair value of investments.

**SUBSEQUENT EVENTS**

Plan management has evaluated subsequent events through August 29, 2025, the date the financial statements were available to be issued.

**Note 3 CERTIFIED INVESTMENTS**

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (the trustee of the Plan), a qualified institution.

**Note 4 FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at quoted prices available in an active market.

*Common/collective trusts:* Valued at the Net Asset Value (NAV) of the underlying assets. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined probable that the fund will sell the investment for an amount different than the reported NAV.

**Note 5 FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS**

The financial statements reflect the adoption of FASB’s authoritative guidance regarding *Reporting of Fully Benefit-Responsive Contracts Held by Certain Investment Companies*. The Plan holds a guaranteed investment contract. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. The following represents the contract value of the investment contract held by the Plan:

The guaranteed investment contract is the Principal Fixed Income Guaranteed Option (PFIGO), with Principal Life Insurance Company. The PFIGO contract guarantees principal and provides a stated crediting rate backed by Principal Life. The interest crediting rate is reset semi-annually and will never be less than the guaranteed minimum interest rate. The PFIGO is backed by the assets in the multi-billion dollar general account of Principal Life. The general account consists of over 6,000 investments, which include corporate bonds, asset-backed securities, commercial real estate mortgages, government bonds and short-term cash equivalents.

Certain events, such as the premature termination of the contract by the Plan or the termination of the Plan, would limit the Plan’s ability to transact at contract value with Principal Life Insurance Company. The Plan administrator believes the occurrence of such events that would also limit the Plan’s ability to transact at contract value with Plan participants is not probable.

The Plan may terminate the contract at any time; however, the Plan will be assessed surrender charges as defined in the Group Annuity Contract.

**Note 6 TRANSFER OF ASSETS FROM OTHER RELATED PLAN**

Certain employees transferred amounts totaling \$440,462 for the year ended December 31, 2024 into the Plan from Windings, Inc. Employee Stock Ownership Plan and Trust, a defined contribution plan sponsored by the Company.

During 2024, the Company acquired an unrelated company and transferred the assets of the participants into the Plan. The assets from Mac M McCully 401(k) Plan was \$259,392 and is included in the transfer of assets from other plan on the statement of changes in net assets for benefits.

**Note 7 RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company. Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. As described in Note 2, the Plan made direct payments to Plan service providers totaling \$5,887 for the year ended December 31, 2024. The Company pays directly any other fees related to the Plan's operations. Notes receivable from participants and transactions with the Company also qualify as party in interest transactions.

**Note 8 PLAN TERMINATION**

Although they have not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their Company contributions.

**Note 9 TAX STATUS**

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter; the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 10 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
