Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Holz Motors, Inc. 401(k) Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Holz Motors, Inc. 401(k) Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. - Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Holz Motors, Inc. 401(k) Savings Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

Note 1: Description of Plan

The following description of the Holz Motors, Inc. 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

The SECURE 2.0 Act of 2022 (SECURE 2.0), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. The Plan has adopted the following provisions:

- Option to allow recovery of retirement plan overpayments to retirees.
- Option to treat employer matching or nonelective contributions as Roth contributions.
- Option to allow employer to rely on employees certifying that deemed hardship distribution conditions are met.
- Option to allow distributions for emergency expenses.
- Option to offer pension-linked emergency saving accounts.
- Option to increase the dollar limit for mandatory distributions into an IRA for balances between \$1,000 and \$5,000 to balances between \$1,000 and \$7,000.
- Option to allow penalty-free withdrawals for individual case of domestic abuse.
- Option to allow a surviving spouse to elect to be treated as the deceased employee for purpose of the required minimum distribution rules.
- Amendment of the qualified birth or adoption distributions recontribution period to 3 years.
- Required minimum distribution at age 73 effective January 1, 2023, and is in the process of evaluating other voluntary provisions.
- Improved coverage for part-time employees. SECURE 2.0 requires employers to allow long-term part-time employees to participate in their 401(k). Employers maintaining a 401(k) plan must have a dual eligibility requirement under which an employee must complete 1 year of service (with 1,000-hour rule) or 3 consecutive years of service (where the employee completes at least 500 hours of services). Section 125 of SECURE 2.0 reduces the 3 year rule to 2 years, effective for the plan years beginning after December 31, 2024.

- Permits employers to provide matching contributions based on student loan payments, rather than based only on elective contributions to retirement plans, in plan years beginning after December 31, 2023.
- Require elimination of the pre-death distribution requirement for Roth accounts.
- Require automatic enrollment and automatic escalation for plans established after December 29, 2022.

The Plan is required to be amended in regard to other requirements of SECURE 2.0 by December 31, 2026.

General

The Plan is a defined contribution plan established by Holz Motors, Inc. (the Plan Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Investments are all participant directed. The Custodian of the Plan is Matrix Trust Company (Matrix). The Recordkeeper of the Plan is OneAmerica Retirement Services LLC.

Eligibility

Employees of the Plan Sponsor who are at least 21 or older and completed 1 hour of service for 90 continuous days are eligible to participate in the Plan. If an employee does not satisfy the 90 day requirement following their date of hire, the employee will be deemed to satisfy the requirement upon completing 1,000 hours of service within 12 months of their date of hire or 3 years of consecutive service with 500 hours. Participation begins on the first day of each quarter of the Plan year following the fulfillment of the eligibility requirements. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan.

The Plan is not available to leased employees or members of a labor, trade, or other union organizations which have collectively bargained for retirement benefits.

Contributions

Participants may contribute to the Plan up to 50% of their eligible compensation, as defined by the Plan, subject to certain Internal Revenue Service (IRS) limitations. Participants may also rollover distributions from other qualified plans.

The Plan Sponsor may make a discretionary profit sharing contribution to the Plan. To be eligible for the profit sharing contributions, participants must have performed at least 1,000 hours of service during the Plan year and be employed as of the first and last day of the Plan year. In 2024, the Plan Sponsor made a discretionary profit sharing contribution to the Plan totaling \$150,000.

Note 1: Description of Plan (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions, Plan Sponsor profit sharing contributions, Plan earnings (losses), and forfeitures of terminated participants' nonvested accounts. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings (losses), account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings (losses) thereon. Vesting in the Plan's profit sharing contribution portion of a participant's account is based on the number of years of service. Plan Sponsor profit sharing contributions vest according to the following schedule:

6 or more	100 %

Participants become fully vested in the profit sharing portion of their accounts upon death, disability, retirement, or Plan termination.

Payment of Benefits

On termination of service, if a participant's vested balance exceeds \$7,000, the participant may elect to receive benefit distributions in a lump sum or in installments. If the participant's vested balance does not exceed \$1,000 upon termination, the participant may only receive their benefit distributions in a lump sum and it will be automatically distributed and, if the participant's vested balance is between \$1,000 and \$7,000 and there is no affirmative direction to distribute the vested balance, the vested balance will automatically be rolled into an IRA provider selected by the Plan Administrator. The Plan also allows for in-service distributions of employee deferrals upon attaining age 59 1/2. In-service distributions from employer contributions are at the attainment of the normal retirement age of 65.

Forfeitures

Forfeitures are portions of participants' accounts that participants surrender by terminating employment prior to becoming fully vested. Forfeited balances are reallocated to the remaining participants in the same manner as Plan Sponsor contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$10,917 and \$9,072, respectively. Forfeitures reallocated during the Plan year ended December 31, 2024 were \$5,437.

Transfers

The Plan Sponsor also sponsors a savings plan for their Watertown location employees. If participants change their employment status to either location their account balances are transferred to or from the corresponding plan. Net transfers for 2024 were \$39,414.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates in Preparation of Financial Statements

The preparation of the accompanying financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's sole investment as of December 31, 2024 and 2023, is its interest in the Master Trust. The Plan's interest in the Master Trust is stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

All expenses of maintaining the Plan are paid by the Plan. Investment-related expenses are allocated proportionately to Plan participants based on their respective account balances and are included as a reduction in Plan interest in net investment income of master trust.

Subsequent Events

The Plan has evaluated subsequent events through September 22, 2025, which is the date the financial statements were available to be issued.

Note 3: Information Prepared and Certified by Custodian

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements, including investments held at December 31, 2024 and 2023, and Plan interest in net investment income of master trust for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Matrix.

Note 4: Interest in Holz Motors, Inc. Master Trust

All of the investments of the Plan are invested in the Holz Motors, Inc. Master Trust (Master Trust), in which investments of the Sponsor's two defined contribution plans are commingled. The investment income and the expenses of the Master Trust are allocated to each plan based on the relationship of the Plan's investment balances to the total Master Trust investment balance.

Note 5: Fair Value Measurements

GAAP specifies a three-tier fair value hierarchy, which prioritizes the inputs used in estimating fair value. These tiers include Level 1, defined as observable inputs such as quoted market prices in active markets; Level 2, defined as inputs other than quoted market prices in active markets that are either directly or indirectly observable; and Level 3, defined as unobservable inputs in which little or no market data exists, therefore, requiring an entity to develop its own assumptions.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds are deemed to be actively traded.

Stable Value Fund: Valued at NAV per share as determined by the issuer of the common/collective trust based on the fair value of the underlying investments. The AUL Stable Value Account (Fund) can be redeemed on a daily basis at its NAV. There were no unfunded commitments. The Fund invests in traditional and synthetic guaranteed income contracts with various crediting formulas. The investment objective of the Fund is to maintain safety of principal while generating a level of current income that is consistent with that of a money market fund. There are no valuation reserves.

Note 5: Fair Value Measurements (Continued)

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables set forth by level, within the fair value hierarchy, the Master Trust's investment assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement:

Note 6: Related-Party Transactions and Party-in-Interest Transactions

Certain Master Trust investments are shares of mutual funds managed by Matrix, the Custodian of the Plan. Therefore, transactions with Matrix qualify as party-in-interest transactions. These transactions are not, however, considered prohibited transactions under Section 29 CFR 408(b) of the ERISA regulations. Investment and administrative fees incurred by the Plan for investment management services provided by Matrix were \$22,939 for the year ended December 31, 2024.

Note 7: Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Plan Sponsor contributions.

Note 8: Tax Status

The IRS has determined and informed the Plan by a letter, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Note 9: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
