INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator
Associates in Women's Health, P.A. 401(k) Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Associates in Women's Health, P.A. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from American United Life Insurance Company, the custodian of the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note H to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. NOTE A - DESCRIPTION OF PLAN

The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan, established January 1, 1997, is a defined contribution plan. Employees of Associates in Women's Health, P.A. (the Company) who have been employed for one year or more, are twenty-one or older may contribute to the Plan. Employees twenty-one or older, who have been employed for one year or more, and have completed 1,000 hours of credited service are eligible for employer matching and discretionary profit-sharing contributions. Effective January 1, 2010, the Plan was amended and restated as a prototype plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may make annual pre-tax and Roth after-tax contributions of up to 85 percent of their annual compensation, as defined by the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company matches 50% of participant deferrals up to 8% of compensation, as defined by the Plan. The Company may also make a nonelective discretionary profit-sharing contribution. The profit-sharing contribution is allocated based on participant compensation and the participant must be employed on the last day of the plan year to qualify. Profit sharing contributions made by the Company for 2024 and 2023 totaled \$494,725 and \$480,060, respectively. Contributions are subject to certain limitations.

Forfeited Accounts

Forfeitures of terminated participants' nonvested accounts are used to pay reasonable plan expenses or to reduce future employer contributions. \$334 of forfeitures was used to reduce plan expenses and \$434 of forfeitures was used to reduce employer contributions during 2024. Unallocated forfeitures were \$41,518 and \$37,618 at December 31, 2024 and 2023, respectively.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's contribution and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reason, a participant (or beneficiary) may elect to receive either a lump-sum amount equal to the value of the participant's vested account, periodic installments, or an annuity, as defined by the Plan.

Vesting

Participants are immediately vested in their deferral contributions plus actual earnings thereon. Vesting in the remainder of their account is based on years of service as defined by the Plan. A participant is vested as follows:

Notes Receivable from Participants

Participants who are actively employed by the Company may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of the borrowing participant's vested account balance or \$50,000. Loan terms range from 1- 5 years or up to 30 years for the purchase of a primary residence. The loans are secured by an irrevocable pledge and assignment of 50% of the nonforfeitable amount in the participant's account and shall bear a reasonable rate of interest based on current external market rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Accounting Method

The financial statements of the Plan have been prepared using the accrual method of accounting and present the net assets available for plan benefits and changes in those net assets based on fair value.

Investments

All investments are stated at fair value, which is based on quoted market prices. The fair value of the guaranteed interest account is based on the valuation formula provided by American United Life Insurance Company. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

Notes Receivable from Participants

Notes receivable from participants are valued at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the Plan document.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Payment of Benefits

Benefits are recorded when paid. There were no withdrawals requested but unpaid at December 31, 2024.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect the reported amounts and disclosures. Actual results could differ from those estimates.

NOTE C - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, each participant's account shall be fully vested and nonforfeitable.

NOTE D - PLAN EXPENSES

Plan expenses, exclusive of certain operating expenses, are paid by the Company and are excluded from these financial statements.

NOTE E - TAX STATUS

The IRS has determined and informed the prototype's sponsor by a letter dated March 31, 2008, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE F - FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The following tables present fair value measurement information for certain financial instruments.

This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. No Level 3 inputs were used by the Plan.

Level 1 Fair Value Measurements

The fair value of the mutual fund is based on quoted net asset values of the shares held by the Plan at year end. The fair value of self-directed brokerage accounts is based on quoted market prices of the specific investments held by the Plan at year end.

Level 2 Fair Value Measurements

The fair value of the guaranteed interest accounts is reported daily based on the contract value provided by American United Life Insurance Company.

During 2024, the Plan transferred \$50,542 from Level 1 to Level 2 and \$12,967 from Level 2 to Level 1 based on participants' investment options. Transfers are recognized on a daily basis.

NOTE G - CONCENTRATIONS

Four funds or investment accounts with the highest value comprised approximately 44% of net assets available for benefits as of December 31, 2024 and 2023.

NOTE I - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE J - RELATED PARTY TRANSACTIONS

Plan investments are in custodial control and managed by American United Life Insurance Company, the custodian as defined by the Plan and, therefore, these transactions qualify as party in interest.

The Plan issues notes to participants, which are secured by the balances in the participants' accounts. These transactions qualify as party in interest transactions.

NOTE K - GUARANTEED INVESTMENT CONTRACTS WITH INSURANCE COMPANY
(GUARANTEED INTEREST ACCOUNTS)

Included in the Plan investment options are Guaranteed Interest Accounts which are fully benefit-responsive traditional group annuity investment contracts with American United Life Insurance Company (AUL). The contracts maintain the contributions in pooled separate accounts and are presented at contract value, which represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. AUL is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on AUL's ability to meet its financial obligations. AUL's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with AUL. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The guaranteed investment contracts do not permit the Plan to terminate the agreement without at least twelve months advance written notice.

NOTE L - SUBSEQUENT EVENTS

Management has evaluated subsequent events through September 5, 2025, the date the financial statements were available to be issued and determined that no additional disclosures were necessary.

There have been no initial selection of accounting policies and no changes in significant accounting policies or their application during 2024. No matters have come to our attention that would require us, under professional standards, to inform you about (1) the methods used to account for significant unusual transactions and (2) the effect of significant accounting policies in controversial or emerging areas for which there is a lack of authoritative guidance or consensus.

Significant Accounting Estimates

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's current judgments. We evaluated the key factors and assumptions used to develop the fair value of the investments in determining that the fair value is reasonable in relation to the financial statements taken as a whole.

Financial Statement Disclosures

Certain financial statement disclosures involve significant judgment and are particularly sensitive because of their significance to financial statement users. The most sensitive disclosures affecting the plan's financial statements relate to:

Form 5500 Procedures

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

Significant Difficulties Encountered during the Audit

We encountered no significant difficulties in dealing with management relating to the performance of the audit.

The ERISA-required supplemental schedules, other than that agreed to or derived from the certified investment information, were subjected to the audit procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

Our responsibility also includes communicating to you any information which we believe is a material misstatement of fact. Nothing came to our attention that caused us to believe that such information, or its manner of presentation, is materially inconsistent with the information, or manner of its presentation, appearing in the financial statements.
