## Independent Auditor's Report

To the Plan Administrator and Participants  
XPO Logistics, Inc. 401(k) Plan:

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of XPO Logistics, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS  
DECEMBER 31, 2024 AND 2023**

**1. Description of Plan**

The following description of the XPO Logistics, Inc. 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan's summary plan description for more complete information. The terms "XPO" or "Company" refer to the entity known as XPO, Inc. and its subsidiaries.

**General**

The XPO sponsored Plan is a defined contribution Plan with profit-sharing and salary deferral features and is subject to the provisions of ERISA, as amended. The Plan is intended to qualify under Section 401(a) of the Internal Revenue Code (the "Code"). The Plan was adopted effective January 1, 2004 and amended and restated effective January 1, 2020.

Overall responsibility for overseeing the Plan rests with the XPO Administrative Committee (the "Committee"), which is appointed by the Chief Executive Officer of XPO. Fidelity is responsible for the control of the Plan's assets, which are held in individual participant investment accounts.

The Plan allows for transfers between other XPO sponsored defined contribution plans when a participant's eligibility to participate in a certain plan changes.

**Eligibility**

Employees are eligible to participate in the Plan upon employment except employees covered by a collective bargaining agreement, nonresident aliens, residents of Puerto Rico, leased employees and certain other employees. Participants are eligible for matching contributions after completing one year of service.

**Contributions**

Participants may contribute up to 50% of eligible compensation subject to certain limitations. Upon reaching the age of 50, eligible employees may make additional catch-up contributions as allowed by the Code. Participants may also roll over amounts representing distributions from other qualified defined contribution plans or individual retirement accounts into the Plan.

The Plan provides for a safe-harbor employer matching contribution ("Matching Contribution") equal to 100% of the first 3% and 50% of the next 2% contributed by the participant. The Company contributes Matching Contributions after participants complete one year of service.

The Company may also make additional contributions to the Plan at its discretion, subject to the limits of the Code. No additional discretionary contributions were made during 2024 or 2023.

**Participant Accounts**

The Plan allows participants to select any one or more of the investment funds, including a money market fund, mutual funds, and common collective trusts, established under the Plan in which contributions can be invested.

Individual accounts are maintained for each of the Plan's participants to reflect the participant's contributions, the Company's contributions, and an allocation of the Plan's earnings and expenses. The benefit to which a participant is currently entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are fully vested at all times in the portion of their accounts attributable to their elective deferrals, rollover contributions, matching contributions and qualified non-elective contributions. All other employer contributions vest according to the vesting schedules set forth in the Plan document.

### **Notes Receivable from Participants**

The Plan has a loan provision allowing participants access to funds. Loans can be no less than \$1,000 and cannot exceed the lesser of \$50,000 or 50% of a participant's vested account balance (subject to administrative adjustment to ensure compliance with the 50% limit). Loans are secured by the vested account balance of the participant. Loans can be made for a term not to exceed 4-1/2 years unless they are loans that were rolled over into the Plan for the purchase of a primary residence in which case the loan period could be extended. Loans bear interest at a rate as determined by the Plan Administrator based on commercial lending rates for comparable loans at the time the loan is granted. Loans outstanding as of December 31, 2024 bear interest ranging from 3.25% to 9.50% and mature through 2029. Principal and interest are paid ratably through payroll deductions.

### **Payment of Benefits**

Participants can receive a total distribution from their accounts upon retirement, death or termination of employment. Other types of withdrawals are permitted by the Plan in limited situations. Participants can elect to have their accounts distributed in a single lump sum or in a series of substantially equal annual installments, as defined by the Plan. Distributions will be made in cash.

### **Forfeited Accounts**

Forfeited nonvested account balances are used to reduce future employer contributions and/or pay Plan expenses. At December 31, 2024 and 2023, unallocated forfeitures totaled approximately \$65,000 and \$37,000, respectively. During 2024 and 2023, no forfeitures were used to reduce employer contributions or pay Plan expenses.

### **Hardship Withdrawals**

Upon certain conditions, participants, while still employed by the Company, are permitted to withdraw, in a single sum subject to a minimum of \$500, a portion of their elective deferrals as a result of an immediate and heavy financial need. These conditions include unreimbursed medical expenses, the purchase of the participant's principal residence, the payment of post-secondary education tuition, the payment of burial or funeral costs of immediate family members, the payment of natural disaster clean-up on the participant's principal residence or to prevent eviction or foreclosure from the participant's principal residence.

### **Plan Termination**

Although XPO has no current intention to terminate the Plan, it may do so at any time by resolution of the Board of Directors. In the event that the Plan is terminated, all balances will become 100% vested and the net assets of the Plan shall be distributed to participants in the amount credited to their accounts.

## **2. Summary of Significant Accounting Policies**

### **Basis of Presentation**

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

### **Risks and Uncertainties**

The Plan offers various investments that are generally exposed to various risks, such as interest rate, credit and overall market-volatility risks. Investments are reported at fair value. Due to the risk associated with certain investment securities, it is reasonably possible that the value of investment securities will change and that such changes could materially affect amounts reported in the statements of net assets available for benefits.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6, "XPO Logistics Inc. Master Trust", for a discussion of fair value measurements.

The annual change in market value, including realized gains and losses, is reported in the Plan's share of XPO Logistics Inc. Master Trust investment income in the accompanying statements of changes in net assets available for benefits.

Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Purchases and sales of securities are recorded on the trade-date basis. Both are reported in the Plan's share of XPO Logistics Inc. Master Trust investment income.

### **Administrative Fee Credits and Administrative Expenses**

The Plan allocates certain administrative fee credits to participants that are in excess of the recordkeeping fees paid by the Plan. During 2024 and 2023, there were no excess administrative fee credits.

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the Plan's share of XPO Logistics Inc. Master Trust investment income. For the years ended December 31, 2024 and 2023, the Plan paid direct expenses of approximately \$869,000 and \$894,000, respectively.

### **Payment of Benefits**

Benefits paid to participants are recorded upon distribution.

### **Estimates**

XPO makes estimates and assumptions when preparing the financial statements in conformity with GAAP. These estimates and assumptions affect the amounts reported in the accompanying financial statements and notes. Actual results could differ from those estimates.

### **Contribution Receivables**

Contribution receivables are contributions earned during the year but not received until the subsequent period due to the timing of the deposit and can be from either the Company or the participants. Contribution receivables are recorded at cost and due to its nature, the Plan does not establish an allowance for credit losses for contribution receivables.

### **Notes Receivable from Participants**

Notes receivable from participants are recorded at their unpaid principal balance plus any accrued but unpaid interest. The Plan does not establish an allowance for credit losses on notes receivable since the receivables are fully secured by the participants' contributions to the Plan. Delinquent notes receivable from participants may be treated as a distribution based on the terms of the Plan document.

### **3. Income Tax Status**

Effective January 1, 2020, the Plan was amended and restated utilizing an individually designed plan document. XPO believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code. Therefore, XPO believes that the Plan is qualified and the related trust is tax exempt.

Assuming it meets certain initial and ongoing requirements, the Plan is generally exempt from federal and state income taxes. However, GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS.

### **4. Related-Party Transactions and Party-In-Interest Transactions**

Certain investment fees are paid by Fidelity and are reflected in the investment income or loss for the year. The Plan also issues loans to participants that are secured by the vested balance in the participants' accounts. As such, these transactions qualify as party-in-interest transactions, which are exempt from the prohibited transactions rules.

Additionally, the Plan sponsor, XPO, is a party-in-interest to the Plan, however, there are no transactions with the Plan sponsor other than the funding of contributions to the Plan and payment of certain administrative expenses of the Plan, which are exempt transactions.

### **5. Information Certified by the Trustee**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The following information included in the financial statements and supplemental schedule was provided and certified by Fidelity, the trustee, as of December 31, 2024 and 2023 as complete and accurate:

- XPO Logistics Inc. Master Trust

## 6. XPO Logistics Inc. Master Trust

The Master Trust was formed to hold the assets of the Plan, the XPO Logistics Retirement Savings Plan and the XPO Logistics Personal Savings Plan. Each Plan has a divided interest in the Master Trust.

### *Fair Value Measurements*

FASB Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, establishes a framework for fair value measurement, which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 — Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 — Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 — Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investment assets measured at fair value. There have been no changes in the methodology used as of December 31, 2024 and 2023.

*Money market fund* - Valued at the published quoted price.

*Mutual funds* - Valued at the daily closing price reported on the active market on which the individual securities are traded.

*Common collective trusts* - The Plan's interest in the common collective trusts are valued at the net asset value ("NAV") of the common collective trust's underlying investments as based on information reported by the investment advisor using the audited financial statements or daily reported NAV of the common collective trust at year-end. The NAV is used as a practical expedient to estimate fair value. Participant transactions can occur daily.

The common collective trusts include investments that are operated by a trust company that manages a pooled group of trust accounts. Common collective trusts combine the assets of various institutional investors to create a larger, well-diversified portfolio. Each investor owns a participating interest that is calculated in units and represents a portion of the holdings of the fund.

Included in the common collective trusts held at December 31, 2024 and 2023 is a stable value fund with the investment objective to maximize current income consistent with the maintenance of principal and to provide for benefit-responsive participant withdrawals at contract value for certain events without penalty. Certain events may result in the stable value fund not trading at contract value. Such events include, but are not limited to, partial or complete legal termination of the trust or a unit holder, tax disqualification of the trust or unit holder, and certain trust amendments if the issuers' consent is not

obtained. Additionally, the Master Trust is required to provide 12 months advance written notice should they desire to eliminate the stable value fund option.

The remainder of the investments in common collective trusts can generally be redeemed without restriction; however, in certain cases, redemption or purchase may be limited to prevent excess and/or short-term trading. There were no unfunded commitments related to the common collective trusts as of December 31, 2024 and 2023.
