### **NOTES TO FINANCIAL STATEMENTS**

December 31, 2024 and 2023

#### **NOTE 1. DESCRIPTION OF THE PLAN**

The following description provides only general information on the provisions of the **SELIG SEALING PRODUCTS, INC. PROFIT SHARING/401K PLAN** (the “Plan”). Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

##### **A. General**

The Plan is a defined contribution plan established by **Selig Sealing Products, Inc.** (the “Company”) under the provisions of Section 401(a) of the Internal Revenue Code (“IRC”), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Effective 2/1/24, the Plan amended the definition of eligible compensation for any discretionary employer contributions to exclude bonus wages and fringe benefits. Further information can be obtained from management.

##### **B. Eligibility and Participation**

All employees except for employees covered by a collective bargaining agreement and nonresident aliens are eligible to participate 90 days after hire date and after attaining the age of 18.

##### **C. Contributions**

Participants may elect to contribute up to a maximum of 100% of their compensation, as defined by the Plan, subject to certain overall limitations. Upon meeting eligibility requirements, employees are automatically enrolled at a 6% deferral rate. Each subsequent year employees’ deferrals are automatically increased by 1% until they reach a 15% deferral rate subject to certain overall limitations. The employee may change, stop or resume deferring at any time. The Company, in turn, will make a matching contribution equal to 50% of the elective deferrals subject to certain overall limitations. The Company also contributed a discretionary amount equal to 4.0% and 1.5% of compensation subject to certain overall limitations as a profit-sharing contribution for each participant for the years ended December 31, 2024 and 2023, respectively.

##### **D. Participant Accounts**

Individual accounts are maintained for each participant to reflect the participant’s contributions and related employer matching contributions, as well as the participant’s share of the Plan’s income and any related administrative expenses. Allocations are based on the proportion that each participant’s account balance has to the total of all participants’ account balances.

Participants are fully vested in their contributions. Participants who leave the Plan because of death, normal retirement, or disability retirement, as defined in the Plan, are considered 100% vested.

Company matching contributions and discretionary profit-sharing contributions are vested in accordance with the following schedule:

1	20%
2	40%
3	60%
4	80%
5 or more	100%

Vesting under the Plan is based upon the 'hours of service' method. The participant will receive a year of service upon completion of 1,000 hours of service during a Plan year.

##### F. Payment of Benefits

Upon termination of service, death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account. The form of payment is a lump-sum distribution. Participants experiencing financial hardship may withdraw a portion of their account balance as defined in the Plan.

##### G. Notes Receivable from Participants

A participant may borrow the lesser of \$50,000 or 50% of his or her vested account balance with a minimum loan amount of \$1,000. Loans are required to provide for level amortization with payments to be made not less frequently than quarterly, over a period not to exceed five years. The total participant loan balance outstanding as of December 31, 2024 and 2023 was \$445,124 and \$479,149, respectively. Interest rates are determined by the Plan Administrator based on prevailing market conditions and are fixed over the life of the loan.

##### H. Forfeitures

Participant forfeitures are used to reduce the Plan's expenses and employer's contributions. In the years ended December 31, 2024 and 2023, \$7,501 and \$56,942 in forfeitures were used, respectively, to offset the employer's contributions. At December 31, 2024 and 2023, the Plan had \$35,702 and \$9,621 in unapplied forfeitures, respectively.

#### NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### A. Basis of Presentation

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America.

##### B. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

##### C. Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

##### D. Payments of Benefits

Benefits are recorded when paid.

##### E. Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

##### F. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

#### NOTE 3. FAIR VALUE MEASUREMENTS

VALUATION OF INVESTMENTS – FASB ASC 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

LEVEL 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

#### NOTE 3. FAIR VALUE MEASUREMENTS – Continued

LEVEL 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical assets or liabilities in active markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

LEVEL 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The funds held by the Plan are deemed to be actively traded.

*Collective Trust Funds:* Valued at the daily closing prices as reported by the collective trust fund. Collective trust funds invest in separate accounts and mutual funds. The fair value of the separate accounts and mutual funds are publicly quoted pricing units. The fair values of these investments are used in determining the net asset value of the collective trust fund, which is not publicly available.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### NOTE 4. INFORMATION CERTIFIED BY THE TRUSTEE (UNAUDITED)

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company, the Trustee, has certified that the following data included on the accompanying financial statements and supplementary schedule are complete and accurate:

- Total investments and participant loans as shown on the accompanying Statements of Net Assets Available for Benefits were \$47,507,837 and \$39,526,273 as of December 31, 2024 and 2023, respectively.
- Total investment income (loss) and interest on participant loans as shown on the accompanying Statements of Changes in Net Assets Available for Benefits were \$5,300,078 and \$5,849,896 for the years ended December 31, 2024 and 2023.

Additionally, the Trustee certified all information on Schedule H, Line 4i - Schedule of Assets (Held at Year End) at December 31, 2024, which may be found on the supplementary schedule.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included on the related financial statements and supplementary schedule.

#### NOTE 5. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by Principal Trust Company. Principal Trust Company is the Trustee as defined by the Plan and therefore, these transactions qualify as party-in-interest transactions.

#### **NOTE 6. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

#### **NOTE 7. TAX STATUS**

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020 that the Plan and related trust established under the Plan is tax-exempt under the appropriate sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

The Plan adopted accounting principles related to uncertain tax positions. Currently, the 2021, 2022 and 2023 tax years are open and subject to examination by the Internal Revenue Service and the Department of Labor. However, the Plan is not currently under audit nor has the Plan been contacted by either of these jurisdictions.

The Plan has evaluated its tax position taken for all open tax years. Based on the evaluation of the Plan's tax positions, management believes all positions taken would be upheld under an examination. Therefore, no liability for the effects of uncertain tax positions was recorded at December 31, 2024 and 2023. Any interest and penalties recognized and associated with a tax position would be classified as other expenses on the Plan's financial statements. No such amounts were recognized in the years ended December 31, 2024 and 2023.

#### **NOTE 8. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported on the Statements of Net Assets Available for Benefits.
